ALL-GRADE DISTRICT-WIDE EDUCATIONAL RESOURCES & PERFORMANCE LICENSE AGREEMENT

This District-Wide Educational Resources & Performance License Agreement (“Agreement”) is made between The Crossing Theatrics LLC (“Licensor”) and the school district or school network identified below (“Licensee”).

1. Grant of License

Licensor grants Licensee a limited, non-exclusive, non-transferable district-wide license to use all three The Crossing Classroom™ grade-level packages during the license term in all qualifying schools within the licensed school district or school network under common administrative control.

Licensed materials include:

- Elementary Grades (3–5): 40+ page Classroom Resource Guide, 3-song classroom concert script, and 3 MP3 listening tracks;
- Middle Grades (6–8): 40+ page Classroom Resource Guide, 6-song classroom concert script, and 6 MP3 listening tracks;
- High School & Beyond: 40+ page Classroom Resource Guide, 10-song concert script, sheet music, and karaoke-style accompaniment tracks for 10 songs.

The Elementary and Middle Grades MP3 recordings are provided for classroom listening and instructional use only and are not accompaniment or karaoke-style performance tracks.

This Agreement covers all qualifying schools and programs within the school district or school network identified above.

2. License Term

This license is valid for thirty-six (36) months beginning on the License Start Date listed above. All rights granted under this Agreement automatically expire thirty-six (36) months after the License Start Date unless renewed in writing.

3. License Fee

All Grade Levels District-Wide Educational Resources & Performance License Fee: \$1,497

Full payment is required before access to licensed materials is provided.

4. Authorized Educational and Performance Use

Licensee may reproduce and distribute the applicable licensed materials only as reasonably necessary for classroom instruction, rehearsal, and authorized educational presentations or performances within qualifying schools and programs covered by this Agreement.

During the license term:

- Each qualifying Elementary school may present the included 3-song classroom concert version as a school-based educational presentation using the licensed classroom concert script. The Elementary MP3 listening tracks may not be used as accompaniment tracks;
- Each qualifying Middle Grades school may present the included 6-song classroom concert version as a school-based educational presentation using the licensed classroom concert script. The Middle Grades MP3 listening tracks may not be used as accompaniment tracks;
- Each qualifying High School or secondary-level program may rehearse and present the included 10-song concert version as a school-based educational performance using the licensed script, sheet music, and supplied karaoke-style accompaniment tracks.

Licensee may not:

- Copy, scan, duplicate, upload, share, distribute, or post licensed materials outside the schools and programs covered by this Agreement;
- Share digital files with individuals or organizations not directly affiliated with the licensed district/network or its covered schools and programs;
- Upload materials to public websites, public cloud folders, or file-sharing platforms accessible beyond authorized district/network personnel and covered school/program personnel;
- Use Elementary or Middle Grades listening tracks as accompaniment tracks for performances;
- Use the licensed scripts, sheet music, or accompaniment tracks to create or present a substantially altered version of the work without Licensor's prior written permission;
- Transfer or sublicense this Agreement to another district, school network, organization, or third party.

5. Changes to Materials

Licensed materials may not be altered, adapted, edited, or modified without Licensor's prior written permission. Licensee may not use the materials in a manner that is misleading, defamatory, or harmful to the reputation or artistic integrity of the Authors.

6. Ownership and Intellectual Property

All educational materials, scripts, recordings, sheet music, trademarks, and related intellectual property remain the property of Licensor and/or the Authors, as applicable. This Agreement grants only the limited use rights expressly stated herein. No ownership rights are transferred.

7. Credit Requirement

When the licensed materials are used in classroom presentations, school programs, educational displays, or authorized performances, the following credit must appear:

8. District / School Network Responsibility

Licensee is responsible for activities conducted under this Agreement, supervision of participants, and compliance with district/network policies and applicable laws. Licensee is also responsible for limiting access to the licensed materials to personnel and schools covered by this Agreement.

Licensee represents that it and/or its covered schools maintain customary institutional liability coverage for educational activities and authorized school-based performances.

9. Indemnity

To the extent permitted by applicable law, Licensee agrees to hold harmless and indemnify Licensor and the Authors from claims, damages, or liabilities arising from Licensee's use of the licensed materials.

10. End of License / Termination

Upon expiration of the license term, or upon termination due to breach:

- All rights to use the licensed materials immediately end;
- Digital materials must be deleted;
- No additional copies may be made or distributed;
- Unused printed copies must be destroyed.

Licensor may terminate this Agreement if Licensee materially violates this Agreement and fails to cure the violation after written notice, where a cure is reasonably possible.

11. Governing Law

This Agreement shall be governed by the laws of the State of New York, without regard to its conflict-of-laws principles.
