✓ LOUISVILLE CONGRESS.—By vote of the Board of Trustees at Toledo, on May 3, the Twenty-second Annual Congress will meet at Louisville, as the guests of the Kentucky Society. It is hoped that compatriots from all parts of the country will feel it a duty as well as a pleasure to assemble again in Louisville, where the First Congress of the National Society was held on April 30, 1890.

✓ GOLD INSIGNIA.—The Executive Committee announces that through the generosity of a friend of the Society a full-sized gold insignia of the Sons of the American Revolution is offered, as in the past year, to the State Society which during the coming year shall add to its membership the largest proportional number of sons of active members. The insignia will be presented at the Annual Congress of 1911.

The insignia was awarded to the Michigan Society in 1909. At the Toledo Congress it was awarded to the New Jersey Society, which had enrolled 20 sons of members out of a total of 63 in thirteen State Societies. The object sought is to arouse interest in the younger generation of patriots.

✓ THE "TRAVELING BANNER," presented to the National Society by the Colorado Society, will be awarded at the next Annual Congress to the State Society of one hundred members or more that shows the largest percentage of increase in members during the coming year.

The Banner was awarded to the Iowa Society in 1908 and to the Maryland Society in 1909, Colorado having each year withdrawn from competition. At the Toledo Congress it was awarded to the New Jersey Society, which had enrolled 167 new members, with a net gain of 42 per cent during the year.

PROCEEDINGS OF THE EXECUTIVE COMMITTEE, MAY 1, 1910.

A meeting of the Executive Committee, duly called by order of the President General, was held at the Hotel Secor, Toledo, at 9.30 o'clock on the evening of May 1, 1910. Present: President General Morris B. Beardsley, who presided; Hon. Henry Stockbridge, of Maryland; Mr. Nelson A. McClary, of Illinois; Commander J. H. Moore, U. S. N., of District of Columbia; Mr. William Allen Marble, of New York; Mr. Lewis B. Curtis, of Connecticut; Secretary General A. Howard Clark, and Treasurer General John H. Burroughs.

The minutes of the meeting of the Committee on November 20, 1909, were approved.

It was voted that the Executive Committee approve, for adoption by the Congress, the amendment to the Constitution recommended by the District of Columbia Society providing for a Permanent Fund, the phraseology of the amendment being recast, on motion of Judge Stockbridge, seconded by Commander Moore.

There was submitted to the Committee a resolution proposed by Mr. Howe, of New Jersey, to be offered for adoption by the Congress, in-

dorsing the action of Compatriot John Franklin Fort, Governor of New Jersey, toward the establishment of a National Park at the place where Washington and his army crossed the Delaware, and recommending immediate action by the Government to secure land in New Jersey and Pennsylvania for such park. The Committee discussed the resolution, and voted to recommend its adoption by the Congress.

The Committee also approved a resolution calling upon the Governor of Pennsylvania to take action to promote the establishment of the above National Park.

It was voted that the Executive Committee recommend to the Congress the appointment of a special committee to call upon the President of the United States and the Secretary of Commerce and Labor and urge the enlargement of the work of the Division of Information in the Department of Commerce and Labor.

It was voted that the Executive Committee recommend to the Congress the appointment of a special committee to secure the re-enactment by the United States Congress of the provision made in 1904 for a memorial to Thomas Jefferson.

It was voted that the following amendment to the Constitution be recommended for adoption by the Twenty-second Annual Congress:

Amend Article III of the Constitution, entitled "Membership," by the insertion of a new Section 2, as follows:

SEC. 2. No one shall be entitled to membership in any State Society who has previously been a member of any other State Society and dropped for the non-payment of dues, until the indebtedness of such individual to the first Society shall have been adjusted.

Renumber present Sections 2 and 3 so as to make them Sections 3 and 4 respectively.

It was voted that it be recommended to the incoming Executive Committee to continue the gathering of data concerning the history of each State Society and its patriotic activities.

There being no further business, the Committee then, at 11.30 o'clock, adjourned.

The minutes of the meeting of the Trustees on May 1, 1909, were read and approved.

The Secretary General reviewed the proceedings of the Executive Committee at its meetings on May 2 and November 20, 1909, and on May 1, 1910, including the recommendation of various resolutions to be presented to the Toledo Congress, and the action of the Committee was approved by the Board.

There being no further business, the meeting then, at 9.30 o'clock, adjourned.

ABSTRACT OF PROCEEDINGS OF TOLEDO CONGRESS, MAY 2 AND 3, 1910.

The Twenty-first Annual Congress of the National Society of the Sons of the American Revolution was called to order in regular session at the Hotel Secor, Toledo, Ohio, at 10.15 o'clock a. m., Monday, May 2, 1910, President General Morris B. Beardsley presiding.

The report of the Credential Committee showed an attendance of 7 General Officers and 111 delegates from the following State Societies: Colorado, 1; Connecticut, 5; District of Columbia, 8; Empire State, 20; Illinois, 11; Indiana, 3; Iowa, 2; Kentucky, 2; Maine, 4; Maryland, 6; Massachusetts, 6; Michigan, 10; Minnesota, 1; Missouri, 2; New Jersey, 8; Ohio, 12; Pennsylvania, 6; Rhode Island, 3; and Vermont, 1.

The Congress was opened with an invocation by Dr. George Gunnell, of Toledo.

The Honorable Brand Whitlock, Mayor of Toledo, delivered an address of welcome.

The President General responded to the Mayor's welcome, and presented his annual address on the work and present needs of the Society. He discussed in some detail the advantage of a large number of local Chapters. The State Society is now the unit, and less than one-fourth of the members are affiliated with Chapters. Only seventeen States have provided for Chapters. During the past year the Old Essex Chap-

ter at Lynn, Mass., has increased to 156 members through the energetic work of Compatriot Luther Atwood; a large Chapter has been formed at Hartford, Conn., under Dr. Geo. C. F. Williams, and at Montclair, N. J., Compatriot George Curtis Sterling has organized a Chapter of 158 members.

MINUTES OF 1909 CONGRESS.—The proceedings of the Baltimore Congress, as published in the National Year Book for 1909, were approved.

THE TRUSTEES' REPORT reviewed the proceedings of the meetings of the Board of Trustees and of the Executive Committee during the year, as published in the Official Bulletin, and the action of the Committee and Trustees at its meetings on May 1 and 2, 1910.

PERMANENT FUND.—The Congress voted to at once consider an amendment to the Constitution recommended by the District of Columbia Society, and upon motion by Judge Stockbridge, duly seconded, the amendment was thereupon adopted by the unanimous vote of the Congress in the following form, as recommended by the Executive Committee:

Renumber Articles VIII and IX of the Constitution so as to make them IX and X respectively.

Insert a new Article, to be numbered VIII and to read as follows:

ARTICLE VIII.—PERMANENT FUND.

SECTION 1. There shall be created and maintained a Permanent Fund of the Society, the income or interest from which shall be covered into the general treasury of the Society and available for the general purposes of the Society, but the principal of which shall be maintained intact, and shall only be used or diminished upon the unanimous recommendation of the Executive Committee, approved by the Board of Trustees, and ratified by a four-fifths vote of the delegates present at the annual or special Congress to which such recommendation of the Executive Committee shall be reported.

SEC. 2. The permanent fund shall be composed of all legacies or donations to the Society, where no other application of the funds is designated by the testator or donor, all commissions received from the sales of badges, rosettes and ribbon, and such sum or sums as may from time to time by the Executive Committee be transferred to such fund from the general funds of the Society.

SEC. 3. The permanent fund shall be invested in securities authorized to be held by Savings Banks in Massachusetts, Connecticut, or New York, and any premium paid in purchasing such securities shall be repaid from the first income received.

Commander Moore presented a check for \$100 from the District of Columbia Society as the commencement of the Permanent Fund. State

Societies quickly responded to the suggestion of the President General that other contributions were in order, with the following total result: District of Columbia, \$100; Connecticut, \$200; Empire State, \$200; Pennsylvania, \$100; New Jersey, \$100; Michigan, \$100; Kentucky, \$100; Illinois, \$200; Anthony Wayne Chapter of Toledo, \$100; Maryland, \$100; Minnesota, \$100; Ohio Society, \$100; Colorado, \$100; Missouri, \$100; Indiana, \$100; Iowa, \$50; Massachusetts, \$200. Total, \$2,050.

(Under subsequent authorization of the Board of Trustees, the President General, the Treasurer General, and ex-President General Cornelius A. Pugsley, were appointed a committee on investment of the Permanent Fund.)

SECRETARY GENERAL'S REPORT.—The Secretary General reviewed the business transacted during the year, including the printing and distribution to every member of four issues of the Official Bulletin, numbering 136 pages, and the printing and distribution of the 1909 Year Book, a volume of 333 pages. The patriotic doings of the State Societies during the year were reviewed as published from time to time in the Bulletin.

TREASURER GENERAL'S REPORT.—Treasurer General Burroughs reported the balance on hand April 24, 1909, \$6,890.42; receipts during the year, \$7,241.65; total, \$14,132.07; disbursements during the year, \$6,367.47; balance on hand April 25, 1910, \$7,764.60.

The Auditing Committee, William A. De Cindry, George Clinton Batcheller, and George F. Burgess, certified to the report as "examined and found correct."

It was voted that the Treasurer General's report be accepted with thanks and filed.

REGISTRAR GENERAL'S REPORT.—The report of the Registrar General showed that 1,064 new members had been enrolled by 40 Societies during the year, making an aggregate enrollment of 21,528 members since April 30, 1889, with a present active list of 12,100 members, after deducting all losses by death and other causes. The greatest number of new members was enrolled in New Jersey, 167, with a net gain in that State of 42 per cent since the Baltimore Congress. Two hundred and fifty deaths have been reported. Sixteen medals were awarded to compatriots for service in the War with Spain, making a total of 693 since May 1, 1899, when the medal of honor was established.

The Registrar General reported 625 certificates of membership engrossed and issued, and called attention to the fact that some State Societies do not provide for these certificates for their members, as authorized by the Constitution.

HISTORIAN GENERAL'S REPORT.—In the absence of Historian General Walter Kendall Watkins, the Secretary General presented the report of that officer, which reviewed the origin, organization, and work of the various Committees of Correspondence, Safety, Inspection, Observation, etc., during the period of the War of the Revolution. It was voted that the report be printed in the Proceedings of the Congress.

MEMORIAL COMMITTEE.—Prof. Arthur B. Bibbins, secretary of the Committee, read its report, in which was included a recommendation that Societies in each of the thirteen original States prepare, as memorials to the Signers of the Declaration of Independence from those States, octavo pamphlets giving their biographies, illustrated by portraits, views of their homes and graves, and other suitable pictures. These several pamphlets by the States might afterward be condensed and combined in a National Society publication. The committee recommended locating and marking the graves of the Signers with appropriate monuments. Also the identification and marking of the graves of those patriots who gave form to the Declaration of Independence, though not actual signers of that document, as well as the graves of Revolutionary Officers and soldiers, with the memorial stones furnished by the Government for that purpose.

The Committee also recommended the restoration of structures intimately associated with the Signers or with those who bore an active and prominent part in connection with the Declaration, to be preserved as landmarks and to be utilized where practicable for patriotic purposes.

The report was accepted and its recommendations referred to the Executive Committee for consideration and action thereon.

ORGANIZATION IN NORTH AND WEST.—Doctor Guyer, chairman of the Committee, reported over 400 letters had been written in promoting the organization work in the North and West. The Nevada Society was organized at Reno on February 19, 1910, with 19 members, making four new Societies in the West since the Denver Congress.

ORGANIZATION IN THE SOUTH.—Commander Moore reported that a Society was organized in Mississippi in May, 1909, and that progress had been made toward the formation of Societies in North Carolina and South Carolina, particularly in the latter State.

COMMITTEE ON EDUCATION.—In the absence of Colonel Lyman, Chairman of the Committee, his report was read by Judge Atwater, of New Jersey. The report showed that a larger number of medals and other prizes have been offered and awarded than in some past years, mainly

in schools, colleges, and universities, for the best essays on Revolutionary subjects and characters, and in some cases to winners of prize debates. The Committee recommends the enlargement of this custom as promising good results in training for patriotism and good citizenship, especially in sections where there is a large percentage of foreign-born children or children of foreign parentage.

Four things may profitably be kept constantly in mind: (1) All programs for Society and Chapter meetings should be arranged and carried out with the distinct purpose of causing an access of patriotism among our members, so much needed in dealing with present-day problems; (2) the influence of our Society should always be felt on the side of law and order and education and clean politics; (3) the immigrant, on arrival, should be met with such helpful attention that his first impression will tend towards good citizenship; (4) similar helpful attention should be shown to him when he is located in our midst, so that his first impressions may be confirmed and he may become a valuable asset of, instead of a menace to, our country.

COMMITTEE ON NATIONAL PARKS.—In the absence of Mr. W. V. Cox, Chairman, his report was presented by Mr. David L. Pierson, of New Jersey. The report reviewed in some detail the unusual interest taken during the past year by the National Government, States and Territories, municipalities, patriotic societies, and generous citizens in acquiring and preserving forest reservations and parks, and in marking historic sites, long and earnestly advocated by the Sons of the American Revolution. Particular mention was made of the Palisades Interstate Park along the Hudson, and its recent extension northward in the region made historic by military struggles during the Revolution, a work made possible through the generosity of Mrs. Harriman and a party of patriotic gentlemen.

The restoration of Fort Ticonderoga splendidly illustrates the spirit which so many Americans are exhibiting in the campaign for preservation. Mrs. Stephen Pell, daughter of Col. Robert M. Thompson, of New York, expressed a desire to have Fort Ticonderoga restored as it was when Ethan Allen and the Green Mountain Boys captured it in May, 1775. "Have it done and send the bill to me," said Colonel Thompson. Work was immediately begun and a portion of it completed at the time of the celebration of the tercentenary of Lake Champlain. It will take ten years to finish the work at an estimated cost of \$500,000.

The Committee expresses the hope that there will be other Colonel Thompsons with patriotic daughters.

A number of bills have been introduced in the present Congress for the establishment by the Government of National Parks, historic battlefield

sites, and the erection of memorials to soldiers and patriots of the Revolution. Among the memorials dedicated during the year was a granite shaft on the battlefield of Kings Mountain, and a memorial to Gen. George Rogers Clark at Quincy, Illinois. The bills before Congress provide for National Parks at Fort Frederic, Maryland, and at Brandywine Battlefield, Pennsylvania; a memorial structure at Point Pleasant, Virginia; a statue of General Greene at Guilford Court House, North Carolina; and statues of General Campbell, General Sullivan, Alexander Hamilton, General Stark, General Miller, Peyton Randolph, and others.

Statues of General Pulaski and General Kosciuszko have recently been erected in the city of Washington, the former by Congressional appropriation and the latter the gift of the Polish National Alliance of America.

A bill (H. R. 16347) was introduced in Congress on January 4, 1910, and referred to the Committee on Military Affairs, providing for a National Military Park Commission to have charge of the restoration, preservation, suitable marking, and maintenance, in commemoration of the valor of American arms and for historical and professional military study, of battlefields, forts, or cemeteries, or parts thereof, of the Colonial, Revolutionary, Indian, and Civil Wars, etc.

PENSION AND MUSTER ROLLS.—Mr. Zebina Moses, of the District of Columbia, reported on the progress made in preparing summary cards from the papers filed in the claims of 60,000 pensioners of the Revolution. When the cards or digests have been completed and published there will become available a mass of most valuable genealogical and military information. A bill is now before Congress (H. R. 22007) authorizing the compilation of military and naval records of the Revolutionary War with a view to their publication. This bill will carry an appropriation of \$50,000 for the compilation of records in the War Department, and \$10,000 for those in the Navy Department.

On motion by Mr. Moses, duly seconded, the following resolution was adopted:

Resolved by the Congress of the Sons of the American Revolution in session at Toledo, Ohio, May 2, 1910, That we heartily approve the objects of bill, H. R. 22007, entitled: "A bill to authorize the compilation of military and naval records of the Revolutionary War with a view to their publication," said bill having been introduced in the House of Representatives February 28, 1910, and that we urge its early enactment.

Resolved, That a copy of these resolutions be transmitted to both Houses of Congress.

INFORMATION FOR ALIENS.—Commander Moore, Chairman of the Committee on Information for Aliens, reported that during the year

there had been a constant demand for the National Society leaflets, No. I, "The United States: Its Opportunities, Government, and Institutions," and No. II, "Naturalization of Aliens in the United States: How to Become Citizens; What is Required; Rights and Duties."

Leaflet No. I has been distributed in the following languages: Greek, Italian, Swedish, Danish-Norwegian, Magyar, German, Polish, Lithuanian, Yiddish, Slovak, Bohemian, Croatian, Slovenian, and English. The largest demand was for Italian, Polish, and Yiddish. Leaflet No. II, on Naturalization, has been published in the English language only, as the Executive Committee did not deem it wise policy to have it translated. There has been a growing demand for this leaflet throughout the year.

Last December a bill was introduced in the House of Representatives, Section 5 of which proposed to abolish the Division of Information in the Bureau of Immigration and Naturalization of the Department of Commerce and Labor. This Division for the past two years has been of the greatest assistance to our Committee in the distribution of our leaflets. It has been working along the same patriotic lines as our Society in its work of assisting in the distribution of the aliens from the congested centers to the farms throughout the country.

The District of Columbia Society commenced work immediately, not only to save this Division, but to strengthen it in its work. At the January meeting of that Society a memorial was adopted petitioning the Senate and House not only to retain the Division of Information, but to strengthen it and enlarge its work. Later, by direction of the President General, a letter was sent to all State Societies and Chapters reviewing the importance of the work of the Division of Information and calling upon each Society and Chapter to protest to Congress against interference with its beneficial operations.

Upon the request of our President General a similar letter and memorial was sent to every State Regent and every Chapter of the Daughters of the American Revolution. For the past two months scarcely a legislative day has passed without the presentation, either in the Senate or the House, of these memorials from the Sons or the Daughters of the American Revolution throughout the land.

The Committee is still of the opinion that the work of education and preparing the alien for citizenship is the greatest patriotic duty that our Society has to perform.

Allusion has been made to the zealous coöperation with and great assistance rendered to this Committee by the Division of Information. The Committee is at the same time impressed with the fact that the Division is capable and desirous of doing far more than it has as yet

been able to do, and that to realize this higher measure of usefulness there is needed a greater personal interest upon the part of those higher in authority, to encourage and stimulate the work of this Division, and with this in view the Committee submits the following resolution:

Resolved by the National Society of the Sons of the American Revolution in the Twenty-first Annual Congress assembled, That the President General of this Society be, and he is hereby, authorized to appoint a committee of three to express to the President of the United States and the Secretary of the Department of Commerce and Labor its appreciation of the work accomplished by the Division of Information of the Bureau of Immigration and Naturalization, and to request and urge that the scope and extent of the work of that Division be extended and its efficiency promoted as far as follows.

The above resolution was unanimously adopted.

The Congress also adopted the following resolutions thanking the Daughters of the American Revolution for their coöperation in protesting against abandoning the Division of Information:

Resolved, That the National Society of the Sons of the American Revolution records its appreciation of and gratitude for the cordial, prompt, and efficient coöperation of the Daughters of the American Revolution in the protest against the abandonment of the Division of Information in the Bureau of Immigration and Naturalization.

Resolved, That the President General and Secretary General of this Society be directed to inform the National Society of the Daughters of the American Revolution of this action.

JEFFERSON MEMORIAL.—Judge Stockbridge, of the Jefferson Memorial Committee, reported that in 1904 a commission was created by Congress to select a site in the District of Columbia for a statue of Thomas Jefferson, to cost, complete, not to exceed one hundred thousand dollars, and five thousand dollars was appropriated for plans and designs. No plans were prepared, and the appropriation lapsed and was covered back into the treasury under the Sundry Civil Act of 1909.

Upon the recommendation of the Committee the following resolution was adopted:

Resolved, That a committee of three be appointed by the President General to recommend to Congress the re-enactment of the provision made in 1904 for a memorial in the city of Washington to Thomas Jefferson, and to report to the next Congress what, if any, further action the Committee shall think it expedient to be taken by this Society.

THE TRAVELING BANNER and the prize insignia were awarded to the New Jersey Society, addresses of acceptance being made by Judge Atwater and Colonel Howard. That Society showed a net gain of 42 per cent in membership and enrolled 20 sons of members

STATE SOCIETY REPORTS.—The Secretary General presented the reports of State Societies reviewing the patriotic work and general operations during the year, and it was voted that abstracts, as usual, be printed in the Year Book.

✓ COMMITTEE OF FIVE ON NEW WORK.—The following resolution introduced by Mr. Vandercook, of Illinois, was adopted, with the recommendation that the Executive Committee bring to the attention of the Committee of Five such matters and lines of work as may be suggested after due deliberation of the subject:

Whereas the Constitution of this Society, under Article II, recites that among the objects of the Society is the following, "To maintain and extend the institution of American freedom, and to carry out the purposes expressed in the preamble to the Constitution of our country and the injunction of Washington in his farewell address to the American people,"

Be it resolved, That the President General of this Society is hereby instructed to appoint a Committee of five to take under advisement some plan of work which shall carry out the purposes of the Society, as above expressed, to the end that the Society shall interest itself in matters of present-day importance and by such work attract large numbers to membership.

✓ PRESIDENT GENERAL'S TERM OF OFFICE.—Ex-President General McClary addressed the Congress on the advantages of a longer term of office for the President General, for it is often impracticable to formulate lines of work and carry them into successful execution within the customary term of one year. The subject was presented by Mr. McClary as one worthy of careful consideration, but no present action was proposed.

✓ WASHINGTON-CROSSING-THE-DELAWARE PARK.—Mr. George R. Howe, of New Jersey, submitted the following resolutions, which were seconded in addresses by several members, and adopted by the Congress:

Whereas, The Legislature of New Jersey at its last session ratified the action of Governor John Franklin Fort in the appointment of a Commission, of which United States Senator Frank O. Briggs is chairman, to establish, if possible, a National Park and to properly mark and perpetuate the place where Washington crossed the Delaware River at the head of his little army of patriots and seized victory from defeat at Trenton and Princeton;

And whereas, The New Jersey Legislature has provided for the preliminary expenses of such Commission;

And whereas, Our honored compatriot, Governor Fort, of New Jersey, has personally called the attention of Governor Stuart, of Pennsylvania, to this action to forever preserve this historic spot as it was "in the days

that tried men's souls," for the benefit of their descendants and those who have since united with them, living in every State of the Union;

And whereas, The old ferryman's house still stands in which Washington tarried for a time, while his enfeebled but valiant army was being reformed on the Jersey shore for its victorious attack upon the Hessians at Trenton;

And whereas, The land on either bank of the Delaware River in the States of Pennsylvania and New Jersey remains very largely as it was in the old days, with the old road clearly defined, and Bear Tavern still standing, so that this patriotic purpose can now be accomplished at a minimum of expense and a maximum of benefit to posterity, in forever preserving perhaps the most spectacular battlefield of the Revolutionary War, and thus preserving one of our most sacred patriotic shrines; therefore

Be it resolved, That the National Society of the Sons of the American Revolution in Congress assembled gives its most hearty endorsement to the noble and patriotic action of the Governor and Legislature of New Jersey, and commends the united action of the various patriotic societies of New Jersey in favor of this project, and urges upon all the State Societies of the Sons of the American Revolution and our individual members everywhere, the importance of active coöperation to secure favorable national legislation, so that a suitable and permanent memorial of this great historical event may be established at the actual spot where it occurred.

And be it further resolved, That the Secretary General be instructed to forward a copy of these resolutions to each State Society, and that each State Society be requested to urge upon its Senators and Representatives in Congress immediate favorable action thereon.

On motion by Mr. Maynadier, of Maryland, the following resolutions were adopted:

Whereas, The Governor and Legislature of New Jersey have taken action looking to the establishment, if possible, of a National Park at the spot where Washington crossed the Delaware River, at perhaps the most critical period of the Revolutionary War, and turned defeat into victory.

And whereas, All the patriotic societies of New Jersey, with large numbers of its public-spirited citizens, are actively coöperating to accomplish the patriotic purpose.

Be it resolved, That the National Society of The Sons of the American Revolution, in Congress assembled, respectfully urges upon Governor Stuart, of Pennsylvania, the great importance of permanently securing this historic spot—and properly marking the same, and to this end asks his active support and that of the Legislature of Pennsylvania in such manner as in their wisdom may seem best.

And be it resolved, That we urge upon the public-spirited citizens of Pennsylvania that steps be taken to arouse public sentiment and help in preserving to the Nation this historic spot within their own borders.

✓ DELINQUENT MEMBERS.—Mr. Marble, of New York, proposed the following amendment to the Constitution, which had been approved by the Executive Committee, and on motion by Judge Stockbridge, the Con-

gress voted to recommend the adoption of the amendment at the next Annual Congress in accordance with the provisions of the Constitution governing amendments thereto:

Amend Article III of the Constitution, entitled Membership, by the insertion of a new Section 2 as follows: SEC. 2. No one shall be entitled to membership in any State Society who has previously been a member of any other State Society and dropped for the non-payment of dues, until the indebtedness of such individual to the first Society shall have been adjusted.

Renumber present Sections 2 and 3 so as to make them Sections 3 and 4, respectively.

The Congress then adjourned to meet at 9.30 a. m., May 3.

Tuesday morning, May 3, at 9.30 o'clock, the Congress reconvened, the President General presiding. In the absence of a clergyman the members arose and repeated the Lord's Prayer.

GEORGE WASHINGTON MEMORIAL BUILDING.—On motion of Judge Stockbridge, duly seconded, the following resolutions were adopted:

Resolved, That the National Society of the Sons of the American Revolution approves the general plan of the George Washington Memorial Association of erecting a building in the City of Washington, adapted for the meeting place of patriotic, scientific, and other organizations aiming to promote the welfare of the American people.

Resolved, That a committee of three be appointed to confer and cooperate with the George Washington Memorial Association, under the supervision and direction of the Executive Committee of this Society.

INVITATIONS FOR CONGRESS OF 1911.—The President General announced that invitations for the Twenty-second Annual Congress might be presented to this Congress, and they would be referred to the Board of Trustees for action, under Article VII of the Constitution.

Mr. Rogers Clark Ballard Thruston, on behalf of the Kentucky Society, extended an invitation to hold the next Congress in the city of Louisville, supplementing the State Society invitation with cordial invitations from the Mayor of Louisville (Hon. W. O. Head), from the Superintendent of the Board of Trade (James F. Buckner, Jr.), the Louisville Commercial Club, and the Louisville Convention and Publicity League.

Vice-President General Guyer, of Colorado, in behalf of the California Society, extended an invitation from that Society to hold the next Congress in San Francisco, where the Sons of Revolutionary Sires was founded in 1875, and read a telegram from President Thomas A. Perkins conveying the greetings of the California Society to the members of the present Congress.

The invitations from Kentucky and California were seconded by several members, and on motion the thanks of the Congress were voted to the Societies in those States for their cordial invitations.

ELECTION OF OFFICERS.—The President General announced that election of officers was next in order. The result of the election was as follows: President General, William Allen Marble, of New York; Vice-Presidents General, R. C. Ballard Thruston, of Kentucky; Commander John H. Moore, U. S. N., of the District of Columbia; William T. Dewey, of Vermont; Col. Samuel E. Bliss, of Illinois, and R. M. Sims, of California; Secretary General and Registrar General, A. Howard Clark, of the District of Columbia; Treasurer General, John H. Burroughs, of New York; Historian General, David L. Pierson, of New Jersey; Chaplain General, Rev. John Timothy Stone, D. D., of Illinois.

Members of the Board of Trustees for the several State Societies were then elected (see list on page 2 of the present Bulletin).

VOTES OF THANKS were extended to the Anthony Wayne Chapter of the "Sons" and the Chapters of the "Daughters" in Toledo, to the Toledo Chamber of Commerce, the Libbey Glass Company, the Toledo Blade, and to Mr. McClary, Colonel Mack, Mr. Pomeroy, Mr. Walbridge, and others for their courteous hospitality to the Congress.

There being no further business, the Congress then, at 12.45 o'clock p. m., adjourned *sine die*.

SOCIAL FUNCTIONS AT TOLEDO CONGRESS.

On Sunday evening, May 1, patriotic services were held in St. Paul's Methodist Church. On Monday evening, at the Hotel Secor, the Ursula Wolcott Chapter of the Daughters of the American Revolution gave a reception to delegates and ladies of the Congress and to the Anthony Wayne Chapter of the Sons of the American Revolution and their wives. On Tuesday afternoon the delegates were given an automobile ride about the city and to Fort Meigs. The same afternoon, at the residence of Mrs. Edward Ford, the Toledo and Fort Industry Chapters of the "Daughters" tendered a tea to the visiting ladies, to which the members of the Congress were also invited.

Tuesday evening the Toledo Chamber of Commerce gave a banquet

to the Congress at the Hotel Secor. Mr. George E. Pomeroy presided as toastmaster. Addresses were made by Judge Doyle, representing the Chamber of Commerce; Judge Beardsley, the retiring President General; Mr. Wm. S. Walbridge, President of the Anthony Wayne Chapter; Mr. John H. Burroughs, Treasurer General; Judge Stockbridge, ex-President General; Gen. J. Kent Hamilton, of Toledo, and Mr. William Allen Marble, President General elect.

At the same hour a banquet was given at the Hotel Secor to the visiting ladies and "Daughters" and the wives of members of the Anthony Wayne Chapter of the "Sons," by the Ursula Wolcott, the Toledo, and the Fort Industry Chapters of the Daughters of the American Revolution.

The Libbey Glass Company, of Toledo, presented to each delegate, as a souvenir of the Congress, a cut-glass bowl, and the Toledo *Blade* presented as a souvenir from that newspaper a sword-shaped paper cutter inscribed "S. A. R. Annual Congress, 1910."

✓ PROCEEDINGS OF THE BOARD OF TRUSTEES, MAY 3, 1910.

A meeting of the Board of Trustees was held at the Hotel Secor, Toledo, Ohio, at 5.20 o'clock, Tuesday afternoon, May 3, pursuant to call by the President General. Present: The newly elected President General, William A. Marble, who presided; Judge Henry Stockbridge, of Maryland; Vice-President General Commander John H. Moore, U. S. N.; Treasurer General John H. Burroughs; Secretary General A. Howard Clark; E. M. Wentworth, of Iowa; Andrew W. Bray, of New Jersey; Rear Admiral George W. Baird, U. S. N., of District of Columbia; Col. R. W. Guthrie, of Pennsylvania; Col. Moulton Houk, of Ohio; Dr. Moses Greeley Parker, representing the Massachusetts Society, and others.

The President General nominated the following-named members of the Executive Committee, and the nominations were thereupon confirmed by vote of the Trustees: President General Marble, *Chairman, ex-officio*; Mr. Lewis Beers Curtis, of Connecticut; Hon. Henry Stockbridge, of Maryland; Col. Isaac F. Mack, of Ohio; Hon. Edward S. Atwater, of New Jersey; Dr. Moses Greeley Parker, of Massachusetts, and Elmer M. Wentworth, of Iowa.

✓ It was voted that the President General and the Treasurer General *ex-officio*, and one other member to be appointed by the President General be a committee to have charge of the investment of the Permanent

Fund. (The President General subsequently appointed Hon. C. A. Pugsley, of New York, as the third member of this Committee.)

It was voted that \$1,800, or so much thereof as may be necessary, be appropriated for the publication and distribution of the Official Bulletin during the ensuing year.

It was voted that not to exceed \$1,000 be appropriated for the publication and distribution of the National Year Book for 1910 in an edition of 750 copies, and the Secretary General was directed to condense the contents of the book by the omission of the banquet speeches and such other condensation as may be deemed advisable, with the approval of the President General.

It was voted that a sum not to exceed \$50 be appropriated for stationery and incidental expenses of the Committee on Education.

It was voted that a sum not to exceed \$500 be appropriated for printing and incidental expenses of the Committee on Information for Aliens.

It was voted that the necessary expenses of the office of the Secretary General and Registrar General be authorized as during the past year.

It was voted that the President General be authorized to continue such of the special committees as he may deem advisable.

✓ It was voted that the Twenty-second Annual Congress of the Society be held at Louisville, Kentucky.

✓ It was voted that \$500 be appropriated toward the expenses of the Louisville Congress, to be accounted for in the usual manner.

✓ It was voted that the President General be authorized to refer to the Executive Committee for their action any matters incident to the Toledo Congress not acted upon by the Trustees, and such new business as in the judgment of the President General may not require the action of the Board.

There being no further business, the meeting then, at 6.30 o'clock, adjourned.

✓ PROCEEDINGS OF THE EXECUTIVE COMMITTEE, MAY 4, 1910.

A meeting of the Executive Committee, duly called by direction of the President General, was held at the Hotel Secor, at 9.30 a. m., Wednesday, May 4, 1910. Present: President General William Allen Marble, who

presided; Mr. Lewis B. Curtis, of Connecticut; Hon. Henry Stockbridge, of Maryland; Col. Isaac F. Mack, of Ohio; Hon. Edward S. Atwater, of New Jersey; Dr. Moses Greeley Parker, of Massachusetts; Mr. E. M. Wentworth, of Iowa, and Secretary General A. Howard Clark.

The following resolution, adopted by the Annual Congress on May 3, and referred to the Executive Committee, was discussed and it was voted that the resolution lie on the table until the next meeting, the Secretary General to send a copy to each member of the Committee for consideration and suggestions thereon:

Whereas, The Constitution of this Society under Article II, recites that among the objects of the Society is the following: "To maintain and extend the institution of American freedom, and to carry out the purposes expressed in the preamble to the Constitution of our country and the injunction of Washington in his farewell address to the American people."

Be it resolved, That the President General of this Society is hereby instructed to appoint a Committee of five to take under advisement some plan of work which shall carry out the purposes of the Society, as above expressed, to the end that the Society shall interest itself in matters of present-day importance, and by such work attract large numbers to membership.

The recommendations in the report of the Memorial Committee to the Congress and referred to the Executive Committee were considered, and it was voted that the Executive Committee recommend to the Societies in the thirteen original States to verify the burial places of Signers of the Declaration of Independence from each such State, and permanently mark the graves, if not now marked, and recommend that pamphlets containing biographical sketches of the Signers be published by the State Societies of a standard size, to be illustrated by portraits of the Signers, views of their homes, and of their graves. The Secretary General was instructed to secure copies of books already issued by some of the State Societies on this subject.

It was recommended that Societies in other than the thirteen original States identify the graves of eminent patriots of the Revolutionary period buried in such States and report them to the Memorial Committee for future consideration.

It was voted that the Secretary General be instructed to continue the gathering of data pertaining to the patriotic work of the State Societies from their organization to date, as begun by the Executive Committee under resolution of September 26, 1908.

The Secretary General announced that a member of the Society had again offered to present a gold ceremonial badge, to be awarded to the State Society that during the coming Society year shall enroll in pro-

portion to its membership the greatest number of sons of present members. It was voted to accept the offer with the thanks of the Committee.

It was voted that Doctor Parker and Judge Stockbridge be a special committee to consider and report at a subsequent meeting on a form of State Society Constitution and By-Laws best adapted to a more uniform regulation of local Chapters, and for a form of Chapter Constitution and By-Laws.

It was voted that when the moneys subscribed to the Permanent Fund at the Annual Congress shall have been paid to the Treasurer General he is authorized to transfer to such fund from the general funds a sum sufficient to increase the Permanent Fund to the nearest thousand above the amount of the subscriptions at the Congress.

Mr. Wentworth, Trustee for the Iowa Society, subscribed for that Society \$50 to the Permanent Fund, and it was ordered to be recorded with the funds subscribed at the Congress, as also a contribution promised by Doctor Parker from the Massachusetts Society.

It was voted that the President General be empowered to act for the Executive Committee in matters not already acted upon that may need immediate attention after the proceedings of the Toledo Congress and of the Trustee's meeting on May 3 and the present meeting of the Executive Committee have been written up.

The President General announced the appointment of Hon. Cornelius A. Pugsley as the third member of the Permanent Fund Investment Committee authorized by the Board of Trustees at its last meeting, May 3, 1910.

There being no further business the Committee then, at 11.30 o'clock a. m., adjourned.

DOINGS OF STATE SOCIETIES.

A monument erected at Compo Beach, Westport, to mark the resistance made to the landing of Tryon's regulars, was reported as ready for dedication at the midsummer meeting.

✓ THE DISTRICT OF COLUMBIA SOCIETY at its April meeting listened to an important illustrated paper by Compatriot Charles E. Monroe on high explosives, reviewing the great improvements and discoveries made in recent years in the manufacture and utilization of explosives, many of these discoveries being the results of the researches of Professor Monroe.

The Society held its spring outing on May 21, at Annapolis, about 200 members and guests, including the Society of Mayflower Descendants, participating. At the luncheon at Carvel Hall addresses were delivered by Attorney E. T. Riley on the early history of the Maryland Capital, and by Judge Stockbridge, of the Maryland Society, on events of the Revolutionary War. The Naval Academy buildings were inspected and opportunity was offered to board the U. S. Ship Hartford, as well as to witness boat races between crews of the Naval Academy and Syracuse University and a baseball game between the Naval Cadets and Georgetown University.

✓ THE ILLINOIS SOCIETY has removed its library and office to larger quarters, at Room 1018 Merchants' Loan and Trust Building, Chicago. Two very interesting and well attended meetings have been held recently—one in March, addressed by Hon. B. W. Snow, Chairman of the Finance Committee of Chicago City Council, and E. R. Pritchard, Secretary of the Board of Health, and one on May 27, addressed by Prof. C. E. Merriam, of the University of Chicago, upon "Municipal Expenditures." At the latter meeting the twelve delegates from Illinois to the National Congress at Toledo made brief reports, and action was taken indorsing the proposition for a branch office in Chicago of the Information Bureau pertaining to immigrants. The membership of the Illinois Society is now 580, and growing.

In the annual report of Secretary Bowman is the recommendation that "some general movement should be fostered by the National Society that would tend to create nation-wide interest in the Society, and which would be calculated to impress upon all eligible citizens something of the dignity, importance, and value of membership in the organization," and it is recommended "that the National Society prepare and place before each State Society suggestions as to ways and methods of carrying on Society work and of enhancing the influence of the Society in the several States."

✓ THE KENTUCKY SOCIETY has under consideration the placing of a "marker," or tablet, to commemorate the battle between the British and Indians and Americans near Mt. Sterling, and also a "marker" at Twelfth and Rowan streets, Louisville, in commemoration of the battle between the Indians and the Americans under Colonel Chenoweth, in Revolutionary time.

The Society will entertain the Congress of 1911 at Louisville, and intends that the event shall be memorable in the history of the National Society, resulting in a large increase in membership throughout the Southern States.

THE LOUISIANA SOCIETY held its annual banquet on the anniversary of Jefferson's Birthday. President Edward Rightor presided as toastmaster, and among those who responded to toasts were Prof. Alcée Fortier, who told some incidents of the life of Thomas Jefferson, and E. T. Merrick, who described the valuable and brilliant achievements of Thomas Paine. Henry W. Robinson told the Society something interesting he had discovered concerning the Declaration of Independence. Capt. Ben W. Hodges, commander of the battleship *Wisconsin*; Col. Lansing H. Beach, of the corps of United States Engineers, and Maj. James A. Shipton, commanding the garrison at Jackson Barracks, also spoke. Secretary Thomas D. Dimitry told of the progress of the Society. Mr. Dimitry exhibited four original autograph letters written by Thomas Jefferson to Robert Mills, a grandfather of Mr. Dimitry. One of these letters was written after Jefferson had sustained dislocations of both wrists, and one of the letters commended in strong terms canals and good roads, and said it would be better for the States to engage in building these than in slaughtering their fellow-men.

THE MAINE SOCIETY will aid in the erection of a memorial at Oldtown, telling of the patriotic deeds of the Penobscot Indians during the War of the Revolution. Mr. Nathan Goold, the Historian of the Society, has gathered much interesting information concerning the participation of the Penobscots in that war, and has published much of it in local papers and elsewhere.

THE MASSACHUSETTS SOCIETY celebrated "Patriots' Day," April 19, by holding its twenty-first annual business meeting at the "Old South Church," Boston, followed by a dinner at the American House. An interesting ceremony at the meeting was the trooping of the colors by a detail from Troop A of the First Squadron of Cavalry, the National Lancers, in command of Capt. John S. Barrows, President of Boston Chapter, S. A. R.

The following officers were elected: President, Nathan Warren, of Waltham; Vice-Presidents, Edwin Sanford Crandon, of Cambridge; Luke Stearns Stowe, of Springfield, and Luther Atwood, of Lynn; Secretary-Registrar, Herbert Wood Kimball, of Waban; Treasurer, Dr. Charles Montraville Green, of Boston; Historian, Brig. Gen. Philip Reade, of Lowell; Chaplain, Rev. Lewis Wilder Hicks, of Wellesley.
