PRESIDENT GENERAL'S LETTER TO COMPATRIOTS.

OFFICE OF PRESIDENT GENERAL,

To the Members of the State Societies of the Sons of the American Revolution.

COMPATRIOTS: The summer vacation season is now over and we are all settled down for the various duties that we have before us, and I take this opportunity to urge upon you now to put forth your best efforts towards increasing our membership, as it is my ambition and yours to make this the Banner Year, in this respect, in the history of the Society.

The reports from two or three of the State Societies, which I have before me, show that already they have undertaken the work in earnest and with gratifying results.

It will be impossible for me to visit all of the State Societies during my official term, but I shall be glad to meet with as many as possible, and have already arranged to be the guest of the Illinois State Society on October 19, the Vermont State Society on November 9, and the Michigan State Society on February 22. If there are to be any meetings of any of the other Societies on dates other than those mentioned, and the compatriots feel that my presence would be in any way an inspiration or a benefit to them in their work, I shall be very glad to correspond with such Societies and arrange to meet with them, if possible. I made this pledge at the time of my election, and am very anxious to fulfill it.

There has been nothing of special importance that has required my official attention thus far. I take pleasure in stating, however, that many of the subscriptions promised at Toledo toward the permanent fund have been paid in, and a New York City bond to the amount of one thousand dollars has been purchased by the Finance Committee, and is in a safe-deposit vault in this city. Some of the State Societies have not yet paid the subscriptions promised, and it is desirable that such payments be made with as little delay as possible.

There will be a meeting of the Executive Committee on November 19, and if any of the State Societies have any matters to bring to the attention of that committee they will kindly correspond with the Secretary General in regard to it.

Trusting that this letter may be the means of my coming in closer relationship with more of the State Societies, I am

✓ LOUISVILLE CONGRESS.—The Twenty-second Annual Congress will meet at Louisville on April 30, 1911, as the guests of the Kentucky Society.

THE NATIONAL YEAR BOOK for 1910 is nearly ready for distribution. It will be mailed to the General Officers, Trustees, delegates present at the Toledo Congress, Chairmen of National Committees, officers of State Societies, and to the Presidents of local Chapters. The edition of the book is 750 copies, and those remaining after the authorized distribution as above will be available to any compatriot on payment to the Secretary General of fifteen cents per copy to cover cost of mailing. The supply of Year Books for prior years is exhausted.

COMMITTEE ON INFORMATION FOR ALIENS.—State Societies and compatriots generally are urged to active endeavor to aid in the early assimilation into American citizenship of the millions of aliens throughout our country, by the wide distribution of leaflets Nos. 1 and 2, published by this Society. No. 1 leaflet entitled "The United States, Its Opportunities, Government, and Institutions," is published in English and in eleven foreign languages. No. 2 leaflet, on Naturalization, is in English only. The Committee is prepared to supply these leaflets free of charge and will forward them in any number desired to any address. The names of officers of organizations of foreigners and of large employers of foreigners are requested. For leaflets or information write to Commander John H. Moore, U. S. THE COMMITTEES ON ORGANIZATION report some progress toward the formation of State Societies in North and South Carolina and in North Dakota. Judge Charles S. Lobingier, of Manila, and a number of other compatriots resident in the Philippines, together with several men who are perfecting application papers, have petitioned for a charter for the Philippine Society of the Sons of the American Revolution.

✓ THE COMMITTEE ON GEORGE WASHINGTON MEMORIAL BUILDING reports that about \$2,500 has so far been received from members of the Sons of the American Revolution in response to the circular issued July 11, 1910.

This Committee was appointed in accordance with a resolution adopted at the Toledo Congress, "to confer and coöperate with the George Washington Memorial Association, under the supervision and direction of the Executive Committee of this Society." The members of the Committee are Dr. Charles D. Walcott, Secretary of the Smithsonian Institution; Col. Charles Lyman, of the Treasury Department, and Rear Admiral Yates Stirling, U. S. N., President of the Maryland Society. A pamphlet distributed by the Association sets forth its objects as follows:

The George Washington Memorial Association was incorporated in the City of Washington in September, 1898, for the purpose of erecting a building to be known as the "George Washington Memorial Building," in commemoration of our first President and his interest in higher education in America. Washington often expressed the thought contained in his various messages to Congress, and in his Farewell Address: "Promote, then, as an object of Primary Importance, Institutions for the general diffusion of knowledge." He also urged "the promotion of science and literature."

This Memorial Building is to be practical in plan and construction, and of the most durable character. It is to be planned so as to furnish

a home and gathering place for National, Patriotic, Scientific, Educational, Literary, Art, Medical, and similar organizations that may need such accommodations. It will furnish a place where all the Patriotic Societies both North and South may testify to their love for the Father of his Country. The building will contain a great hall or auditorium and rooms for large congresses, rooms for small and large meetings, office rooms and students' research rooms.

We propose to raise two million dollars for the building, and an additional five hundred thousand as an endowment for maintenance in order that conventions and societies can use this building without charge for rental.

Mrs. Henry F. Dimock, President of the Memorial Association, reports that \$50,000 is in the treasury, and a like amount subscribed by various Societies and individuals. A large meeting in the interest of the movement will be held in Boston in December, and in other parts of the country great progress is looked for in the next three months.

On the Advisory Council of the Association are included Compatriots Hon. Elihu Root, Gen. Horace Porter, and Dr. Charles D. Walcott.

DELAWARE RIVER PARK.—On May 18 circulars were sent to each State Society containing resolutions adopted at the Toledo Congress, favoring the establishment of a National Park to commemorate "Washington Crossing the Delaware." These resolutions were printed in full on pages 16, 17 of the May BULLETIN. Societies were requested to urge upon Senators and Representatives in Congress immediate action thereon, but no national bill has so far been introduced toward the consummation of this commendable project.

JOHN PAUL JONES.—On June 1, 1910, Compatriot Depew introduced in the U. S. Senate a proposed amendment to the Sundry Civil Bill, providing for the appropriation of \$135,000 "for completing and furnishing in every respect the crypt of the chapel at the U. S. Naval Academy, as a permanent resting place for the body of John Paul Jones." By direction of the President General a letter was addressed to the Presidents of State Societies requesting them to take such action as might be feasible to secure the passage of the above amendment, but the early closing of Congress prevented its consideration and enactment.

OGLETHORPE MONUMENT.—Compatriot Geo. Wm. Drummond, of the Maine Society, has been designated by the President General to represent the National Society at the unveiling, at Savannah, on November 24, of a monument in memory of General James Edward Oglethorpe, English founder of the Colony of Georgia.

DOINGS OF STATE SOCIETIES.

✓ THE CALIFORNIA SOCIETY held a banquet at Key Route Inn, Oakland, on August 27, in commemoration of the last engagement of the Revolutionary War, at Combahee Creek, South Carolina, on August 27, 1783. Among the speakers were Compatriot Ex-Governor George C. Pardee, Mayor Mott, of Oakland; Mr. A. J. Vining, and Rev. Thomas F. Boyer. The occasion was the most enthusiastic for years.

At the annual meeting of the Society on April 19, 1910, the following officers were elected, all residents of San Francisco: President, Thomas A. Perkins, Mills Building; Senior Vice-President, O. D. Baldwin, 1000 Green Street; Junior Vice-President, A. J. Vining, 2134 Pine Street; Secretary, Edwin Bonnell, 101 Montgomery Street; Treasurer, A. D. Cutler, 510 Kohl Building; Registrar, A. S. Hubbard, 2135 Sutter Street; Marshal, F. W. Cushing, Oakland Custom House.

Thirteen new members were elected on July 13.

The San Diego Chapter, No. 2, of the California Society, was organized on June 13 with about 20 members. The following officers were elected: President, W. J. Mossholder; Vice-Presidents, A. E. Dodson and Franklin P. Reed; Secretary, John R. Berry; Treasurer, John P. Burt; Marshal, Charles A. Joslyn; Historian, Ed. M. Burbeck; Chaplain, Dr. A. Judson Gray.

✓ THE COLORADO SOCIETY has published a manual containing a letter to its members, general information concerning the objects of the Society, list of members, and other data. There has also been printed an address delivered before the Society by President Wardner Williams on February 22.

✓ THE CONNECTICUT SOCIETY, on June 17, at Compo Beach, Westport, unveiled a life-size bronze statue of "The Minute Man," designed by H. Daniel Webster, and erected by the Society to commemorate the heroism of the patriots who defended their country when the British, under General Tryon, invaded Connecticut in April, 1777. General David Wooster, Colonel Abraham Gould, and more than 100 Continentals fell in the engagement at Ridgefield and closing at Compo Hill. The ceremonies included singing by a High School chorus and children of other schools, and patriotic addresses by Hon. Morris B. Beardsley, President Lewis B. Curtis, Selectman Wakeman, of Westport; William H. Burr, Mr. Webster, Mrs. Buel, the State Regent, and Mrs. Sterling, the Vice Regent of the Daughters of the American Revolution, and concluded with a poem on "The Minute Man," by Mrs. Agnes Lewis Mitchell.

In presenting the statute on behalf of the committee Judge Beardsley said:

In the introductory note by the editor of the admirable article of Mr. Burr upon the extent which the monument to be unveiled today is to commemorate, and which I hope every one who has not already done so will read, occurs these words:

"The American people are inclined to undervalue the nation's historic shrines and in its unparalleled prosperity the noble landmarks are being swept away to make room for progress. Such is the thoughtlessness of a material age when the supreme moment is the next one and the great yesterdays are forgotten." It requires an organized appeal to gain the attention of the populace today.

The patriotic societies, among which ours occupies no mean place, furnish the medium for making this appeal and the organization necessary to carry it into effect. Among the objects enumerated in our constitution is "to mark the scenes of the Revolution by appropriate memorials."

The Connecticut Society of the Sons of the American Revolution has to its credit in this line the purchase, fitting up, and maintenance of the old war office at Lebanon; the purchase and restoration of the Nathan Hale school house at New London, and five bronze tablets marking historical sites in different parts of the State.

Connecticut is not rich in these sites. She furnished about one-eighth of the entire Continental army. Her sons fought on every field, but little at home. It was her boast, and almost true, that no foreign foe ever remained over night on her soil.

The Connecticut Society has published an illustrated pamphlet of 31 pages, entitled "The Minute Man," arranged by Henry C. Sherwood, fully descriptive of the occasion.

The oldest living member of the Sons of the American Revolution is enrolled in the Connecticut Society, Elijah Clark Sears, born June 23, 1805, now resident in South Dakota.

General David Humphreys Branch of New Haven, on Memorial Day, June 26, 1910, assisted by the Second Company Governor's Foot Guard (organized March 2, 1775), decorated the graves of 187 Revolutionary soldiers and patriots in Grove Street Cemetery and elsewhere. The exercises included invocation by Rev. Anson Phelps Stokes, Jr., Chaplain of the Chapter; remarks by President Seymour C. Loomis, and an address by Hon. A. Heaton Robertson. The names of the soldiers and patriots and the location of their graves are printed in the program of the occasion.

THE EMPIRE STATE SOCIETY has published a "Year Book for 1909-1910" of 107 pages containing "List of Officers and Members. Constitution and By-Laws. Information for Candidates. Reports of the Secretary, Treasurer, and Registrar. Addresses delivered at Society meetings

and banquets. List of Revolutionary events." The invested "Special Fund" of the Society aggregates \$9,878.91.

The Committee on Memorials to the New York Signers of the Declaration of Independence reported to the Board of Managers as follows, on October 7:

The Chairman of your committee, appointed to "locate the graves of the four Signers of the Declaration of Independence from New York," would respectfully report the following facts:

PHILIP LIVINGSTON was born in Albany, N. Y., Jan. 15, 1716. He died in York, Penna., June 12, 1778, and was buried in the Livingston vault in Trinity Churchyard May 12, 1810.

GENERAL LEWIS MORRIS. In St. Ann's Church, corner of St. Ann's Avenue and 140th Street, Morrisania, there is a tablet in memory of the Morris family inscribed thus: "1654-1848—To the glory of God and in loving memory of Captain Richard Morris, an officer in Cornwallis's Army," and thereafter follows a short sketch of the Morris family, including the following words: "General Lewis Morris, eldest son of Hon. Lewis Morris and Catherine Staats, born at Morrisania April 8, 1726, where he died January 22, 1798. He served in the army of the Revolution with his three sons, Lewis, Jacob, and William, and was one of the Signers of the Declaration of Independence. And his wife Mary Beckman Walton, who died March 11, 1794."

GENERAL WILLIAM FLOYD, born in Brookhaven, Suffolk Co., Long Island, December 17, 1754; died in Oneida Co., N. Y., and was buried in the village cemetery of Westonville in that county, not far from the village of Floyd, which took his name and was his home. His grave is in perfect condition, and a large and dignified sarcophagus has been erected by his descendants.

FRANCIS LEWIS, born in Wales May, 1713; died in New York City December 30, 1802, aged 90 years; was buried in Trinity Churchyard January 1, 1803. The exact location of his grave has not been discovered, but is supposed to be in the northwest corner. In St. George's Episcopal Church, Flushing, L. I., there is a tablet inscribed as follows: "1713-1803.—In memory of Francis Lewis. A Signer of the Declaration of Independence of the United States. A church warden of this church, 1765-1790."

THE ILLINOIS SOCIETY is experiencing a healthy growth, thirty new members having been received during the summer months. Its enlarged library space is proving a helpful feature. Several new and valuable volumes have recently been purchased. The Society participated in the

notable Chicago Sane Fourth of July celebration. The Recruiting Committee has recently compiled and published a list of several hundred men eligible for membership, and systematic efforts to interest them are now being made.

On September 16 the Board of Managers, 21 members being present, were entertained at supper at the River Forest Country Club by Secretary Bowman and his wife. There were patriotic addresses and music, and the guest of honor, Mr. Revere Lincoln, great-grandson of Paul Revere, made a few pleasing remarks. A new leaflet entitled "How to Become a Member," has been published. The present membership of the Society is 625, of which 421 are in Chicago and vicinity, 132 are in other Illinois cities, and 72 are in other States.

The Oak Park Chapter arranged for a number of its members to deliver addresses in the public schools upon national peace day. A new local Chapter is in process of formation at River Forest, Ill. The Annual Yorktown Day Banquet was held October 19, with President General Marble as the guest of honor.

✓ THE INDIANA SOCIETY has issued an eight-page recruiting circular of directions for tracing ancestry, with references to sources of information for Revolutionary service in the various colonies. A membership committee, with President George Oscar Dix, of Terre Haute, as chairman, consists of twenty-six compatriots, scattered in twenty-three Indiana cities and towns.

✓ THE IOWA SOCIETY has been seeking to influence educational processes along patriotic lines. With the intent to stimulate the study of the history of the United States, in 1907 the Society authorized the bestowing of a bronze medal upon the student of each college in Iowa who should during the year do the best work in the study of the history of the United States. This proposition was made to twenty colleges in the State at the beginning of the academic year in 1907. The term "college" here includes universities as well. As a result twelve medals were bestowed on students of as many colleges at commencement time in 1908.

In 1909, sixteen medals were bestowed on college students and six on students in high schools, the high school medals being gifts of individual members of the Society.

At commencement season of 1910, fifteen medals were awarded to college students and an equal number (of special design) to pupils in high schools. In Des Moines the three high schools each embraced the plan of competing for the History medals. These medals have no intrinsic

value to appeal to the student, yet are sought with eagerness and highly prized by the winners, and the testimony of educators is that these competitions are exerting a wholesome, stimulating influence in the schools and producing the result desired in stimulating patriotic thought among the student body of our people.

At its annual meeting, on April 19, the Iowa Society elected the following officers: President, Hon. David Charles Mott, Marengo; Vice-Presidents, Hon. Elmer Marston Wentworth, and Rev. Ezra Butler Newcomb; Treasurer, Leo Eugene Stevens; Secretary, Capt. E. D. Hadley, of Des Moines; Registrar, Dr. E. H. Hazen, of Des Moines; Chaplain, Rev. James Perkins Burling, of Des Moines.

✓ THE KANSAS SOCIETY has established an annual cash prize of a five-dollar gold piece to the history class of Bethany College for the best essay on the cause of the American Revolution. The presentation for the present year was made on June 6, by J. M. Meade, President of the Society, to Miss Dorothy Wood.

✓ THE KENTUCKY SOCIETY, on June 17, held a "smoker" and business meeting at the residence of its President, George Lewis Danforth, in Louisville. The Society is adding to its numbers and expects a large increase in membership during the present year, and is enthusiastically arranging for the Annual Congress of the National Society on April 30, 1911.

Mr. W. K. Boardman, 424 W. Jefferson Street, Louisville, was elected Secretary on June 17. On July 4 a patriotic meeting of the Society was held at the residence of Compatriot James F. Buckner at Pewee Valley, near Louisville.

✓ THE MARYLAND SOCIETY strongly commends the suggestion of its Vice-President, George W. Hyde, that all bands on vessels leaving and entering the harbor of Baltimore play "The Star Spangled Banner" when passing Fort McHenry. It is the judgment of the Society that such a custom would be "a timely and fitting tribute to the National Hymn, as well as a forceful reminder to all persons passing Fort McHenry of that historic spot, and of the successful repulse of the British which inspired the distinguished Marylander, Francis Scott Key, to write the song which is now the inspiration of the Nation."

✓ THE MASSACHUSETTS SOCIETY observed its Annual Field Day at Malden on the new holiday, Columbus Day, October 12. The Society assisted in the exercises attending the unveiling of the memorial tablets at Bell Rock Memorial Park. The program included introductory re-

marks by Frank E. Woodward, President of the Malden Chapter; address by Edwin S. Crandon, Vice-President of the Society; address by Mayor George H. Fall; unveiling of the tablets by Miss Elizabeth Dexter Walker and Miss Katherine Hall; address by Sylvester Baxter, chairman of the Malden Park Commission, and an address by Charles E. Mann, President of the Malden Historical Society.

The Revolutionary tablet, originally placed on the boulder at Bell Rock, was removed to give place to the new soldiers' monument, and was replaced on the left facade of the base of the new monument, while the new Founders' tablet was placed on the opposite side of the facade.

Following the exercises at the park the members of the State Society were served a banquet in the ball-room of the auditorium. Vice-President Edwin S. Crandon presided, and among the speakers were ex-Mayor Levi S. Gould, of Melrose; Mayor George H. Fall, of Malden, Joseph Santosuosso, of Boston.

The Committee of the Society in charge of the arrangements were President Nathan Warren, Charles K. Darling, Luther Atwood, Frank E. Woodward, Alphonso S. Harris, John S. Barrows, and William H. Winship.

The Malden Chapter of Massachusetts held its annual meeting and dinner on May 31, at the City Club, Boston, and elected the following officers: President, Frank E. Woodward; Vice-Presidents, William H. Winship and Spencer T. Williams; Secretary, W. K. Watkins; Treasurer, Charles L. Parker; Historian, W. B. Snow. Addresses were made by Hon. L. A. Frothingham, Lieutenant Governor of Massachusetts; President Woodward, Edwin S. Crandon, Vice-President of the State Society; Melville C. Freeman, and Mayor Fall, of Malden.

✓ *THE NEW HAMPSHIRE SOCIETY* held its annual meeting in the Memorial Parish house at Concord on July 12, when the following officers were elected: President, Otis G. Hammond, Concord; Vice-Presidents, Franklin W. McKinley, Manchester; John K. Bates, Portsmouth; Henry H. Metcalf, Concord; Secretary-Treasurer, Howard F. Hill, Concord; Historian, H. H. Metcalf, Concord; Registrar, William P. Fiske, Concord; Chaplain, Rev. L. Waterman, Hanover.

Rev. Howard F. Hill, D. D., Secretary-Treasurer, reported the Society in good condition with an active membership of 295. Rev. William Elliott Griffis, D. D., L. H. D., delivered an address on "The New Hampshire Brigade in the Sullivan Campaign of 1779."

✓ *THE NEW JERSEY SOCIETY*, on June 23, held exercises at Springfield, commemorative of the 130th anniversary of the battle at that place, and

dedicated a flag-pole and raised a flag at the Revolutionary Cemetery, recently deeded to the State Society. The celebration was the first held on the grounds since 1896, when the Society erected a granite memorial shaft in the cemetery. Judge Edward S. Atwater, President of the New Jersey Society, presided and delivered the introductory address. The principal speaker of the day was Rev. Dr. William M. Lawrence, of North Orange, whose subject was "Battle of Springfield—Some of Its Lessons." In his address Mr. Lawrence said:

New Jersey was the pivotal point of the American Revolution. The Battle of Springfield was one of the most important engagements in the war. The battle which was fought here, directly on the ground where we are standing, was the third battle in which Springfield citizens engaged.

The British wanted Springfield for its value as a strategic point. There was a powder mill located here, guarded by an army. The British wanted the powder mill and they wanted to defeat the enemy, which protected it. It is hard to realize that Springfield is but five or six miles from Staten Island, and but a short distance from New York, and when we do, we realize the value of occupying Springfield.

The citizens of this section had more to contend with than those in many other sections of the country where the battles were fought. A brigade was formed for the purpose of fighting for the British, so that the patriots had not only to fight the British and the soldiers the British had hired from Germany to kill them, but they were compelled to battle almost against their own households.

By a ruse the British hoped to split the American army and defeat it. The ruse was partly successful. Washington was completely fooled. He left a portion of his army encamped near here under the leadership of Nathanael Greene. General Greene had but 1,500 men. The British had between 5,000 and 6,000, and twenty pieces of artillery. Yet in the Battle of Springfield the British lost 300 men, while there were but 100 fatalities on the American side. With a force of men one-quarter of the size of the enemy, they defeated them decisively with a loss of but one-third as large.

It was this battle, that was one of the three decisive battles of the war, which led to the final withdrawal of the British from America.

Principles never change. Liberty means as much to the men and women in the country today as it did in the days of '76. It should be taught with the same enthusiasm and thoroughness as it was then. Men who dwell with privileges are apt to forget their responsibilities and be satisfied with things as they are.

This is the great temptation that faces us. Many are apt to be content that their fathers have done all the work and they are merely to reap the benefits. That we may not forget our responsibilities and remain steadfast to the doctrines of our fathers, history must be taught. The knowledge of the fights and history of our forefathers is essential and obligatory if we would remember our responsibilities.

It is on such occasions that history is really taught, scientifically and thoroughly—by a vivid and vital presentation of scenes and facts. The Society of the Sons of the American Revolution has done more to teach

the people of the country their country's history than any college or school in the United States. It erects monuments and every monument erected impresses a certain fact or historical interest in the minds of all who see it. If your children are taught history in this way they will soon teach it to the immigrants, and the glorious Stars and Stripes for which blood was shed and homes were burned on this very spot will never be hauled down.

Among the guests of the day were President General Marble and Treasurer General Burroughs. On the return to East Orange a supper was served at the English Banquet Hall in honor of the President General and other guests. Historian General David L. Pierson served as toastmaster, and remarks were made by Mr. Marble, Doctor Lawrence, Mr. Burroughs, Mr. Huntting, and several others.

✓ THE PENNSYLVANIA SOCIETY, on June 29, held a noonday luncheon on the Hotel Lincoln Roof Garden, Pittsburg, when members were requested to invite friends eligible to the Society. The exercises included patriotic music by the Ladies' Royal Orchestra, and short talks on the objects of the Society. The Flag Committee has published for general distribution "Copy of Law to prevent and punish the desecration of the Flag of the United States, and of this State," adopted May 23, 1907.

✓ THE RHODE ISLAND SOCIETY, on May 30, held its customary Memorial Day exercises at Hopkins Park, Providence, when large numbers of Italian school children and their parents paid honor to Commodore Esek Hopkins. President Frederic W. Easton, of the Rhode Island Society, presided and made the introductory address. The Declaration of Independence was read by Compatriot Amasa M. Eaton; "Song for Memorial Day" was rendered by the school pupils, and an address on the day was given by Mr. Rathbone Gardner. The pupils of the fifth grade gave the declamation "Captain, O, My Captain," in concert, after which a wreath was placed on the Hopkins statue. Prof. Alessandro G. Laurenzio followed with an address in Italian on "The Duty of Italians to their Adopted Country."
