THE OFFICIAL BULLETIN records action by the General Officers, the Board of Trustees, the Executive and other National Committees, lists of members deceased and of new members, and important doings of State Societies. In order that the Official Bulletin may be up to date, and to insure the preservation in the National Society archives of a complete history of the doings of the entire organization, State Societies and local Chapters are requested to communicate promptly to the Secretary General written or printed accounts of all meetings or celebrations, to forward copies of all notices, circulars, and other printed matter issued by them, and to notify him at once of dates of death of members.

THE ANNUAL CONGRESS.

By direction of the President General the following circular was issued, and the replies being almost unanimous in favor of delay, the President General has decided that, unless unforeseen conditions should arise to necessitate an earlier session, the adjourned Congress will reconvene on the third Monday in May, 1918:

SEPTEMBER 21, 1917.

COMPATRIOT: At the session of the Twenty-eighth Congress of the National Society at Nashville, Tenn., on May 21, 1917, attended by President General Wentworth, Past President General Thruston, Vice-President General Boardman, State President Rawles of Arkansas, State President Hume of Tennessee, and delegates Sioussat, John De Witt, and Carey Folk, the following resolution was unanimously adopted:

The Society of the Sons of the American Revolution, true to its principles, has so imbued its members and their families with the spirit of patriotic service that when our country entered into the present conflict to preserve the principles of democracy the response to the President's call was practically unanimous. Those of military age rallied to the colors. The older members engaged in the varied patriotic activities which are equally essential to place this nation in position to do its duty to humanity.

Recognizing that attendance at the Annual Congress of the National Society of the Sons of the American Revolution called to convene at Nashville, Tenn., May 21, 1917, would interfere with the performance by delegates of their higher duty of national service and of preparation for such service, the National Executive Committee recommended to the President General that the Congress should be postponed, and notice thereof was sent to all officers and delegates entitled to representation therein: and

Whereas the Twenty-eighth Congress of the Society of the Sons of the American Revolution, duly assembled in the city of Nashville this 21st day of May, 1917, is without the requisite number of delegates to constitute a Congress of the said Society for the transaction of business; therefore

Be it resolved, That this Congress do now adjourn to meet in the city of Nashville, State of Tennessee, upon the call of the President General, on the giving of at least three weeks' notice by the Secretary General of this Society of the time designated by the President General.

The President General instructs the Secretary General now to communicate with the general officers, the Past Presidents General, and officers of State Societies, to ascertain their opinion as to whether it is advisable to hold the adjourned session of the Congress during the present autumn, and at what date, or to defer meeting until the customary time in May, 1918.

The necessary routine business usually transacted at the Annual Congress, with the exception of the election of officers, was acted upon by the Executive Committee at its meeting in New York on May 24, and the activities as well as routine affairs are progressing without delay or hindrance.

DEATH OF MOSES GREELEY PARKER, M. D.

Moses Greeley Parker, M. D., President General in 1911, died suddenly at Lowell, Mass., October 1, 1917, aged 75 years. He received his degree of M. D. from the Harvard Medical School and from European institutions. He served in the Civil War as assistant surgeon in the 57th Mass. Infantry. He became interested in the telephone industry at its very beginning and was a large stockholder and a director of the New England Telephone and Telegraph Company and of other telephone companies. He was deeply interested in medical and surgical work and in philanthropic and patriotic activities, being a member of many organizations, and for many years was one of the leading practitioners in his native city.

During his busy life Dr. Parker found time to devote to the study of electricity and was the first to photograph the electric current and show that it takes the form of spirals. Dr. Parker also invented a thermocautery, and not long after devised and patented an improvement in the process of producing and maintaining a very high degree of heat by hydro-carbonization. The Massachusetts Charitable Mechanics' Association presented him a diploma for an incandescent cautery. He was a contributor to medical and scientific journals.

OBSERVANCE OF CONSTITUTION DAY.

The President General issued a circular calling upon State Societies, Chapters, and individual compatriots to observe on Monday, September 17, a celebration in honor of the deputies who, on September 17, 1787, signed the completed Constitution of the United States. In many parts of the country public attention was called to this celebration and appropriate exercises were held in observing the anniversary of the signing of that great document, "a still more glorious triumph in the cause of national liberty than even that which separated us from the mother country."

WAR ACTIVITIES.

The Sons of the American Revolution all over the country are doing their patriotic duty by personally participating in activities connected with the war of 1917. More than 300 are rendering service in the United States Army and Navy. A large number stand ready for home defense in the State Guard. Many are leaders and otherwise actively at work in the Red Cross, the War Y. M. C. A., in Food Conservation, in expediting the building of ships and airplanes, and other industrial efforts. Many of our compatriots are among the leading financiers who have successfully provided war funds.

The National Society, through the Executive Committee, urges State Societies, Chapters, and individual members to do their utmost in aiding the War Council of the American Red Cross, the official body for war-relief work.

In order that the patriotic efforts of this Society in connection with the war of 1917 may be of the highest efficiency in the national service, avoiding duplication or overlapping of activities by other organizations, the Executive Committee has recommended that State Societies and Chapters operate in general under the advice and direction of State and local councils formed by the Council of National Defense as organized by Congress.

LEAGUE FOR NATIONAL UNITY.

The League for National Unity was organized at Washington on October 8 for the following purpose:

To create a medium through which the loyal Americans of all classes, sections, creeds, and parties can give expression to the fundamental new war for the independence of America and the preservation of democratic institutions and the vindication of the basic principles of humanity.

The President, in accepting the offer of service by the League, acknowledged the government's real need of such an authoritative group. He affirmed his full belief that the people of the United States were not in doubt as to the justice of our cause, and were whole-heartedly behind the prosecution of the war to a successful conclusion, but made recognition of the necessity for an organization of public opinion—a new emphasis upon the importance of team play.

The League for National Unity will have its headquarters in New York and will organize at once for service. The chairman of the League is Compatriot Theodore N. Vail of the Empire State Society of Sons of the American Revolution, President of the American Telephone and Telegraph Company.

CIFTS TO SOLDIERS IN FRANCE.

One of the State Societies having under consideration the gift of a supply of chocolate for American soldiers in France, inquiry was made of the War Department as to the best method of procedure and of securing shipment. In reply the Quartermaster General advises the Society that chocolate is on the list of supplies kept on hand by the Quartermaster Corps for sale to officers and enlisted men. Chocolate has been and is being shipped to France, and such quantities as desired can be procured by troops serving there. It would be manifestly inadvisable for the War Department to distribute gratuitous contributions of such supplies as are provided for sale. At present all available cargo space of transports to Europe is being utilized in carrying supplies absolutely necessary for the troops. It is expected that in the future a limited amount of cargo space will be available for carrying small packages to our soldiers, and it is suggested by the Quartermaster General that all arrangements for contributions be made with the Red Cross authorities, to whom the work of effecting the distribution of gifts has been assigned.

LIBERTY LOAN OF 1917.

The individual subscriptions of members of the Sons of the American Revolution to the First Liberty Loan aggregated more than \$50,000,000, while many millions more of subscriptions were made by establishments under the direction or control of members of the Society. The National Society and several State Societies invested portions of their treasury funds in the Liberty Bonds.

The Treasury Department of the United States now urges the cooperation of the Society through the purchase of bonds of the Second Liberty Loan of 1917. A letter to the Secretary General from the Director of Publicity of the Loan reads in part as follows:

To carry on this war our government must have funds. Our men at the front must have food and all the things so essential to victory. This money must be supplied through the purchase of bonds of the Second Liberty Loan of 1917. The proceeds of this Loan will be used to purchase supplies for our men on the firing line and for those of our allies with whom we have made common cause. You and the members

of your organization can perform no more patriotic act than by buying Liberty Bonds. Every effort should be put forth to reach the goal of five billion dollars and ten million subscribers. The larger the number of subscribers the greater will be the moral effect upon those countries, the rulers of which have forced the United States Government to take up arms to defend American honor and American rights.

Liberty Bonds are the safest investment in the world. Liberty Bonds afford everyone an opportunity to demonstrate his patriotism in a substantial way. A Liberty Bond may save a soldier. Liberty Bonds will help to shorten this conflict by providing your government with sufficient funds to conduct the war in an efficient manner, and hasten the advent of peace. There should be a Liberty Bond in every home. I feel confident that your organization will leave nothing undone to make the Second Liberty Loan of 1917 an overwhelming success.

FOOD CONFERENCE.

On invitation of Mr. Hoover the Secretary General attended an informal conference of representatives of patriotic societies called together at Washington on July 11, to discuss plans for enlisting the members of these organizations in the important work of food conservation. Mr. Hoover addressed the delegates and explained the object and purposes of the food conservation campaign, and showed the immense saving that can be effected by voluntary individual economies amounting to only a few cents a day. He dwelt upon the moral and patriotic aspects of the movement and declared that if the nation can get rid of extravagance and learn to live simply the benefit will endure

Dr. Ray Lyman Wilbur outlined the purposes of the division of food conservation, and declared that we are embarking on a test of the strength of the methods of autocracy and democracy. We must save now, through voluntary effort, or run the danger of being forced to go without necessary food later. Saving food and other resources now is the most effective way of ending the war with victory.

The following resolutions were adopted:

I. "That we, as individuals, bind ourselves to carry out in our own households the recommendations of the United States Food Administrator and in particular to make through the most convenient channels

2. "That each of us, in his representative capacity, pledges the approval and co-operation of his organization, and will recommend specific action by such organization with a view to the enrollment of its membership and such other persons as it can readily reach without duplication of effort, as active agents in co-operation with the United States Food Administrator, and to making by each member of the weekly reports of individual progress in conserving food and eliminating waste, and such other measures as the Food Administrator may, from time to

SONS OF THE AMERICAN REVOLUTION SERVICE BAR.

The Executive Committe has authorized the issuance and presentation to each compatriot who may enlist in the Army or Navv of the United States during the War of 1917 a service bar in the colors of the Sons of the American Revolution, and it is the desire of the National officers that every compatriot so enlisting or now in the service of the nation be presented with and wear this bar whenever permissible in accordance with official regulations. Application should be made through Secretaries of State Societies, stating name, address, and branch of service to which member belongs, the application to be endorsed by the State Secretary and forwarded to the Secretary General.

The bar is not an emblem of merit, but is a mark of membership in our great patriotic Society. It is designed to take the place of the lanel button or rosette, which cannot be worn on uniforms. It is limited to the Army and Navy for the reason that members in Red Cross or Y. M. C. A. war service in civilian clothes can wear the lapel button. The authority for wearing the badge of the Sons of American Revolution is Uniform Regulations of 1917 (Office of the Quartermaster General), paragraph 64 (b):

64 (b). Badges of military societies may be worn by officers and enlisted men who in their own right, or by right of inheritance, are members of military societies of men who served in the armies and navies of the United States in the War of the Revolution, the War of 1812, the Mexican War. *

It is not permitted, however, to wear the formal insignia of military societies at the same time as the official medals or badges awarded by the government (62d), nor can any medals or badges be worn on other than full-dress uniform (64d).

The Quartermaster Corps furnishes bars bearing the ribbons of government medals and badges to be worn on service uniforms, and likewise the Sons of the American Revolution provides ribbon bars to be worn by its members on service uniforms, but the Society ribbon bars should not be worn together with government bars.

More than three hundred (300) service bars have been issued to compatriots, and additional names are reported daily. It is expected that a complete roster of compatriots in the Army and Navy of the United States will be published at a later date. Among the State Societies so far represented in United States Military and Naval Service are: Arizona, 2: California, o: Connecticut, 6: District of Columbia, 5; Empire State, 43; Illinois, 7; Indiana, 1; Iowa, 18; Kansas, 2; Maine, 3; Massachusetts, 47; Michigan, 24; Minnesota, 1; New Jersey, 41; Ohio, 6;

Pennsylvania, 11; Utah, 27; Washington, 20; Wisconsin, 12. Included in the list are 3 rear admirals, and many other high officers in the navy. In the army there are 3 brigadier generals, 20 colonels and lieutenant colonels, 15 majors, 60 captains and lieutenants, 25 medical officers, 15 in Signal and Aviation Service, many in Quartermaster Corps and Ordnance Department, and a large number in officers' training camps awaiting assignment.

THE WASHINGTON GUARD.

To the Members of the National Society of the Sons of the American

Compatriots: Despite the hearty support of the last National Congress and the loyal co-operation of the President General and his Executive Committee, the work of enrollment of the names of the sons of our members under the age of twenty-one (with their ages and addresses) has lagged somewhat.

On all sides we hear of naught but enthusiastic approval of the Washington Guard; but to perfect the enrollment and the organization in the various States it is of the utmost importance that we should secure the services of at least one enthusiastic member from each State who will undertake the work of enrollment and proper organization.

These are strenuous times and it is indeed difficult for our busy members-all serving their country in some form or other-to spare the time for any work that is not of immediate importance.

It is my privilege to report that many of the young men now enrolled in the Washington Guard throughout the country have enlisted in their

A junior organization of the Sons of the American Revolution will undoubtedly do much for the parent Society and any young man or boy will be proud to be enrolled therein. The question which has been uppermost in the minds of those directly concerned in the administration of the Guard's affairs is this: AFTER ENROLLMENT, WHAT?

You will readily understand that it is difficult to build such a junior organization on the foundation of social intercourse, for older Guardsmen do not readily "mix" well with younger Guardsmen. Patriotic meetings, of course, enlist the interest of all, but the social side is also necessary. It has been the aim and purpose of the undersigned—for over a year now-to find one common aim which will serve to stimulate a real interest among all Guardsmen from ten years to twenty-one, and I am pleased to report that we have found it.

Having found it, we thought it best to "try it out" first before bringing the plan to the attention of the State Societies. The success achieved has been far beyond our fondest dreams.

THE PLAN IS THIS: A MILITARY ORGANIZATION WITHIN THE WASHING-TON GUARD. The military organization is open to Senior Guardsmen (15 to 21) and to Guardsmen (10 to 15), sons of members and others who may be eligible by right of descent from a soldier or sailor of the American Revolution. Those Guardsmen who do not care to enlist in the military organization are not obliged to do so and they may still be enrolled members of the Guard.

Post No. 1 of the New Jersey Commandery of the Washington Guard (the baby of Orange Chapter) is proof of the wisdom of this move. The roster now contains over seventy-five names of boys between the ages of twelve and eighteen. The Post drills every Thursday night in the Sunday-school room of the Central Presbyterian Church of Orange, and we gained at least three new recruits each drill night before the close of the drills at the end of June.

Post No. I, with its handsome uniforms of dark blue cloth, trousers striped with wide buff stripe, white belt, etc. (colors of the S. A. R.), is in great demand for all sorts of civic and patriotic gatherings and it is fast attaining an enviable reputation for military efficiency. Many of the members are members of the Boy Scout organization, and the two organizations work together in harmony. The Scouts, as you know, is not a military organization.

What appeals to me most is, of course, the good this military organization does to the boys themselves. It makes for discipline, for reverence, for respect, and for bodily good, and it teaches a lesson to the community when they behold sixty or seventy direct lineal descendants of the Boys of 1776, banded together in their day and generation. ready to do their "bit" for their country as their great grand daddies did so long ago. If compulsory military education is coming, and we all hope that it is, the training these boys are now getting will be of immense benefit to them.

The Commandant of Post No. 1 is Compatriot Earle A. Miller, lately of the New Jersey National Guard, and he has worked long and zealously to perfect this military organization.

A charter has been granted to the Passaic Valley Chapter of Summit, N. J., and the formation of Post No. 2, with some forty members,

is now under way. There is but one obstacle in the way of these organizations, and that is money. The uniforms and equipment of Post No. 1 have cost considerable. The full-dress uniform costs \$16. The fatigue uniform (which is now being considered) will probably cost \$4. Post No. I raised over \$400 by the giving of a Colonial Ball, the tickets to which were but \$1 each. Orange Chapter and the New Jersey Society have each contributed \$50. The balance has been contributed by friends. The investment is well worth while, and surely if the Oranges can do this much other communities can do as well, if not better. It is a day of service and ours is the BATTLE OF 1917 NOT 1776.

We shall shortly issue an official pamphlet containing descriptions of uniforms and suggestions for organizations of Posts. In the meantime I respectfully request each President of a State Society to nominate some member of his State Society to take charge of enrollment, and also some young man under the age of twenty-one who can act as an Aide to the undersigned and, in conjunction with the member memtioned, endeavor to organize Posts in his State. Such an Aide will be expected to purchase his own uniform and will later be properly com-

ADDITIONS TO MEMBERSHIP.

From May 16 to September 30, 1917, there was enrolled by the Registrar General a total of 397 new members in 37 State Societies, as follows: California, 4; Colorado, 19; Connecticut, 14; Florida, 2; Hawaii, 2; Idaho, 7; Illinois, 29; Indiana, 6; Iowa, 20; Kansas, 10; Kentucky, 8; Louisiana, 6; Maryland, 4; Massachusetts, 33; Michigan, 12; Minnesota, 10; Missouri, 3; Nebraska, 12; New Hampshire, 2; New Jersey, 31; New Mexico, 1; New York (Empire State), 41; North Carolina, 1; North Dakota, 1; Ohio, 20; Oklahoma, 1; Oregon, 15; Pennsylvania, 16; Rhode Island, 7; South Dakota, 4; Tennessee, 4; Utah, 11; Vermont, 3; Virginia, 5; Washington, 7; Wisconsin, 24; Wyoming, 2.

DOINGS OF STATE SOCIETIES.

The Arkansas Society observed the anniversary of the signing of the Constitution September 17. The Society has a colonel, two majors, and several officers of other rank in the Home Guards. It is doing its full share toward the welfare of troops in the large cantonment near Little Rock.

The California Society. Upon the recommendation of the Sons of the American Revolution, the President of the Board of Education of San Francisco (Mr. George E. Gallagher) called the attention of school teachers to the celebration of the 130th anniversary of the signing of the Constitution of the United States, and asked them "to set aside a proper amount of time on that day to explain to the children the meaning of this wonderful document and what it stands for at the present day."

Dr. Rawlins Cadwallader, now captain in the Medical Reserve Corps, U. S. Army, has resigned as Registrar and is succeeded by Thomas A. Perkins, who becomes both Secretary and Registrar.

The Society is active in war-relief work. One of its members, Compatriot Marshal Hale, for many years a leader in Red Cross work in San Francisco, has been made manager of the Pacific Coast Division of the Red Cross, without salary, for the duration of the war.

Prizes of \$25, \$15, and \$10 have been offered by the California Society to the pupils of the high schools of the State for the three best essays on "America in the War for Democracy."

The Colorado Society.—On August I, "Colorado Day," the Chapters of the "Sons" and the "Daughters" of the American Revolution, at Grand Junction, dedicated and presented to the city a boulder and bronze tablet commemorative of Marcus Whitman, "patriot missionary, who swam the Grand River near this point on his heroic transcontinental ride which saved the great Northwest to the United States, midwinter, 1842-43." President Charles L. Nichols of the Grand Junction Chapter of the S. A. R., presided at the ceremonies and the tablet was accepted in behalf of the city by Mayor Charles E. Cherrington.

Constitution Day was observed by a meeting of the Chapter, when a paper was read by Judge Sprigg Shackelford of Gunnison. In all the schools of the city and vicinity attention was given to the anniversary; in the high schools lectures were given on the Constitution and the Flag.

The Connecticut Society.—The Board of Managers of the Society, on July 12, held a special meeting at the New Haven Country Club in honor of Gen. Edwin S. Greeley, one of the Society's oldest members and former President General. Remarks were made by Dr. George C. F. Williams, Judge Morris B. Beardsley, H. Wales Lines, and Commander William S. Wells. The meeting was presided over by President Clarence H. Wickham. The Committee on War Relief has issued an appeal to members for generous contributions for carrying on the work planned by the Society in providing for the comfort and welfare of the soldiers in training camps and in France and in caring for their families during their absence.

The District of Columbia Society co-operated with the Sons of the Revolution in a Fourth of July celebration at the base of Washington Monument. Commander John H. Moore, U. S. Navy, presided. The program included music by the United States Marine Band, reading of the Declaration of Independence by Col. Frederick C. Bryan, and addresses by Hon. Champ Clark, Speaker of the House of Representa-

tives, and His Excellency, the French Ambassador, M. Jules J. Jusserand. The British Ambassador and other members of the Diplomatic Corps and members of official commissions from several countries were in attendance.

Rear Admiral Frank F. Fletcher, Commander John H. Moore, and other retired officers of the navy and of the army are on active duty during the war, and all the compatriots are doing their share of patriotic work.

The Empire State Society, on July Fourth, officially participated in many celebrations in Manhattan and other cities throughout the State. President Ames, vice-chairman of the Manhattan celebrations, was chairman of assemblages at Grant's Tomb, Sailors' and Soldiers' Monument, and Central Park. Edward Hagaman Hall was secretary of the city celebrations and presided at a patriotic meeting in Central Park, attended by about 30,000 people.

On the morning of July 4 President Ames addressed the meeting at Montclair, under the auspices of the New Jersey Society. The President General attended a patriotic meeting, held under the auspices of the D. A. R., at Chautauqua, N. Y., on Monday, August 13, and delivered a strong address against pacifism and half-heartedness during the war of 1917.

THE HUNTINGTON CHAPTER took the lead in the celebration of July Fourth at Huntington, L. I. A procession of local patriotic societies was headed by a fifer and drummers in costume representing the "Spirit of '76," followed by more than two thousand marchers. Compatriot Sammis acted as master of ceremonies of the day.

The Newburgh Chapter observed Independence Day by a flag raising at Washington's headquarters and parade, in which the Chapter members marched in a body. The public exercises took place at headquarters, where after an invocation by Compatriot The Rev. J. Lewis blage, which was presided over by Compatriot S. L. Stewart, President of the Chapter.

Religious services were held on Sunday, July 1, at Trinity M. E. Church, Newburgh, and addresses were delivered by Rev. Dr. Hartsock and former Governor B. B. Odell. The flags of the Chapter were displayed at the pulpit platform.

THE CORNELIUS VAN DYKE CHAPTER of Schenectady, at its annual meeting in June, elected the following officers: L. E. Montgomery, President; Allen W. Johnston, First Vice-President; W. W. Roe, Sec-

ond Vice-President; Hanford Robison, Secretary; J. G. Sanders, Treasurer; Prof. Olin H. Landreth, Registrar; E. R. Whitney, Historian, and Rev. R. C. Penney, Chaplain. The Chapter now consists of 57 compatriots, and a campaign is in progress to double the membership. Chaplain Penney presided at a partiotic service in the First Baptist Church Sunday evening, July 1.

At a meeting September 5 a special committee of five was appointed to formulate a plan for special activity of the Chapter during the war. A committee was also appointed to join with committees from the D. A. R. in reference to marking Revolutionary sites in Schenectady County. On Saturday, October 6, members of the Chapter assisted in dedicating a marker to General Abraham Ten Broeck of the Albany County Militia on the battlefield of Saratoga.

THE MOHAWK VALLEY CHAPTER of Herkimer has been very active in local matters connected with the present war. Compatriot Col. John W. Vrooman, President of the Chapter, was one of the principal speakers at the farewell to the National Guard in August. Hon. F. W. Cristman presided at the speakers' meeting at the farewell of the first drafted men. He is also chairman of the Home Defense Committee, of which Senator Theodore Douglas Robinson is another member, both of whom are greatly interested in doing everything possible in connection with assisting in the draft work. Judge Charles Bell is connected with home defense work.

THE PAINTED POST CHAPTER of Corning is active in the patriotic meetings and work of the community. A patriotic meeting was held on July 2 at the First Presbyterian Church, under the auspices of "The Painted Post Chapter" of the Sons of the American Revolution and "Corning Chapter" of the Daughters and was largely attended. The church was decorated with American flags and flags of various nations allied with this country in the world war for the preservation of democratic institutions as a war measure. Addresses were delivered by Uri Mulford, Historian of the Chapter; Rev. Harold S. Stewart, Rev. John Chester Ball, and Rev. Thomas H. Derrick.

The Syracuse Chapter participated in Americanization Day exercises on July 4. President Newell B. Woodworth was chairman of the Citizens' Committee of Arrangements and Compatriot George N. Crouse was vice-chairman. The program included music by the band of the 30th U. S. Infantry; receiving of the flag and pledge of allegiance; invocation by Chaplain Jones of the 4th U. S. Artillery; massing of the colors by patriotic organizations; addresses by Lieutenant Governor

Schoeneck, Major Stone, Chief Justice Hiscock of the New York Court of Appeals, and by Rev. Pio Parolin, S. K. Kalebdjian, Nicholas Valentine, Frank Sladick, Edmund Tyminski.

In the printed program are given the names of about 1,300 newly naturalized citizens, many of whom were present with their families.

In the Post-Standard of August 2 there is given a detailed report of the work done during the few weeks previous by the Syracuse Chapter of the American Red Cross, under the direction of President Newell B. Woodworth of the Sons of the American Revolution. The Chapter has furnished dietary food for the camp hospital at the State Fair grounds; established a dietary kitchen; provided linen, pajamas, and robes; sent convalescent soldiers to private homes; obtained volunteer day nurses for the hospital; organized surgical dressings makers; given financial aid to soldiers' dependents; spent \$1,500 for camp hospital aid, and purchased \$5,000 worth of raw material.

The Far Eastern Society.—Hon. Charles S. Lobingier, Judge of the United States Court for China, the founder and now Honorary President of the Far Eastern Society, on a recent visit to Washington reported that the organization in the Orient, although limited in permanent membership, is exerting an influence for good and is appreciated by visiting members from the States. It is proposed at an early date to establish local Chapters at Manila, the present headquarters, and at Shanghai, and probably later at other places where there may be a sufficient number of members to form a nucleus for growth.

Compatriot Lobingier also reports a gratifying growth of the American colony in China, both in numbers and influence. There are now about 2,000 Americans in the consular district of Shanghai alone, and the American community there is rapidly acquiring national consciousness and solidarity. It has an American Woman's Club, of which Mrs. Lobinger is president, with a membership of considerably over 200; an American University Club, an American Chamber of Commerce, an American Town Club, and an American Country Club. Shanghai is also the headquarters of the Far Eastern American Bar Association, the American Association of China, and the Dewey Section of the Navy League of the United States.

These various organizations unite in observing our national holidays and are now co-operating actively in war-relief work. It is believed that such a field offers an opportunity for a live Chapter of the Sons of the American Revolution.

The Society in France.—Members of the Sons of the American Revolution participated in celebrations in Paris on July 4. At the Invalides Major General John J. Pershing received two banners from the descendants of the men who fought with Lafayette in the American Revolution. At Lafayette's tomb in Picpus cemetery the ceremony was extraordinary and stirring. The rostrum was placed at the end of the grounds near the tomb of Lafayette and was draped with flags. The ceremony, as in previous years, had been arranged by the Sons of the American Revolution and was presided over by Mr. H. Cleveland Coxe, of the Empire State Society, former Vice-Consul General.

Hon. Brand Whitlock, former United States Minister to Belgium, delivered a thrilling address. In conclusion he said:

What was it that led Lafayette to go forth to a new land in the midst of war? He had a place at the most brilliant court of his time; he had youth and wealth and a noble name; he had a bride and he was in Paris. And yet when he heard of the struggle across the sea he said: "My heart was enrolled and I had no other idea than to join my colors."

My colors! The colors of liberty, whose radiant vision beckoned him as it has beckoned the loving and the daring at all times. He knew that wherever liberty was menaced there was his place; that wherever the flag of liberty was unfurled there was his post. Noblesse oblige! And the noblest, like Lafayette and Washington, are not content with liberty for themselves alone; they must have it for all men on equal terms, for they know that character can be developed only in liberty, where the human soul has the right not only to live, but the exceedingly more important right to live a beautiful life.

Today, as we stand by the tomb of him who in his youth went forth alone to join his colors across the seas, we hear the tread of a million youths of America, sons of his spirit, marching to the waiting ships that bear them hither to this new front of liberty. They come with the same unselfish motive that led him forth, not for conquest, but for freedom-to help, as our President said, "to make the world safe for democracy." They come as came the brothers of their English blood, with the grim determination of their race, vowing that autocracy shall not tear up the Magna Charta and the bill of rights, the Declaration of Independence and the declaration of the rights of man. They come in the name of those great principles of which Lincoln for us is the incarnation, resolved that the dead on all the battlefields of liberty "shall not have died in vain"; that each nation, "under God, shall have a new birth of freedom," and that "government of the people, by the people, for the people shall not perish from the earth." They come singing the "Battle Hymn of the Republic" to the blowing of the bugles that shall never sound retreat. They come bearing the hopes and the resolutions and the faith of a whole free people, a mighty continent aroused, whose genius salutes the sister republic in the strophes of Walt Whitman, the poet and prophet of democracy:

"A star! O ship of France! beat back and baffled long! Bear up, O smitten orb! O ship! continue on!"

The Illinois Society celebrated Flag Day, June 14, by an excursion to the officers' training camp at Fort Sheridan, Illinois. About 280

members and guests made the trip and were given opportunity to see something of the work going on in the training for official positions in the new army. A number of the members of the Society took the training and received commissions and a still larger number of sons of

The membership of the Society is growing steadily, more than a hundred having been enrolled thus far this year. At a meeting of the Board of Managers, on July 12, twenty-nine new members were received and on September 25 about twenty were elected.

A special War Service Committee has been appointed to consider and recommend ways in which the Society can be of the largest possible in the present national emergency.

The annual Yorktown Day banquet is arranged for October 19, with addresses by Major General Carter, U. S. A.; Lieut. Harold R. Peat of the Canadian Volunteers, by the French Consul in Chicago, and by national service not only in all branches of the Society are rendering in civilian positions as members of Exemption Boards and in other capacities.

THE OAK PARK CHAPTER made its usual presentation of prizes to pupils in the grade schools for historical essays of merit.

The Indiana Society is most active through the John Morton Chapter at Terre Haute. The annual meeting of the Chapter was held on September 4, at the Hotel Deming, in observance of the 105th anniver-John D. O'Malley, the first Indiana man certified for the national army, of the State Society.

Capt. J. E. Thomas, Chairman of the Military Affairs Committee of the County Council of Defense, was introduced by Lieut. Col. C. T. Jewett, who told of steps being taken to provide military organizations in Indiana when the federalized National Guard leaves for training camp.

Prof. Herbert Briggs, past president of the Chapter, presented Capt. A. C. Duddleston, First Indiana Infantry, who paid a high compliment to the patriotism and faithful efforts of the members, and pledged the company to give a good account of itself in France.

Captain Duddleston spoke feelingly of the great task undertaken by the nation and asked for earnest support of the people at home.

Compatriot Briggs reported for the memorial committee that the obligation assumed by the Chapter in sending flowers to the cemeteries

and the centennial monument had been performed. He also reported that he had prepared memorials for the late Dr. E. T. Spotswood and William C. Durham for the Society Bulletin. The Chapter directed that official report be made.

The resolutions presented by Floyd D. Allen and Judge James H. Swango pledged the Chapter to full support of the President and nation in the war to make the world safe for democracy and all peoples.

Constitution Day was observed at Terre Haute on September 17 by holding appropriate exercises in the city schools. A large number of illustrated cards, designed by Compatriot Herbert Briggs and quoting the words of Edouard Rene Lefebvre de Laboulaye, were distributed around the city and displayed in prominent places.

The Iowa Society.—The observance of Constitution Day in Iowa was general in the churches on the 16th of September and in the schools on the 17th. At Des Moines a large audience assembled the evening of the 16th in the University Church of Christ when a discourse by Rev. C. S. Medbury, suited to the occasion, was delivered.

The secretary reports that the Society's History Medals have been bestowed on winners in 17 colleges and 25 high schools in Iowa the past year. The eleventh offer of the medal has just been made to the colleges and high schools.

The last Society year was the most prosperous in its history in that 53 members were admitted by application. Since the April meeting 23 members have been admitted.

A calendar is being prepared providing for eight meetings of Ben Franklin Chapter of Des Moines, the initial meeting occurring October II at which President Chassel will deliver an address. In November President General Wentworth will address the Chapter. The President General has visited Oskaloosa and other places, delivering patriotic addresses, as also have Past President J. Edward Kirbye and others.

On August 24 the President General, President Chassell, and Secretary Hadley visited Grinnell with several D. A. R. officers and assisted in presenting to the First Iowa Cavalry an Iowa State Flag, designed by the D. A. R. The State has never before had a State Flag.

Eighteen service bars of the Sons of the American Revolution have been issued to compatriots who are in the U. S. Army during the present war.

The Maine Society, on September 17, marked the observance of Constitution Day by holding a field meeting at Yarmouth, at the Drinkwater Inn. There were brief informal addresses and other features in keeping with the spirit of the occasion.

The Maryland Society has been largely instrumental in securing the elimination of the teaching of the German language in the public, primary, and elementary schools of Baltimore city. There had been brought to the attention of the Society the astonishing fact that the German language was not only taught, but was in effect the language of the schools in a number of the primary public schools of Baltimore city. The Society believing that the use of any foreign language, and of the German language especially, was detrimental in the highest degrees to the best interests of our free institutions and subversive of the ideals of our government, tending to keep alive much that exists in foreign governments which is opposed, both in form and in principle, to American ideals, passed a formal resolution embodying these views and requesting the School Board of Baltimore city to immediately take steps to eliminate the use of the German language from the schools in question, and to have the English language used alone therein. Our Society reminded the School Board that while we always welcomed to our shores the oppressed of every nation, yet we had the right to expect and to demand that these people should not merely obey our laws, but acquire our language and imbibe the spirit which actuated our forefathers in establishing our government, and their descendants in developing it to its present position among the great nations of the earth, While we felt that the sons of other lands who sought our country should be at liberty, as far as they desire and as far as is not inconsistent with American citizenship, to retain the knowledge of their native language and customs, yet our public schools were established and maintained for the purpose of training American citizens. We believe that our public schools should be conducted along lines which would most effectively impart to the children the spirit and knowledge of our own institutions, and we believe that any course which tends to foster allegiance to the language or customs or the ideals of any other country is contrary to the purposes for which our schools are established.

Upon consideration the School Board determined to eliminate the study of German in the first seven grades of the elementary public schools, leaving certain options to scholars in the eighth grade. The press was at first unresponsive, but later yielded to arguments presented by representatives of our Society and other citizens.

The result has been that the German language will no longer be taught or used in the primary and elementary public schools of Baltimore city in the first seven grades. Our Society has also taken this stand against the teaching of not alone the German, but any other foreign language in the primary public schools.

The Society is co-operating with the city authorities in erecting a

monument to Lafayette at the base of Washington Monument in Baltimore. Arrangements are being made to place a tablet in the building in Annapolis where the First Congress met.

The Massachusetts Society, through its "1917 S. A. R. Minute-man Committee," is giving practical aid and comfort and instant help in assisting troops summoned to the aid of the United States. Headquarters of the Committee are at 216 Washington Street, Boston, the old building where General Knox studied artillery tactics. In reporting on the work of the Committee, under date of September 1, President Vernon A. Field says:

There has been received at headquarters to date, \$1,800 in cash, some 2,000 comfort bags, and over 300 articles of various other kinds. We are constantly sending out comfort bags and receiving about fifty per week from societies with whom we are in touch. Medical service, dentistry, and chiropody have been furnished free: cash assistance in moderate amounts has been paid to a recruit or his needy family after investigation. Outlays for socks have been made, on emergency call from the camps. We have recruited 250 men into all branches of the service. Sixty of our comfort bags were most gratefully received by the sailors of the French convoys recently in Boston Harbor. The instant aid thus rendered to more than 3,000 men by your Committee has made good its existence.

On October 8, at Camp McGuinness, Framingham, a storm flag donated by President Vernon A. Field was given to the Fifth Regiment in the presence of a committee of the Society and the commissioned officers of the regiment. Following a patriotic speech of presentation by President Vernon Field, replied to by Colonel Stover, the flag was run up on the post staff, Sergeants Smith and Carey at the halyards, the regimental band playing "The Star Spangled Banner." With the party were Lieutenant Lyon, representing Major General Ames, commanding the State Guard; Captain Appleton, National Lancers, and others.

Fall Field Day was observed at Lynn and vicinity on October 12, with an attendance of about one hundred members. Visits were made to the "Iron Works House" in Saugus, built in 1646, and to other historic buildings and sites. Exercises at The Chateau consisted of an invocation by Rev. G. T. Morse and addresses by President Vernon A. Field, Joseph E. Peirson of Pittsfield, and William Sumner Appleton of Boston. Resolutions were adopted upon the death of Past President General Moses Greeley Parker, M.D.

The S. A. R. School Republics Committee, under the Chairmanship of Compatriot George H. Nutting, has secured the enactment of a State law requiring "training in the duties of citizenship" in all the public schools of the Commonwealth. The Wendell Phillips School in Boston

has already adopted the system of School Republics. The whole school is the "republic," each grade is a "state," and each class-room is a "city," each with its officers, legislative, judicial, and executive. The operations of the system in the above school were quite fully described in *The Boston Globe* of August 1, 1917.

The Old Essex Chapter participated in bidding good-bye to Companies I and D of the Eighth Regiment at Lynn on July 27. Compatriot Benjamin N. Johnson delivered an address to the soldiers, which has been published.

THE FRANCIS LEWIS CHAPTER of Walpole on July 4, in co-operation with the Nelly Custis Lewis Chapter of the D. A. R., held a flag raising on Lewis Square. The local Post of the Washington Guard took part in the exercises, which were under the direction of President Isaac Newton Lewis.

The Michigan Society.—The Detroit Chapter held its annual meeting and election of officers, June 1, 1917, at the Board of Commerce. President Dr. Stephen H. Knight told of the support of the Society to the Red Cross campaign and of its material assistance extended to members of the naval militia by raising a fund for their relief and comfort. The report of the Secretary, Raymond E. Van Syckle, showed an increase in membership of 25 during the year and loss by death of two. The Historian's annual report, presented by William Stocking, stated that the year was an especially eventful one for Detroit Chapter, its meetings having been dominated by the national needs arising from the European war. The activities of the Membership Committee were described by Carl F. Clarke, chairman; Entertainment Committee, Julius E. Thatcher, chairman; Patriotic Education, Benjamin F. Comfort, who described the military units in the high schools and credited the Sons of the American Revolution with having been largely instrumental in bringing about the increased activity in the education of aliens in the municipality; National Defense, Gen. Charles A. Coolidge; Patriotic Legislation, Walter M. Trevor; Historical, Frank D. Taylor; George W. Bates, chairman of the Flag Committee, gave an interesting account of the flag law and violations, illustrating same with posters. The report of the Memorial Committee was made by Charles M. Woodruff. The report of the Public Welfare Committee was presented by Dr. Walter P. Manton, illustrated with stereopticon views of the conditions in the alleys in the outlying districts of Detroit.

The Sons of the American Revolution in Detroit, through the persistent efforts of Compatriot Albert M. Henry of the National Exec-

utive Committee and others, have done effective work toward establishing the English language among the many aliens in that city. English speaking has been insisted upon as a primary duty. The following newspaper editorial well describes the conditions in that great center of industry:

Some years ago in Detroit, home of many manufacturing industries, thoughtful persons looked at the groups and clumps and herds and colonies of foreign-born, non-English-speaking men and women employed in the many factories and found the situation not good. These employees formed so many unassimilated knots of potential trouble in the population. Not "trouble" in the sense of perplexities in the labor market, for the need for labor was constant and pressing, but real

There were as many problems as there were nationalities, and the first necessity was for a solvent of the crust of separation. This separation was caused primarily by the obstacle of a foreign language. These good citizens of Detroit set out to remove it. They opened schools—night schools and day schools—all sorts of special instruction were contrived, and then an agreement among employers resulted in the announcement that English is the official language of the United States, and that all employees were expected to learn it, as well as to see that their children learned it. Preference in employment and in pay was assured to persons speaking English over those who did not. The plan worked perfectly. The clots were broken up, foreign habits and prejudices were disintegrated little by little, and a great improvement was made within a few months; after a year or so the tendency was well enough established to guide its own current.

The New Jersey Society has been very active since the declaration of war in securing recruits for the army and navy. Up to September 1 thirty compatriots had responded to the call to the colors. Dr. George H. Richards, who had been Registrar of the Society for the past ten years, has entered the Medical Reserve Corps and been assigned to a ward in the base hospital at Fort Oglethorpe, Ga., with the rank of first lieutenant. His successor as Registrar is Compatriot William J. Conkling.

Constitution Day, September 17, was observed by Orange Chapter. President Bridgewater M. Arnold sent notices to all the pastors of churches and superintendents of schools, nearly 100 in number, in his jurisdiction, asking that the adoption of the Constitution be remembered in the churches on Sunday and in the schools on Monday. There was a general recognition of the day in the vicinity of the historical Orange Mountains. Orange Chapter has prepared an honor roll of all its members who have performed and are performing military or naval service.

Orange Chapter observed Independence Day at the Dispatch Rider

statue, in the Old Burying Ground. President Arnold presided, and the oration was given by the Rev. Dr. Lyman Whitney Allen, First Vice-President of the State Society. The Declaration of Independence was read by David L. Pierson, Historian General. The prayer was offered by the Rev. George P. Eastman, Chaplain of the Chapter. In the evening Mr. Pierson made a patriotic address at the Watsessing Park, East Orange, in the presence of 10,000 enthusiastic Americans. The Chapter paraded in East Orange on September 21 in a farewell demonstration to Batteries A and C, First New Jersey Artillery, of that city. The Chapter's flag and banner attracted much attention and were frequently applauded along the line of march. The Chapter participated in a country fair and circus during the week of October 1, the proceeds of which (estimated at \$10,000) will be applied to the war-relief fund.

The State Society participated in a Red Cross parade in Newark in September. The Board of Managers afterward, through the Rev. Dr. Lyman Whitney Allen, presented an ambulance to the Newark unit.

Orange Chapter participated in the parade in East Orange on Constitution Day, when the selective men of that city for the National Army were escorted to the Lyceum. Compatriot Howard Marshall made an address, in which he alluded to the fact that the Constitution had been adopted 130 years ago, and that now the people were pledging their lives and property for the furtherance of the principles of democracy the world over. Compatriot M. De Forrest Soverel, vice-president of the War Relief Committee of East Orange, presided.

State President Chester Neville Jones and several compartiots visited the camp of the First Battalion, Fifth Infantry, at Pompton, on June 28, the 139th anniversary of the Battle of Monmouth. A flag of Stars and Stripes was presented to Major William A. Lord, a member of the Society and commandant of the post, and which was displayed from the Liberty Pole on the camp ground. Colonel Austen Colgate, former State Senator of New Jersey and a member of the Society, presented Compatriot Lord with the first service bar of the Society, presented compatriots who are enlisted in the U. S. Army and Navy. Several large packages of tobacco were left at the camp by President Jones in behalf of the Society, and the observance of the day was concluded by a dinner at the Mansion House, Pompton, in honor of Major Lord, and a band concert afterward at the battalion headquarters.

The Liberty Pole in the Old Burying Ground at Springfield, owned by the New Jersey Society, was found to be in a dangerous condition on the anniversary of that battle, June 23, and was removed later in the summer. A new and more enduring shaft will be erected. The battle anniversary was remembered by the Committee on Monuments and

Memorials, which visited the ground and caused the old-time bell in the helfry of the Presbyterian Church to be rung 15 minutes at sunset.

A memorial upon the death of Compatriot George R. Howe, former Vice-President General of the National Society, has been adopted and sent to the family of the deceased. He died on June 9.

Applications for membership continue to be received and plans for an active season are in course of preparation.

George M. Denny, President of Newark Chapter, has been doing yeoman service in securing recruits for the army and navy of the United States. The Chapter is pledged to present an ambulance to the Red Cross.

The Ohio Society at the close of the last school year awarded a gold medal, a silver medal, and 25 bronze medals of the Sons of the American Revolution to pupils of Ohio high schools for the writing of essays on the underlying causes of the American Revolution and the results of the war. The gold medal was the gift of former President George E. Pomeroy and was won by Helen Schade of Toledo. The silver medal was awarded to a Cleveland boy.

The Register of the Society for 1917, a volume of 66 pages, contains an historical sketch of the organization, the names and addresses of members, and the names and location of burial of 350 Revolutionary soldiers in Ohio.

THE BENJAMIN FRANKLIN CHAPTER of Columbus at a luncheon on September 26 was addressed by Professor Magruder of the Aviation School, Ohio State University.

The Oregon Society continues active in promoting the education and naturalization of aliens. On the evening of July 12 Judge Kavanaugh, sitting for the Circuit Court of Oregon for Multnomah County, naturalized 141 applicants for citizenship. Members of the Oregon Society were on the stage. Two of the silk flags which the Society has presented to the Circuit Court were in evidence, and Mr. James F. Ewing, Vice-President, spoke on behalf of the organization. The Society presented silk flags to each of the new citizens. About five thousand were present. Half a dozen of the applicants were examined by Mr. Hazard, of the Bureau of Naturalization, the remainder having been examined earlier in the day. Judge Kavanaugh made an eloquent address, and administered the oath of allegiance most impressively. The oath was taken in groups of nationalities, Belgium being first and Turkey last.

The Oregon Society celebrated the one hundred and thirtieth anni-

versary of the signing of the Constitution, on Monday evening, September 17. A smoker was held at the University Club in Portland, when a paper was read by Compatriot T. S. Robinson in which he pictured the disorders of the critical period, and paid a high tribute to Washington, Hamilton, Madison and the other statesmen through whose efforts the Constitutional Convention was convened. He spoke interestingly of the personnel of the Constitutional Convention, and eulogistically of its work. He was followed by Chief Justice Thomas A. McBride, who has recently become a member of the Society, and who spoke impressively on the political achievements of the American people. He showed that they were pioneers in the work of government and had wrought out the first successful republic of long duration in modern times.

Judge McCamant, President of the Society, has printed a critical review of Muzzey's School History, prepared at the request of the President General and others. It is in the form of a letter to the President General. Judge McCamant sums up his objections to the history under three heads: (1) The history is almost wholly lacking in incidents calculated to inspire patriotism in the children studying it; (2) it is inaccurate to a degree not to be tolerated in school history; (3) the concluding chapters of the history are a brief for the author's political views on the current political questions of our day; the views of the author are, in my opinion, unsound, unpatriotic, and unsuitable to be taught to school children.

Copies of the review may be obtained from the Secretary General.

The Pennsylvania Society, through its officers at Pittsburgh, called public attention to the observance of Constitution Day. Exercises were held in the city schools appropriate to the day.

The Rhode Island Society, in co-operation with the City Committee, arranged for a public celebration of July 4 at the Providence Opera House. William A. Viall, vice-president of the Rhode Island Society presided. Addresses were made by former Lieut. Gov. Roswell B. Burchard and Rev. Anthony Bove, rector of St. Ann's Church. Patriotic selections were sung by the Lyric Opera Company, and the Declaration of Independence was read by Ralph W. Hazelhurst. Prayer was offered by Rev. Dr. Clarence M. Gallup.

In the course of his introductory address Mr. Viall made a vigorous plea for prompt response to the nation's needs during the war. He said:

In time of peace it has been our practice to dwell on the patriotic acts of our ancestors. At the present time, however, we should have less regard for what has been done by our ancestors than for what we are

to do ourselves. Our country entered the war with great reluctance and after much deliberation, and now that we have entered it, it is incumbent upon us to show that we are worthy of our ancestors. In 1776, 1812, and 1861 they fulfilled their duty in a manner that inspired us with pride and gratitude. Such situations as then confronted them have come to us, and we must do as they did.

On September 6 the Society decorated the Monument to our French Allies at the North Burial Ground, Providence, in commemoration of Lafayette's Birthday. The floral piece was in the colors of the Society. The ceremony was directed by Secretary Rhodes.

THE KENT COUNTY CHAPTER dedicated a Flag and Pole at Kent County Court-House, East Greenwich, on September 26. The program was as follows: Singing, "America," by Community Chorus; prayer by the Chaplain, Rev. C. Fremont Roper; historical remarks, by Rev. Daniel Goodwin, D. D.; hoisting of flag, by Samuel Ward Greene, Esq., great-great-grandnephew of Gen. Nathanael Greene; singing, "Starspangled Banner," by Community Chorus; address, by Hon. Roswell B. It is a voluntary association, sponsored by the Sons and Daughters of the American Revolution. Its membership consists of patriotic Americans-men, women, and children-whose hearts are filled with love of country, and who are inspired by willingness to sacrifice and render personal service for our country and help, aid, and assist worthy

One of the methods of doing good is for each member during the period of the war to practice doing without small luxuries and unnecessary things which the member at the time chooses to forego. Money thus saved is put in a small pocket bag carried for that purpose to be given either to the Red Cross, French war orphans, or such other fund connected with the war as the individual member wishes, or to be applied upon the purchase of a Liberty Bond, if so desired. The idea being that each member who is designated "patriot" may have an opportunity to render personal service for our country and feel that he or she is doing a little something to aid our boys who are offering their lives as a sacrifice upon the altar of liberty.

The Wisconsin Society.—President General Wentworth visited Milwaukee during the last week in July and met the members of the Sons of the American Revolution.
