#### PRESIDENT GENERAL'S MESSAGE ON AMERICAN HISTORY IN SCHOOLS.

COMPATRIOTS: My attention has been called to a new text-book on American history in which I am advised that "the author devotes but two pages to the actual events of the American Revolution."

While I have not seen the book and do not know the publishers, the information should be an incentive for each compatriot to familiarize himself with the text used in his community.

No more important subject is listed in our educational course. The failure of the "melting pot" to fuse the race hatreds, class prejudices and national antagonisms into loyal Americans is as much the fault of our educational as our social conditions. One-sixth of our population uses its native alien tongue in its daily social business and religious intercourse. Knowledge of history is negligible, and of our institutions as a rule, just enough to comply with the very liberal naturalization requirements.

Citizenship has cost them nothing in service or sacrifice. What can it mean to them and to their children if they are not taught what its

cost, in service and sacrifice, was to our forefathers?

The hero tales should be taught the children; they should be encouraged by instruction and discussion in the class-room to deeper research into the events leading up to the Declaration of Independence, the War of the American Revolution, and the adoption of the Constitution Regardless of modern school text-books, the wisdom of the fathers who, rebelling against the attempt of George III to rivet the Teutonic theories of government upon the Colonies, achieved their independence and organized their liberties under the Constitution is demonstrated daily, as we are made familiar with the atrocities of German autocracy and the destruction following Russian democracy.

Will civilization hesitate in choosing its ideal between Washington and Wilhelm?

Does Peace Leaguer and Pacifist place Lenine above Lincoln?

If not, why not teach American history as Washington and Lincoln made American history?

COMPATRIOTS: I have received many inquiries asking if some arrangement cannot be made to admit to full membership men who have regu-Jarly enlisted in the military or naval service of the nation, otherwise eligible but for our constitutional age requirement.

These young men, true to their inheritance, have responded to the call to the colors "to maintain and extend the institutions of American freedom," and it would be a source of real satisfaction to them if they could specifically honor those ancestors by becoming full members of this great patriotic Society, founded "to perpetuate the memory of the men who by their services and sacrifices during the War of the Ameriican Revolution achieved the independence of the American people."

I feel sure our members recognize the service of these young patriots and would heartily welcome them as compatriots, provided our constitutional requirements as to legal age did not prevent. I hold it unfortunate that the military age does not correspond with the legal age for citizenship, but more especially at this time, when they are doing man's work in the manliest way, our laws and rules regard them as minors, withholding the privileges of citizenship and membership.

This is a question in which every compatriot is interested, and I will be glad if every compatriot will feel free to write me, stating his opinionand making his suggestions to cover this most important matter.

Record of patriotic work.—The attention of the Secretaries of State Societies is called to the schedule accompanying the present Official. BULLETIN. The National Executive Committee requests that State Societies summarize the returns from these schedules and forward such summary to the Secretary General for preservation by the National Society.

### PROCEEDINGS OF NATIONAL EXECUTIVE COMMITTEE, NOVEMBER 14, 1917.

A meeting of the National Executive Committee, duly called by direction of the President General, was held on November 14, 1917, at the residence of Compatriot Lewis B. Curtis, Bridgeport, Conn. Members of the National Advisory Committee, the Vice-Presidents General, and several of the Past Presidents General were invited to be present in conference with the Executive Committee. President General Wentworth presided. Others of the Committee present were Mr. Albert M. Henry of Michigan, Mr. Lewis B. Curtis of Connecticut, and President Louis Annin Ames of New York; also Treasurer General Burroughs Secretary General Clark, Vice-President General Thomas W. Williams Past Presidents General Morris B. Beardsley and Edwin S. Greeley. and former Treasurer General Birdseye. Regrets at inability to attend were received from compatriots Jenks, Merrill, and Woodworth, of the Committee; also from Judge McCamant, Vice-Presidents General Emerson, Turner, and Boardman, Past Presidents General Thruston, Pugsley, Marble, and others.

The minutes of the meeting of May 24, 1917, were presented and

approved.

The President General reported on the present condition of the Society and its activities throughout the country, as observed by him during visits to many of the State Societies since the last meeting of the Committee.

The Registrar General reported that from May 1 to November 12 there had enrolled a total of 652 new members, an increase of 36 per cent over the same period in 1916. Under authorization of the Committee at its May meeting, there is now issued to every new member an enrolment card or certificate recording the date of registration and the national and State numbers.

The Treasurer General reported total receipts in the General Fund from May 15 to November 1 amounting to \$1,917.61, and disbursements, including purchase of Liberty Bond, amounting to \$4,606.27, leaving a balance in the Treasury of \$4,630.73 to cover expenses to the close of the Society year.

The President General announced that Moses Greeley Parker, M. D.,

Past President General of the National Society, died at his home in Lowell, Mass., on October 1, 1917. Past President General Morris B. Beardsley of Connecticut, Past Vice-President General Edwin S. Crandon of Massachusetts, and Past Treasurer General Nathan Warren of Massachusetts were appointed a committee to prepare a tribute to the memory of Doctor Parker for insertion in the proceedings of this meeting.

The Secretary General reported that notification had been received from one of the executors of the estate that Doctor Parker had by his will created a trust fund, to be known as "Moses Greeley Parker Fund," aggregating about \$60,000. The fund is to be held in trust by the executors, as trustees, and the net income from specified portions of the fund is to be paid on October 12 of each year, the anniversary of his birth, to twelve specified patriotic and historical societies and hospitals. The National Society of the Sons of the American Revolution will receive the net income from \$5,000; the Massachusetts Society of Sons of the American Revolution the net income from \$5,000, and the Old Middlesex Chapter of the Sons of the American Revolution the net income from \$1,000. It is estimated that the National Society will thus receive about \$250 a year. There is also created a "Moses Greeley Parker Fund for Free Lectures in the City of Lowell," on Economy, Medicine and Hygiene, Education, and Civil Government with particular reference to the Constitution of the United States, etc. The trustees and executors are his sister, Mrs. Mary G. Morrison; his nephew, Theodore Edson Parker, and the Boston Safe Deposit and Trust Co.

The Secretary General reported a large increase in volume of correspondence, indicating greater public interest in the Society's work and broadening of its influence. The State Societies report their members as individuals to be earnestly engaging in every effort to aid the govern-

ment during the present war.

Under authority of the Committee, there is being issued to compatriots serving in the Army or Navy of the United States a simple bar bearing the ribbon of the Society badge, to be worn on service uniform on unofficial occasions, the standard badge being authorized only on full-dress uniforms, and then not in connection with badges or medals awarded by the government. More than 400 of these bars have so far been issued. The names, rank, and branch of service of compatriots receiving the bars are recorded by State Societies and the Secretary General for future use.

Inquiry having been made as to issuance of the bar to members in other branches of military service, it was voted that it be limited to compatriots in the Army or Navy of the United States. The Secretary General was authorized to furnish State Societies with additional bars at 25 cents each to replace any that may be lost or defaced.

The Secretary General was requested to insert in the December Official Bulletin a schedule, to be returned to State Societies, indicating the special patriotic activities in which each member may be engaged and other details pertinent to war work, for preservation and record by the National Society and State Societies.

Mr. Henry reported on the prosperous condition of the Society in Michigan and of active work toward the Americanization of the large alien population in Detroit.

Mr. Ames reported on many lines of patriotic work in New York in co-operation with the Red Cross and other organizations. The Empire State Society has created a War Fund, now amounting to several thousand dollars, to be expended in suitable directions.

The Committee reviewed the numerous activities of State Societies, Chapters, and individual compatriots of the Sons of the American Revolution in co-operation with the Council of National Defense, the War Council of the Red Cross, and in general aid to the government in its effort to overthrow the power of the Germanic Alliance and to make the "world safe for civilization;" and it was

Resolved, That the President General appoint a committee of seven to investigate and report to the Nashville Congress if there may be some specific and definite activity that the National Society, without duplication of effort, may assume and promote.

The President General designated as such committee five Past Presidents General and two Presidents of State Societies, as follows: Past Presidents General Morris B. Beardsley of Connecticut, Nelson A. McClary of Illinois, William A. Marble of New York, Henry Stockbridge of Maryland, and R. C. Ballard Thruston of Kentucky, President Wallace McCamant of the Oregon Society, and President Chester N. Jones of the New Jersey Society.

The Committee considered various matters concerning the general welfare and the activities of the Society without taking formal action thereon.

There being no further business, the meeting adjourned at 5.30 p. m., after extending a vote of thanks to Compatriot and Mrs. Curtis and to Bridgeport members of the Sons of the American Revolution for their hospitality.

#### COUNCIL OF NATIONAL DEFENSE.

In order that the activities of the State Societies and individual members of the Sons of the American Revolution may be effective in the highest degree, and to prevent duplication of effort, attention is called to the following notice issued from Washington to State councils:

We inclose herewith a copy of a resolution passed by the Council of National Defense concerning the co-ordination under the State councils of defense of the work of all voluntary patriotic organizations and committees within their States.

The council feels that co-ordination is necessary to effective service by such organizations, and that the State councils, as the official war bodies in each State, are the proper agencies to undertake it. Several have already done so. The National Council indorses their action and recommends it to all, and believes that to assist therein this resolution should be brought to the attention of all such patriotic organizations and societies in your State.

Resolution adopted by the council at its meeting of November 2: Whereas it appears that there are many voluntary organizations and committees engaged in patriotic service throughout the country; and

Whereas, in the opinion of the Council of National Defense, such organizations and committees can render the most effective service if properly co-ordinated; and

Whereas a State council of defense has been organized in each State to co-ordinate the war activities within the State and to co-operate with the Council of National Defense; therefore

Be it resolved, That the Council of National Defense strongly urges that wherever practicable voluntary patriotic organizations and committees in each State work through and under the guidance of the State council of defense, so that the State council of defense may be the central, co-ordinating agency for all voluntary patriotic work within the State directed toward assisting in the prosecution of the war.

#### "1917 S. A. R. MINUTE MAN COMMITTEE."

As noted on page 19 of the Official Bulletin for October, the Massachusetts Society has organized the "1917 S. A. R. Minute Man Committee," which is giving practical aid and instant help to soldiers and sailors in directions not usually provided for them. President Vernon A. Field of the Massachusetts Society summarizes the Committee's work as follows:

Starting with the proposition that millions of waiting hands were ready to help, and that the natural stream of that help would be toward the worthy Red Cross, our study was to discover the place of need, if any, left unsupplied by reason of red-tape requirements or otherwise, to which our organization could render independent and immediate assistance. This we very soon found. Both the Army and Navy and

Red Cross were naturally overwhelmed and our first call was for medicine. One of our members secured, through the kindness of the State Street Trust Company, an excellently located headquarters at 216 Washington Street, and we were further fortunate in securing for an Executive Secretary Mr. Norman R. Willard (subsequently com-

missioned as captain in an engineer regiment).

Our first request for medicine was supplied in less than three hours, and since April I we have been able to render instant aid on demand as follows: 2,000 comfort kits, 60 of them going to French sailors on convoys in harbor; medical supplies to practically all Massachusetts camps to value of about \$300; \$50 worth of socks; quantities of reading matter; jellies to camp hospitals; cash aid to temporary dependents; 250 men enlisted through our advice; use of the State blue uniforms while men were waiting for winter outfit from the United States; through Congressmen at Washington, delayed pay checks for State Guardsmen transferred to United States; free medical service, dentistry, and chiropody; the money value of goods distributed has been \$3,000 and the number of men served, 3,500.

## ADDITIONS TO MEMBERSHIP.

From October 1 to November 30, 1917, the Registrar General enrolled a total of 251 new member in 30 State Societies, as follows: California, 8; Colorado, 3; Connecticut, 4; Florida, 2; Idaho, 1; Illinois, 26; Indiana, 3; Iowa, 9; Kansas, 4; Louisiana, 4; Maine, 5; Maryland, 1; Massachusetts, 30; Michigan, 32; Montana, 7; Nebraska, 8; New Hampshire, 2; New Jersey, 33; New York (Empire State), 17; North Dakota, 1; Ohio, 7; Oregon, 1; Pennsylvania, 9; Rhode Island, 9; South Dakota, 2; Texas, 2; Utah, 4; Vermont, 1; Virginia, 3; Wisconsin, 13. [Sixteen additional papers were received from Wisconsin and 15 from Illinois a few days after the preceding enrolment.]

The above is an increase of 93 new members over the same period in 1916; and from May 1 to November 30 the increase has been more than 46 per cent over that period in 1916. The present total active member-

ship is about 15,700.

### THE S. A. R. BADGE AND THE SERVICE BAR.

BADGES.-The standard badge of the Sons of the American Revolution, as provided by Art. XV, Sec. 1, of the Constitution, "may be worn by any member of the Society on ceremonial occasions only, and shall be carried on the left breast, or at the collar if an officer or Past President General of the National Society, or the President, active or past, of a State Society."

The authority for the wearing of the badge by Army and Navy officers is the following:

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the distinctive badges adopted by military societies of men who served in the armies and navies of the United States in the War of the Revolution, the War of Eighteen Hundred and Twelve, the Mexican War, and the War of the Rebellion, respectively, may be worn upon all occasions of ceremony by officers and enlisted men of the Army and Navy of the United States who are members of said organizations in their own right.

Approved, September 25, 1890. (U. S. Stat. at Large, Vol. 26, p. 681.)

Army Uniform Regulations of 1917 (Office of the Quartermaster General), paragraph 64 (b), reads:

64 (b). Badges of military societies may be worn by officers and enlisted men who in their own right, or by right of inheritance, are members of military societies of men who served in the armies and navies of the United States in the War of the Revolution, the War of 1812, the Mexican War. \*

It is not permitted, however, to wear the formal insignia of military societies at the same time as the official medals or badges awarded by the government (62d), nor can any medals or badges be worn on other than full-dress uniform (64d).

Service Bars.—Army Uniform Regulations make no provision for the wearing of bars or sectional ribbons pertaining to military societies, but the Quartermaster Corps provides (to be worn with service uniforms) sectional ribbons and bars covered with ribbon corresponding to the medals and badges awarded by the Government, such as "Certificate of Merit Badge," "Medal Commemorating the Battle of Manila Bay," and about a dozen other official badges. The Sons of the American Revolution Service Bar is not specifically authorized by army uniform regulations and it is therefore unofficial. As in the case of the badge, the bar should not be worn at the same time as any government

Naval uniform regulations describe the form of ribbon bars and specify the manner of wearing them; but no specific mention is made of bars of military societies, which are considered as unofficial.

The S. A. R. bar is not an emblem of merit, but is a mark of membership in a great patriotic Society. It is designed to take the place of the lapel button or rosette, which cannot be worn on uniforms. It is limited to compatriots in the Army and Navy of the United States, and it is the desire of the National Executive Committee that every compatriot in the service wear the bar whenever permissible in accordance with the official regulations. Members in the Home Guard or in Red Cross or Y. M. C. A. war service can wear the lapel button and therefore do not need the bar.

Application for the bars should be made through Secretaries of State Societies, stating name, address, and branch of service to which member belongs, the application to be endorsed by the State Secretary and forwarded to the Secretary General.

About five hundred service bars had been issued to compatriots up to December 1, and additional names are reported daily. It is expected that a complete roster of compatriots in the Army and Navy of the United States will be published at a later date.

#### DOINGS OF STATE SOCIETIES.

The California Society observed the anniversary of Washington's Farewell Address to the Army by holding an informal dinner at the Hotel Fairmont on the evening of November 2. Among the guests of the Society were Major General Arthur Murray, U. S. A.; Hon. A. Carnegie Ross, H. B. M. Consul General; Hon. J. Neltner, Consul General of France; Hon. Chas. de Cazotte, Consul of France, and a number of French, English, and American officers. Addresses were made by Col. R. C. Croxton, U. S. A.; Capt. M. Clavel, of the French Army; Hon. A. Carnegie Ross, H. B. M. Consul General.

The Society has published a pamphlet of 93 pages containing addresses delivered at meetings from 1913 to 1917, biographies of deceased members, Constitution, roll of members, and other historical data, prepared by Thomas A. Perkins and Edmund D. Shortlidge, editors.

The Colorado Society.—The October session of the Pueblo Chapter was held at the Congress Hotel on the evening of October 25. Members of the Pueblo and Arkansas Valley Chapters of the D. A. R. were guests of the occasion. Walter L. Wilder, President of the Pueblo Chapter, introduced the Rev. Frederick A. Hatch, who acted as chairman. Miss Mary L. Shaw, Regent of the Arkansas Valley Chapter, and Rev. Mr. Hatch delivered addresses, and remarks were made by Mrs. R. C. Robe, Regent of the Pueblo Chapter of the D. A. R., and Rev. Thomas Casady.

The Connecticut Society.—On November 13 the State Conference of Connecticut Daughters of the American Revolution was held at Stamford. The National Executive Committee of the Sons of the American Revolution were specially invited to attend. President General Wentworth, Mr. Lewis B. Curtis, Mr. Albert M. Henry, Dr. George

C. F. Williams, and others were present and addressed the Conference on patriotic topics, particularly concerning war activities of both the "Daughters" and the "Sons."

THE COLONEL JEREMIAH WADSWORTH BRANCH held its annual meeting at the City Club, Hartford, on the evening of October 29. Ways of helping to make trench life pleasant for the American troops abroad by supplying them with extras were discussed, and it was decided that the soldiers are being well taken care of in the camps, and that the Society should give its attention to the men already in the trenches and to those now in cantonments when they get in the trenches. Although no definite decision was reached, it was decided that when the Society gets down to business of war relief the efforts should be directed to furnishing extra clothing to keep them warm. Also it was discussed sending Christmas packages and sweets of all kinds to the men.

Officers were re-elected. They are as follows: President, Herbert H. White; Vice-President, John M. Parker, Jr.; Secretary-Treasurer, Charles G. Stone; Historian, Frank B. Gay; Chaplain, Rev. Francis Goodwin; Necrologist, Leverett Belknap; Auditor, Edward W. Beards-ley; Executive Board, Edwin P. Taylor, George S. Godard, Edward N. Stopley

Stanley.

The Committee on Memorials reported that a boulder will be placed within a few weeks in Windsor on the spot where stood the house of Daniel Bissell, the Revolutionary spy. Before the meeting adjourned \$50 was voted to buy wool for the Navy League as the first part of the war-work program.

The General Silliman Branch of Bridgeport gave a reception and war dinner in honor of the National Executive Committee and other general officers at the Stratfield Hotel on the evening of November 14, which was attended by many members of the Daughters of the American Revolution. Mr. Lewis B. Curtis presided as toastmaster. Addresses were made by President General Wentworth, Mrs. Minor, Vice-President General, and by the State and Chapter Regents of the D. A. R., by President Louis Annin Ames of the Empire State Society, Treasurer General Burroughs, and Secretary General Clark.

Mr. Curtis gave a luncheon to members of the Executive Committee and other guests at the Brooklawn Country Club at noon and tendered his home for the business meeting of the Committee.

The District of Columbia Society held the first meeting of the season on November 21, when an address on Food Conservation was delivered by Compatriot James T. Du Bois, who spoke of conditions throughout

the South as observed during a recent lecture tour in the interest of the Food Administration. Announcement was made of the election of 10 new members and 12 applicants proposed for membership whose papers are approved.

The Empire State Society held its regular fall meeting on Tuesday evening, October 16, at the Waldorf-Astoria Hotel, New York City. After receiving the colors the compatriots sang "America," led by a quartette of male voices. It was unanimously voted to omit the usual annual banquet this year.

Having been requested by the White Plains Chapter of the Daughters of the American Revolution to aid them in procuring a flag-pole for the "Washington's Headquarters" at North White Plains, which has been placed in their custody, it was voted to assume the expense of erecting a suitable pole at this place and present it to the White Plains Chapter.

Compatriot John H. Burroughs presented the following resolution which was unanimously accepted:

Whereas, under the present laws of the State of New York, the General Nicholas Herkimer Homestead Association through its constitution does not allow as active and voting members any male descendants of the American Revolutionary Fathers, confining said membership to persons who are members of the German-American Alliance and to the Daughters of the American Revolution:

Whereas such restriction is an injustice to the patriotic Americans who are descendants of the men who fought with General Herkimer at the battle of Oriskany and to other descendants of men who gave active service in the American Revolution; therefore be it

Resolved, That this Society protests strongly against this injustice and respectfully requests the legislature of the State of New York at its next session to amend the said law, eliminating such restriction; be it further

Resolved, That an additional amendment of said law be enacted, to wit: That the presidency of the said General Nicholas Herkimer Homestead Association shall be vested in the person of a native-born American; that no foreign-born person shall be eligible to such office, or to membership in the Association.

This resolution was unanimously approved by the Daughters of the American Revolution at the annual State conference, held at Troy on November 8 and 9.

After receiving the reports of various committees the meeting was addressed by Rev. H. Percy Silver, Chaplain of the United States Military Academy at West Point, N. Y., and Hon. Job E. Hedges.

THE ROCHESTER CHAPTER held its annual meeting on October 17 and re-elected its officers for another year. A War Service Committee,

George Halford Clark, chairman, was appointed to plan and carry out the patriotic work of the Chapter during the period of the war. President Charles E. Ogden prepared a program for the celebration of October 19 as Patriots' Day in the public schools. The Chapter has subscribed for a block of Liberty bonds. An Honor Roll has been engrossed showing the names and service of eight members of the Chapter and 13 sons of members now engaged in military or naval service.

The Illinois Society held its annual meeting at the Auditorium Hotel, Chicago, on December 3, 1917, in commemoration of the admission of Illinois into the Union. About 100 members were present and there was much active interest. At the Board meeting, preceding the general meeting, 15 new members were elected, making a total of 120 names enrolled during the year, and a present active membership of 1,118. The five meetings of the Society during the year are arranged to observe the anniversary of important historic events. Five hundred dollars of the Life Membership Fund has been invested in Liberty bonds. More than 40 members have so far reported themselves in military or naval service.

At the annual dinner addresses were made by Hon. Joseph E. Paden, ex-Mayor of Evanston, on "Pioneers of Illinois," and by Sergeant Baldwin of Canadian Troops, on "Experiences in the Trenches."

An address on "The New War of Independence," delivered by Col. J. A. Ryan at the Yorktown Day Banquet, has been printed as a four-page leaflet.

The Maine Society.—Members of the Maine Society on November 17 tendered a luncheon to President General Wentworth at the Falmouth Hotel, Portland. Addresses were made by the President General, Vice-President General Turner, President Vaill, Vice-President Sanderson, Past President Talbot, and others. Compatriots of the

Maine Society are fully aroused by the gravity of the present struggle of the nation in its determination to overthrow the power of Germany.

The Maryland Society, on October 19, celebrated Peggy Stewart Day by a meeting at the Hotel Belvedere, when an address was delivered by Major M. S. Boehm of the Canadian expeditionary forces (who was wounded at the front) on "The Battle Line in Northern France." James E. Hancock spoke on "The New Drafted Army."

The Massachusetts Society, as mentioned on another page of the present Bulletin, is doing practical patriotic work through its "1917 S. A. R. Minute Man Committee." Recent advices from France report the arrival of the committee's first consignment of boxes for the men in service, including articles for wear and comforts in the way of to-bacco and cigarettes, writing materials, and suitable food luxuries. The President General visited the Boston headquarters of the committee on February 16.

The Boston Chapter met at the Harvard Club on the evening of November 17. Members of the Board of Managers of the State Society were present. Addresses were made by President General Wentworth, President Vernon A. Field, Marshall Putnam Thompson, President of the Boston Chapter; Burton H. Wiggins, President of the Old Middlesex Chapter of Lowell; General Philip Reade, Major Myrick, and others. Mr. Wentworth said in part:

When with you last year I told something of the un-American attitude and activities of our Teuton and pacifist population, particularly their efforts to prevent preparation for the conflict they, as well as every other citizen, realized must come soon or late.

Today much of it is common knowledge through the press accounts of alien enemy activities as exposed through the governmental agencies.

While certain groups with German ideas and inheritance have been and are loyal to the land of their adoption, the Russian revolution and Italian reverses made mighty pleasant reading and were seized upon as additional evidence of the complete co-operation between the all highest and the Almighty.

There is a marked repression of opinion, and I can say the active pro-German of last year has assumed an outwardly neutral attitude at present.

This is not true of the Austrians and certain Russians—a strange combination, opposition to America and opposition to all government bringing about a harmony of effort to handicap any effort toward a vigorous prosecution of the war.

The latter are particularly aggressive in presenting pacifist propaganda, sowing the seeds of doubt and suspicion at every opportunity.

Thus it behooves every American to be alert; the watchful eye and attentive ear must safeguard our liberties and curb their activities.

Do not take any man's patriotism for granted. You do not need to do so in these days, when the nation has a duty for every citizen and affords opportunity for every citizen to prove by his deeds his loyalty.

Patriotism requires more than lip service and the adoption of ringing resolutions. Patriotism today requires work—sacrifice—work by every man physically fit and mentally competent; universal service and universal sacrifice, every one doing his bit—in the army or navy; at home or abroad; in shipyard or factory; on farm or road—let there be neither slacker nor striker!

The well-fixed and the well-to-do, through their sons and their savings, responded to the call of country without whine or whimper, the exemplification of sacrifice through service. Who shall measure the manhood of our first hundred thousand in France, dedicated to the task of making a world safe for democracy, and the hundred thousand at home striking to force a closed shop in industries organized to provide the materials essential to safeguard the hundred thousand in France?

Do not expect me to do it. Your son and my son, true to inheritance, tendered their services. My question is impersonal: If Uncle Sam can command the service of youth and wealth, why tolerate the treasonable and treacherous inactivities of slacker and striker?

THE OLD MIDDLESEX CHAPTER of Lowell held a joint meeting with the Molly Varnum Chapter of the D. A. R. on November 19. President General Wentworth addressed the meeting. He reviewed the work of the Society and the general conditions throughout the country as he has seen them on his various visits to State Societies and Chapters in recent months.

THE OLD SUFFOLK CHAPTER of Chelsea held its 156th meeting, at the Cary Mansion, on November 26, when Mr. E. Philip Finn read a paper on "The Constitutional Convention."

THE WORCESTER CHAPTER is a beneficiary under the will of its Vice-President, George Maury Rice, who died on November 8. Mr. Rice bequeathed \$250 to the Chapter and \$1,000 to the State Society of Sons of the American Revolution.

OLD ESSEX CHAPTER.—President General Wentworth was the guest of officers of the Old Essex Chapter at Lynn on the evening of November 16. Short addresses were made by President Field, Vice-President Bruce, and Past President Atwood of the State Society. President Charles Frederick Smith of the Old Essex Chapter, presiding, was presented with a badge of the Society in behalf of the Chapter, after which President Smith, in behalf of Past President Atwood, presented to the President General a service flag in honor of his son, Capt. Edward N. Wentworth of the 341st Infantry.

On October 19 the Chapter celebrated the anniversaries of Saratoga

and Yorktown by holding a meeting at the "Chateau," on the shores of one of the lakes of Lynn. The meeting was well attended and of exceptional interest. The dinner conformed to the recommendations of Administrator Hoover. A genial wood fire blazing on the hearth of the mammoth stone fireplace which the Chapter has just completed added much to the good cheer of the occasion. The hall was decorated with the flags of our country and our allies, and also with a service flag containing fifteen stars in memory of our fifteen compatriots who are enlisted for service in the present war.

The address of the evening was by Mr. Fred M. Ferrill on "The Aborigines of New England and their Primitive Industry."

The Francis Lewis Chapter of East Walpole has organized a Post of The Washington Guard, with President Isaac Newton Lewis as commandant. Mr. Lewis is local chairman of the Minute Man Committee of the State Society and a member of the Military Efficiency Association of Harvard University. Chaplain Crossett, just returned from France, is Treasurer of the Massachusetts Y. M. C. A. in the effort to raise a large amount for the work of that organization at the war front, and other members of the Chapter are doing their utmost to aid the nation during the war.

The New Jersey Society is very active. The headquarters are open daily and a Bureau of Information patriotically has been established there. The Society sent a large Christmas box to its members on duty in the service, 65 in all. Each one weighed 18 pounds and contained a pipe, handsomely engraved and bearing the initials "S. A. R.," boxes of cigarettes, raisins, domino sugar, tooth-paste, tooth-brush, and other articles suitable for a soldier on field duty. President Chester N. Jones wrote a letter to each soldier and it was enclosed in the box.

Ten members of the Board of Managers visited Camp Dix at Wrightstown, on Evacuation Day, November, 25, and inspected the various Y. M. C. A. buildings, where the men enjoy their hours off duty. The Society will decorate each of the eight structures with an American Flag and pictures of historic scenes. The Society will also invest over a hundred dollars in equipping the buildings and make them as cheerful as possible during the long winter days.

Dues and admittance fee have been remitted by the New Jersey Society to all men in the service.

During the last three months 33 new members have been elected and two reinstated, making the total membership on December 1, 1,283.

The Society purchased a fully equipped standard ambulance and presented it to the New Jersey Red Cross Society. The ambulance took

part in the Red Cross parade on September 22 and the presentation speech was made by Rev. Lyman Whitney Allen, D. D., first vice-president of the Society, at the close of the parade. This was the first ambulance presented to the New Jersey Red Cross Society.

In some recent excavations on Governors Island, in New York harbor, a number of revolutionary cannon balls were dug up and three of them were obtained by Past President W. I. Lincoln Adams and presented to the Society.

The Society was one of the subscribers to the Liberty Loan to the extent of \$1,000, and most of its members were also subscribers, their subscriptions totalling very large figures.

The custom of a quarter of a century and more of holding the annual meeting on the third of January, the anniversary of the Battle of Princeton, will be abandoned for the first time at the forthcoming event. Revision of the constitution and by-laws provide for the holding of the annual meeting on April 19. This has been changed so as to make it easier to close up the affairs of the Society at the end of the fiscal year, on March 31. The Chapters will be invited to hold their annual meetings also on a uniform date.

J. Frank Bowers of Orange Chapter has been very active in the work at Camp Dix. Recently he entertained two officers, whose homes are in the Southland, at his home in East Orange. They were Lieutenants J. E. Peavy, Jr., of Atmore, Ala., and John C. Seay of Germantown, Tenn., both in the Medical Reserve Corps. Mr. Bowers also secured a number of invitations for officers to homes in the Oranges on Thanksgiving Day.

A number of the members of the New Jersey Society fittingly observed the 131st anniversary of the beginning of Washington's retreat across New Jersey on November 20. This date marked the retreat of the army from Fort Lee.

Orange Chapter held its regular monthly meeting on December 1 at the Central Presbyterian Church lecture room, Orange. The guest of the evening was Sergeant-Major W. J. Bramhall, of the Princess Patria Regiment, Canadian contingent, which landed in France December 20, 1914. The Sergeant-Major is one of six or seven survivors of the original roster. The Society, in connection with the New Jersey Historical Society, the Daughters of the American Revolution, and the Daughters of the Revolution, will celebrate on December 18 the anniversary of the adoption by New Jersey of the Constitution of the United States. This was a very important historical event, as the adoption by New Jersey practically settled its final ratification. The exercises are in charge of Historian General David L. Pierson as chairman of the Committee.

The Ohio Society has organized at Lancaster "The Tarhe Chapter," named for a noted Indian chief who once reigned in that vicinity. This was the home of Gen. William Tecumseh Sherman and also of the Ewing family, prominent in politics and in all of our wars. The following are the names of the officers: Henry K. Beck, President, Lancaster, Ohio; William W. Kemper, Vice-President, Lancaster, Ohio; Curtis L. Berry, Secretary and Registrar, Lancaster, Ohio; Louis W. Eyman, Treasurer, Lancaster, Ohio; Dr. George A. Harman, Historian, Lancaster, Ohio.

THE BENJAMIN FRANKLIN CHAPTER held its November luncheon at the Chittenden Hotel, Columbus, on November 8, when Dr. E. F. Tittle, who had just returned from a two months' stay at Fort Sheridan, Ala., told of the work that is being done by our young soldiers.

The Rhode Island Society met at the State Historical Society rooms, Providence, on the afternoon of November 15 and was addressed by President General Wentworth, who discussed in considerable detail the history and present evil influence of Teutonic ideals and the necessity of crushing the Central Powers if civilization is to be preserved. He spoke of his personal observations in portions of the United States where disloyalty was openly manifest among aliens, and of the importance of thwarting insidious efforts being made to propagate principles antagonistic to the sound principles of our forefathers.

Secretary General Clark spoke briefly on the present condition and of the more important activities of the National Society.

The Virginia Society.—President Arthur B. Clarke, on November 13, 1917, read a paper before the Art Club at Richmond on "Light Horse" Harry Lee, in which he traced the genealogy of the Lee family of Virginia from the founder, Lancelot Lee, of France, who went to England with William the Conqueror. He reviewed "Light Horse" Harry Lee's brilliant career in the War of the Revolution and his service in the General Assembly of Virginia and Governor of the State. It was Harry Lee who in his address at the burial of Washington pronounced that thrilling tribute: "First in war, first in peace, and first in the hearts of his countrymen."
