JUNE 1, 1918.

DEAR COMPATRIOTS:

Congresses do not resemble each other any more than men do. Some are extremely important because they are associated with great events.

The National Society of the Sons of the American Revolution recently held its first Congress since our Nation, with an overmastering sense of duty, accepted its burden in this conflict.

ABSTRACT OF PROCEEDINGS OF THE ANNUAL CONGRESS OF 1918.

On the invitation of the Rochester Chapter, the Twenty-ninth Annual Congress of the National Society was held at Rochester, N. Y., on May 20 and 21, 1918. There was an attendance of 127 General Officers and delegates representing 20 State Societies.

THE PRESIDENT GENERAL'S REPORT reviewed the activities of the Society during the year as observed by him during his visits to nearly every part of the country. He urged increased effort to eradicate disloyalty evident in certain quarters.

THE AMERICAN RED CROSS.—Addresses on the Red Cross were delivered by Hon. James T. Du Bois and Past President General Newell B. Woodworth, following which the Congress adopted the following resolution:

WHEREAS during the present week the President of the United States, as president of the American Red Cross, has called upon the people of this country to raise the sum of \$100,000,000 for the use of the American Red Cross in its work of relief at home and abroad; and

WHEREAS the American Red Cross is the recognized governmental agency for carrying on the work of war relief; now it is hereby

Resolved, That the Sons of the American Revolution, in Congress assembled, expresses its approval of this work and of the funds to be raised, and strongly urges all its members to give their active and earnest support in their respective communities to the accomplishment of this week's campaign for the benefit of the American Red Cross.

THE SECRETARY GENERAL reported that the general activities of the National Society had been intensely stimulated by the entrance of the United States in the war, and about one thousand compatriots had gone into service in the Army, Navy, and Marine Corps. The Empire State Society has 156 in service, Massachusetts 144, New Jersey 97, Iowa 62, Michigan and Wisconsin 50, and others in like proportion. The members of the Sons of the American Revolution have contributed very large amounts to the American Red Cross and other war relief work, and to the Liberty Loan many millions have been subscribed.

VICE-PRESIDENTIAL DISTRICTS.—The following amendments to the Constitution, presented by Mr. Curtis at the Newark Congress and recommended by the Connecticut Society and the National Executive Committee, were adopted by the Rochester Congress:

Amend Article V, Section 1, of the Constitution, so as to read as follows:

SECTION 1. The General Officers of the National Society shall be a President General, five Vice-Presidents General, a Secretary General, Treasurer General, Registrar General, Historian General, and Chaplain General, who shall be elected by ballot by a vote of a majority of the members present and entitled to vote at the annual meeting of the Congress of the National Society, and shall hold office for one year and until their successors shall be elected and qualified.

In case of the death or disability of any of the above officers, the Executive Committee is empowered to elect a successor to fill the unexpired term.

In the election of the five Vice-Presidents General one shall be chosen from each of five districts, as follows:

(1) New England District: (Maine, New Hampshire, Vermont, Massachusetts, Rhode Island, Connecticut).

(2) Middle and Coast District: (New York, New Jersey, Pennsylvania, Delaware, Maryland, District of Columbia, Virginia, North Carolina, South Carolina, Georgia, Florida).

(3) Mississippi Valley, East District: (Michigan, Wisconsin, Illinois, Indiana, Ohio, West Virginia, Kentucky, Tennessee, Alabama, Mississippi).

(4) Mississippi Valley, West District: (Minnesota, North Dakota, South Dakota, Nebraska, Iowa, Kansas, Missouri, Oklahoma, Arkansas, Louisiana, Texas).

(5) Mountain and Pacific District: (Montana, Idaho, Wyoming, Nevada, Utah, Colorado, Arizona, New Mexico, Oregon, Washington, California, Hawaii, Philippines).

The boundaries of the said districts may be changed by vote of the Executive Committee.

Amend Article V, Section 3, second paragraph, second and third lines, by eliminating the words, "or in case of his absence or inability, at the call of the Senior Vice-President General, certified by the Secretary General."

The Board of Trustees amended the By-Laws as follows:

Amend Article IV so as to read:

The Vice-Presidents General shall, in each of their respective districts, seek in every manner to promote the interest and activities of the National Society and of the State Societies within their jurisdiction; encourage the formation of new chapters and the enrollment of new members. They shall represent the National Society in the absence of the President General on any proper occasion, but acting at all times under his direction and control.

Amend Article XI by eliminating present Section 3 and renumbering present Sections 4 and 5.

THE REGISTRAR GENERAL reported 1,473 new members enrolled during the year, an increase of 322 over the year preceding and the greatest number in the Society's history. The active roll on May 15 was 15,629

members. The largest State Societies are Massachusetts, 1,736; Empire State, 1,549; New Jersey, 1,309; Connecticut, 1,132; Illinois, 1,120. The greatest number of new members was registered in Massachusetts, 139, and to that State the Syracuse banner was awarded. The traveling banner was won by Wisconsin, which made the greatest percentage of net gain among Societies of more than a hundred members.

THE TREASURER GENERAL reported the balance May 15, 1917, \$7,265.39, and the total receipts of the year \$12,342.54, which included a \$2,000 bequest of Zebina Moses. The total disbursements were \$11,676.10, which included \$3,250 invested in Liberty Loan Bonds, leaving a balance on May 15, 1918, of \$7,931.83 for carrying on the operations of the following year. There is now invested in the Permanent Fund a total of \$13,400. The late Moses Greeley Parker, M. D., former President General, bequeathed the net annual income of a trust fund of \$5,000 held by his executors, but it is not yet known what this income will aggregate.

THE HISTORIAN GENERAL, Mr. David L. Pierson, called particular attention to the institution by the Society of "Constitution Day," on September 17, to commemorate the adoption of that matchless document, and urged the annual observance of that anniversary.

CO-OPERATION WITH THE PRESIDENT.—The following resolution was adopted by the Congress:

WHEREAS the United States of America is engaged in the most stupendous war of recorded history; and

WHEREAS it is the duty of every citizen and every organization to extend its aid and assistance to the United States Government in the suppression of both German propaganda and un-American disloyalty and treason; and

WHEREAS the Society of the Sons of the American Revolution is under a peculiar obligation and has a special duty, owing to its past history, the ancestry of its members, and the devotion with which the Society and its members hold our Government, our traditions, our aspirations and hopes for the future; therefore be it

Resolved, That the National Society of the Sons of the American Revolution does hereby, through its President General and the other proper officers of the Society, extend to the President of the United States its offer of assistance and co-operation to whatever field of endeavor he may assign them; that it offers to the country a membership descended from the patriots who gave their lives and their fortunes to the cause of American Nationality and Independence, and it offers this membership of the blood of the patriots of the War of the Revolution to the service of our country for any duty which may be determined by the President of the United States or other officers of the Government in any suitable field to which they may be assigned.

It was voted that the above resolution be signed by the President General and the Secretary General and forwarded to President Woodrow Wilson at Washington.

REVISION OF IMMIGRATION LAWS.—The Congress adopted the following resolution, introduced by Mr. Lewis K. Sands of Wisconsin:

WHEREAS the participation of our country in the world war now raging has disclosed the fact that many naturalized citizens of foreign birth and children of naturalized citizens born in America are nevertheless alien in sympathy and sentiment and disloyal in thought and act, manifesting a purpose in seeking the opportunities here afforded them purely selfish and mercenary; therefore be it

Resolved, That a special committee of seven be appointed, whose duty it shall be to prepare and submit to the Congress of the United States a memorial, urging a careful revision of the laws covering and dealing with the subject of immigration; that such laws be so amended as to require that all immigrants of sixteen years of age and upwards be required upon entering the United States to declare in writing and under oath their purpose and intention in entering or seeking a domicile in the United States; that if such immigrants shall declare it to be their intention to become citizens of the United States and to acquire a permanent domicile therein, such declarants be required by law to enter upon the study of the English language and governmental science, especially in relation to the Constitution and laws of the United States and American history, unless at the time of entering they are able to pass a satisfactory examination in the fundamentals of the subjects named; that such studies be conducted under the general direction and supervision of the Commissioner of Education of the United States, and that before citizenship shall be conferred applicant therefor shall pass a satisfactory examination in English, civics, and American history; that all aliens entering for business, pleasure, or other temporary purpose, and with no intention of becoming citizens, declare specifically their purpose and be subject to reasonable governmental supervision and regulation as to travel, residence, occupation, etc.; that any act of hostility or unfriendliness subject the person or persons guilty thereof to immediate deportation.

THE AMERICAN'S CREED.—The following resolutions, introduced by Hon. James H. Preston, Mayor of Baltimore, Vice-President of the Maryland Society, were unanimously adopted:

WHEREAS in March, 1917, the city of Baltimore, through Mayor James H. Preston, offered a prize of \$1,000 for the best creed of American citizenship. Committees were then appointed to pass upon the creeds submitted. These committees were (1) a committee on manuscripts, consisting of Porter Emerson Browne, Henry S. Chapin, Hermann Hagedorn, and representatives from leading American magazines; (2) a committee on award, consisting of Matthew Page Andrews, Irvin S. Cobb, Hamlin Garland, Ellen Glasgow, Julian Street, Booth Tarkington, and Charles Hanson Towne; (3) an advisory committee, consisting of

Dr. P. P. Claxton, United States Commissioner of Education, and other National and State officials; and

WHEREAS on the 6th day of March, 1918, the aforesaid committee on award selected from the several thousand contestants creed number 384, the creed submitted by William Tyler Page, which reads as follows:

"THE AMERICAN'S CREED.

"I believe in the United States of America as a Government of the people, by the people, for the people, whose just powers are derived from the consent of the governed; a democracy in a Republic; a sovereign nation of many sovereign States; a perfect Union, one and inseparable, established upon those principles of freedom, equality, justice, and humanity, for which American patriots sacrificed their lives and fortunes.

"I therefore believe it is my duty to my country to love it, to support its Constitution, to obey its laws, to respect its flag, and to defend it against all enemies."

AND WHEREAS on the 3d day of April, 1918, in the city of Washington, the aforesaid creed was presented to the nation through the Hon. Champ Clark, Speaker of the House of Representatives of the United States, and by Dr. P. P. Claxton, United States Commissioner of Education, who, for the nation and in the presence of an assemblage of members of the Senate of the United States and House of Representatives of the United States and other representatives of the Federal Government, accepted the aforesaid American Creed "for the nation and in their name," all of which will more fully appear by reference to the *Congressional Record* of April 13, 1918; and

WHEREAS it is peculiarly appropriate that at the Twenty-ninth Annual Congress of the National Society of the Sons of the American Revolution, taking place in the midst of the world war, some renewal of the memories of the past and a pledge for the future should be entered into by the descendants of the patriots whose blood and sacrifice have made safe to us our national existence and liberties; now, therefore, be it

Resolved by the Twenty-ninth Annual Congress of the National Society of the Sons of the American Revolution, That we do hereby indorse and approve the "American Creed" by William Tyler Page, as selected by a committee of the Vigilantes and presented to the nation, in the city of Washington, as described in the *Congressional Record* of April 13, 1918, and that we give our hearty assent and approval to the sentiments contained therein, and that we commend to our compatriots in whatever jurisdiction the words and the spirit contained in the said "American Creed"; and

Be it further resolved, That the Secretary General be instructed to convey specially to each of the secretaries of each of the State Societies a copy of this resolution, with instructions to read the same at the next general meeting of their respective State Societies.

AMERICAN'S CREED.—Mr. C. P. Wortman of Syracuse offered the following resolution, which was adopted:

Resolved, That the Committee on Americanization and Aliens of the Sons of the American Revolution be authorized to furnish the State Societies, when so requested, with copies of "The American's Creed" for use in the various Chapters in promulgating the work of Americanization in the various communities in the United States; that the expense for the same be paid for out of the funds in the treasury of the various State Societies so receiving the same.

GERMAN LANGUAGE IN SCHOOLS.—The following resolution, introduced by Past President General Woodworth, was adopted by the Congress:

WHEREAS the Society of the Sons of the American Revolution is dedicated to the preservation of American ideals—one land, one flag, one speech, and one standard of loyalty; and

WHEREAS it is manifest that the teaching of the German language in our schools is now subversive to such principles; be it

Resolved, That we call upon those in authority to exclude the teaching of the German language from our public schools; and be it further

Resolved, That the Secretary General be instructed to send copies of this resolution to the President of each State Society; and be it further

Resolved, That the Presidents of each State Society be directed to send copies of this resolution to the Governor, the Department of Education, and to the press of their respective States.

GERMAN NEWSPAPERS AND PERIODICALS.—The following resolutions were adopted by the Congress:

WHEREAS the publication or circulation of papers or periodicals in an alien enemy language is now most dangerous to the welfare of this nation and inimical to its interests; and

WHEREAS it is a well-known fact that the papers and other periodicals now published in the German language are known not to be actively partizan to the cause of this nation and its Allies in the war against the Central Powers of Europe and are but passively patriotic; and

WHEREAS the circulation of such papers and periodicals is yet very large in many parts of this country, where there are also many enterprises of vital importance to the United States Government and to the conduct of the war; and

WHEREAS the movement to curtail and stop the circulation of the German language papers has now reached large proportions; now therefore be it

Resolved by the National Society of the Sons of the American Revolution:

First. That it absolutely opposes the publication and circulation of papers and periodicals or other literature whatsoever in the German language.

Second. That it is in favor of the necessary Federal legislation to suppress such publication and circulation to be passed as soon as possible.

Third. That it hereby requests the proper authorities at Washington to take such immediate and effective action in the premises as they may

be advised is proper to bring about uniform curtailment of the circulation of the said papers.

Fourth. That it directs a copy of these resolutions be sent forthwith to the President and the Congress of the United States.

Fifth. That it directs a copy of these resolutions be sent forthwith to the secretaries of the several State Societies, with the request that it be placed before their representatives in Congress.

GERMAN-AMERICAN ALLIANCE.—The following resolutions, introduced by Col. John W. Vrooman, were unanimously adopted:

Resolved:

First. We approve the statement made in the program of this Congress: "When we win this war there will be just two kinds of people—those who did help and those who did not help."

Second. We congratulate the Empire State Society in its good work in eliminating the German-American Alliance from the custody of the State-owned home of the American-born patriot, Gen. Nicholas Herkimer, the hero of Oriskany.

Third. We thank the Governor and legislature of New York in the passing and signing of a bill repealing the law which authorized the German-American Alliance to largely control the Herkimer home referred to and adopting a new bill, which permits Sons of the American Revolution and all other patriotic societies to have equal opportunity to be selected as commissioners to govern the patriotic shrine of the gallant brigadier.

Fourth. We approve the bill introduced in the Senate of the United States by Senator William H. King repealing the charter of the National German-American Alliance.

CANCELLATION OF INDEBTEDNESS OF FRANCE.—The Congress voted the following resolution:

Resolved, That it is the opinion of the Sons of the American Revolution, in Congress assembled, at Rochester, N. Y., on May 21, 1918, that we can never repay France for all she did for America in the days of the American Revolution; that any action of the Congress of the United States looking to the remittal of indebtedness of France to the United States will meet the hearty approval of the Sons of the American Revolution.

[In the Senate of the United States, May 7, 1918, a joint resolution (S. J. Res. 154) was introduced by Mr. Kenyon, providing "that all obligations of the Republic of France to the United States of America for moneys borrowed or funds advanced since the commencement of the present war, including interest thereon, be and are hereby canceled."]

JUNIOR MEMBERSHIP.—Several State Societies having recommended the formation of some plan by which young men under 21 years of age

now in the service of their country in the Army, Navy, and Marine Corps, and who are otherwise eligible to membership in the Sons of the American Revolution, may be enrolled as junior members, the Executive Committee presented the question to the Congress. After careful discussion favorable to the plan, it was voted that the President General appoint a special committee to formulate a plan, if feasible, and report to the Executive Committee.

ORGANIZATION COMMITTEE.—Mr. Lewis B. Curtis, chairman of Organization Committee for Atlantic States, reported on the operations of that committee, calling particular attention to the war activities of the State Societies and to the large growth of membership in Massachusetts and New Jersey.

THE COMMITTEE ON AMERICANIZATION AND ALIENS reported, through its chairman, Chancellor L. Jenks, and vice-chairman, John H. Moore, U. S. N., that the work the committee had been doing in the teaching of aliens and in the encouragement of naturalization had been greatly stimulated by broad plans of operation undertaken by Government bureaus, relieving the Society of much detail. The report of the chairman called particular attention to "the secret enemy within our borders, which is more dangerous for America than the fighting Boche abroad, not only because of his insidious operation in the dark, but also because his venomous propaganda is inspired by the basest ingratitude and hatred."

FLAG COMMITTEE (W. V. Cox, chairman).—After the reading of the report of the Flag Committee by Mr. Charles O. Parks, the following resolutions were adopted:

Resolved, That the National Society, Sons of the American Revolution, in Congress assembled, approve the report of the Flag Committee, and earnestly ask the Congress of the United States to enact a law at this session to prevent the flag of the United States from desecration, mutilation, and improper use.

Resolved, That the officers of this Society forward to the Committees on Military Affairs, House and Senate of the United States, a copy of this and other reports of this Society, asking legislation to protect the flag.

The committee urged the immediate passage of a law to prevent the desecration of the United States flag.

THE WASHINGTON GUARD.—Governor General John Lenord Merrill reported on progress made in the organization of The Washington Guard, particularly in the formation of military posts of the Guard for

actual training and discipline, with suitable uniforms and other equipment. A proposed form of constitution for such posts was made part of Mr. Merrill's report.

REPRESENTATIVE FROM FRANCE.—Lieutenant Dewierzbicki of the French High Mission, special guest of the Congress, was formally introduced and made a brief address. At the banquet he gave a thrilling account of the war.

TRIBUTE TO DOCTOR PARKER.—Judge Beardsley, chairman of a special memorial committee, presented a tribute to the memory of Dr. Moses Greeley Parker (died October 1, 1917), late President General, prepared by Mr. Edwin S. Crandon of Boston, former Vice-President General, and it was adopted and ordered printed in the National Year Book.

TRIBUTE TO MR. MOSÈS.—On motion by Judge Beardsley, the following resolution was adopted:

WHEREAS our late compatriot, Zebina Moses, has given the National Society of the Sons of the American Revolution a legacy of \$2,000 as an addition to its Permanent Fund; therefore

Resolved, That the Society gratefully appreciates the gift and tenders its sincere thanks for the same.

GRAVE MARKER.—Mr. Woodworth, chairman of special committee on standard grave marker for Revolutionary soldiers, recommended for general use by the National Society a seal, or medallion, submitted by the District of Columbia Society. The Congress adopted the design and referred the matter to the Executive Committee to be carried out. The marker is a bronze circular disk three and a quarter inches in diameter and three-eighths inch thick, bearing three concentric circles containing suitable lettering and inclosing in the center the cross of the Society. The disk is intended to be embedded in the original grave-stone or in a special stone cut for the purpose. The committee called attention to the fact that the marker might be modified for use on graves of compatriots killed in the present world war.

INVITATIONS FOR 1919 CONGRESS.—The Michigan Society invited the Congress to meet in Detroit in 1919, and like invitations were presented by the Maryland Society to meet in Baltimore and by the Wisconsin Society to meet in Milwaukee, all of which were referred to the Board of Trustees, having selection of place of meeting under the provisions of the Constitution.

ELECTION OF OFFICERS AND TRUSTEES concluded the business of the Congress. General Officers were unanimously chosen, as printed on a preceding page.

SOCIAL FUNCTIONS connected with the Congress included (1) a luncheon on Monday noon at the Hotel Seneca, given to delegates and ladies by the members of the Irondequoit Chapter of the Daughters of the American Revolution, when addresses were made by Mrs. Frank F. Dow, Regent; President General Wentworth, Mrs. A. Howard Clark, Mayor Preston of Baltimore, Colonel Vrooman, and others; (2) a reception on Monday evening at the home of Mr. and Mrs. Frederick Yates; (3) an automobile ride on Tuesday afternoon through the city parks; (4) a banquet on Tuesday evening at the Hotel Seneca in honor of delegates and ladies, when addresses were made by the retiring President General and the President General elect, by Lieutenant Dewierzbicki of the French High Commission, and by Hon. James T. Du Bois, former Ambassador to Colombia.

RELIGIOUS PATRIOTIC SERVICES were held in the Central Presbyterian Church on Sunday evening, May 19, at 7.30 o'clock. Delegates marched from the Hotel Seneca to the church, escorted by Company 3, Rochester Home Defense League. The sermon was preached by Rev. C. Waldo Cherry. The Congress voted to ask Dr. Cherry for a copy of the sermon for publication in the National Year Book.

MINUTES OF MEETING OF EXECUTIVE COMMITTEE, MAY 20, 1918.

A conference of the Executive Committee, duly called by order of the President General, was held at the Hotel Seneca, Rochester, N. Y., on the afternoon of May 19, and the proceedings were formally ratified at a meeting at 9 a. m., May 20. Present at the conference were the President General, Past President General Woodworth, Mr. Curtis, Mr. Ames, Mr. Henry, and Mr. Merrill of the committee; also Secretary General Clark, Historian General Pierson, Chaplain General Foster, Gen. Philip Reade, Past President General Beardsley, and Mr. Williams.

The minutes of the meeting of the committee on November 14, 1917, as published in the December BULLETIN, and action taken since that day by correspondence were approved.

It was voted to accept with gratitude a bequest of \$2,000 from late Compatriot Zebina Moses as an addition to the Permanent Fund and to ratify the action of the President General in authorizing the investment of the bequest in Liberty Bonds.

Mr. Curtis was requested to prepare a tribute to Compatriot Moses for presentation to the Congress.

After some discussion of the feasibility of establishing a grade of junior membership in the Society, Mr. Woodworth, Mr. Ames, and Mr. Nevins were appointed to submit a recommendation on the subject to the Congress for its consideration.

The President General announced that Judge Beardsley, Mr. Henry, and Mr. Foster would be appointed the Committee on Resolutions offered at the Congress.

There was informal discussion of various matters to come before the Congress.

There being no further business, the meeting then adjourned.

Amendments to Article IV and Article XI of the By-Laws were announced for action at the next meeting of the Board.

There being no further business, the meeting then adjourned.

MINUTES OF MEETING OF BOARD OF TRUSTEES.

MAY 21, 1918.

A meeting of the Trustees elected at the Rochester Congress was held at the Hotel Seneca, on call of the President General, immediately after the adjournment of the Congress. Present, President General

Ames, Mr. Wentworth of Iowa, Mr. Clarke of Virginia, Mr. Smith of Utah, Colonel Elliott of Delaware, Mr. Henry of Michigan, Mr. Read of Massachusetts, Colonel Houk of Ohio, Historian General Arnold of Rhode Island, Secretary General Clark, Mr. Pugsley of New York, and others.

The following nominations by the President General for members of the Executive Committee were approved: President General Ames, chairman; Elmer M. Wentworth of Iowa, Chancellor L. Jenks of Illinois, Lewis B. Curtis of Connecticut, John Lenord Merrill of New Jersey, John M. Reifsnider of Maryland, George E. Pomeroy of Ohio. Mr. Henry recommended that the Executive Committee prepare a map defining the boundaries of the Vice-Presidential districts.

Invitations for the entertainment of the 1919 Congress were received from Detroit, Baltimore, and Milwaukee. After consideration, it was voted to accept the Detroit invitation and to thank the Societies in Maryland and Wisconsin for their courteous offers of hospitality.

It was voted that the Executive Committee be, and is hereby, empowered to make appropriations for such expenses as may be proper to be incurred in furthering the work of the Society.

It was voted that the Executive Committee be, and is hereby, empowered to act on such matters referred to the Board of Trustees by the Congress, or such new business as in the judgment of the President General may not require the action of a meeting of the Board.

The following amendments to the By-Laws recommended by the Connecticut Society and the National Executive Committee, notice thereof having been given at a meeting of the Trustees on May 20, were unanimously adopted:

Amend Article IV so as to read:

The Vice-Presidents General shall, in each of their respective districts, seek in every manner to promote the interest and activities of the National Society and of the State Societies within their jurisdiction; encourage the formation of new chapters and the enrollment of new members. They shall represent the National Society in the absence of the President General on any proper occasion, but acting at all times under his direction and control.

Amend Article XI by eliminating present Section 3 and renumbering present Sections 4 and 5.

There being no further business, the meeting of the Trustees was then adjourned.

MINUTES OF MEETING OF EXECUTIVE COMMITTEE,
MAY 21, 1918.

A meeting of the Executive Committee, duly called by the President General, was held at Rochester, N. Y., on the afternoon of May 21, 1918. Present, President General Ames, Mr. Wentworth, Mr. Curtis, and Mr. Pomeroy, of the committee, Secretary General Clark, and Vice-President General Williams.

Appropriations were voted for carrying on the affairs of the Society during the year, including \$500 toward expenses of the Detroit Congress; \$500 for expenses of office of President General; salary of Secretary General and Registrar General and necessary office expenses, including clerical assistance, as during the past year, and for necessary traveling expenses of the Secretary General in attendance at the Annual Congress and meetings of the Executive Committee and Trustees, and for traveling expenses of Treasurer General in attendance at the Annual Congress.

It was voted that during the period of the war the October issue of the OFFICIAL BULLETIN be omitted, and the Secretary General was authorized to reduce the expense of the issues for June, December, and March as much as he deemed advisable.

It was voted that the National Year Book for 1918 be published in a limited edition, free distribution to be made only to the General Officers, Executive Committee, Trustees, two copies to each State Society, one to each Chapter, one to each delegate at Rochester, and to the usual list of libraries. Such additional copies as may be available may be sold at cost price.

The Secretary General was instructed to edit the contents of the Year Book by condensing debates and omitting unimportant matter. Such amount as may be necessary was voted for printing and distributing the Year Book.

The President General was authorized, at any time when he shall so desire, to submit by mail or telegraph any matter requiring the action of the Executive Committee to the several members thereof, and that any vote so taken by mail or telegraph shall have the same force and effect as if the Executive Committee had been convened in special session and action taken at such specially called meeting.

The Secretary General was instructed to ascertain and report to the committee what arrangements could be made for the manufacture and sale of the grave-marker adopted by the Congress for general use by the National Society.

There being no further business, the committee then adjourned.

Seventy-one pupils of the high schools of California competed for prizes offered by the California Society for the three best essays on "America in the War for Democracy." The first prize of \$25.00 was awarded on March 7 to a pupil in the Vallejo High School, the second of \$15.00 to a pupil in the Stockton High School, and the third of \$10.00 to a pupil of the Stockton High School.

The Connecticut Society held its annual meeting at the Hartford Club on June 15, 1918, and elected officers as follows: President, George F. Burgess, New Haven; Vice-President, Merritt Hemingway, Watertown; Secretary-Treasurer, Charles G. Stone, P. O. Box 847, Hartford; Registrar, Frederick Bostwick, 144 Grove St., New Haven; Historian, Frank B. Gay, Hartford; Chaplain, Rev. E. Livingston Wells, Hartford; Necrologist, Leverett Belknap.

Resolutions were adopted protesting against teaching or the use of the German language in public schools of the State. The retiring President, Clarence H. Wickham, presided.

THE COLONIAL JEREMIAH WADSWORTH BRANCH held its spring meeting and supper at the Hartford Club on April 25, when Mr. F. T. Moore gave a demonstration of the latest model of the Browning gun, and remarks were made on Colonial arms.

The exercises at the meeting included reports of officers and committees; short talks by compatriots in the service, and an illustrated lecture on Petrograd by Compatriot Dr. Oliver G. J. Schadt, formerly resident tutor among the Russian nobility and American Commissioner to the World's Fair at Petrograd in 1904. The roster of compatriots in service during the war is published in the Empire State Society Bulletin. The Treasurer reported \$16,600.15 invested in the Special or Permanent Fund provided by the Constitution.

THE NEW YORK CHAPTER of the Empire State Society has been chartered, with a membership of 850.

THE ROCHESTER CHAPTER, on May 20 and 21, entertained the Twentieth Annual Congress in a most hospitable manner. There was an attendance of 127 delegates—a number much greater than anticipated under war conditions. The business of the Congress had much to do with war activities and delegates seemed earnest in endeavors to help the nation. Social functions, including luncheon, reception, automobile ride, and banquet, were all exceedingly pleasant affairs.

THE NEWBURGH CHAPTER observed the fifteenth anniversary of its organization, on Lexington Day, by holding a meeting at the Palatine. A dinner was first served, the retiring President, S. L. Stewart, presiding. The principal address was by compatriot, the Rev. J. Lewis Hartsock, Ph. D., on "God's Purpose in America." Short patriotic talks were given by Compatriots Purdy, Whitney, Stewart, and President-elect Kelly. The exercises included greetings by Dr. Cyrille Vermeren, Consul for Belgium; address, "Messages from the Trenches," by a returned Canadian army officer; address, "What Every American Should Know," by Compatriot Carl D. Case, D. D.; address, "Was the Sacrifice of the Fathers Worth While?" by Bishop Thomas Nicholson.

The Iowa Society held its annual meeting and dinner at Des Moines on April 19. The following officers were elected: President, Dr. Edward Elisha Dorr, Des Moines; First Vice-President, Lewis L. At the dinner at 7 o'clock 104 persons were present. Addresses were made by Hon. Chancellor L. Jenks of Evanston, Ill., and President General E. M. Wentworth. The address by Mr. Jenks is printed in the Society's publication, "The Old Continental."

A service flag bearing 62 stars was unfurled and presented, having on it two golden stars for compatriots who have lost their lives in this war.

The Kentucky Society has elected Ben La Bree, the Registrar, to serve also as Secretary of the Society for the unexpired term of Mr. Crutcher, removed to Oklahoma.

The Louisiana Society has been reorganized during the past ten months, and with new officers and new zeal has made decided progress. President Churchill reports the enrolment of many members, with prospect of an increase of more than fifty within the next few months.

In December, at a general meeting of the Society, Compatriot E. T. Merrick, former President, gave an address on the history of the organization, and laid special stress on what the Louisiana Society had not done and should do in the future. This being the annual meeting, the new officers were elected.

Early in April a lecture was given by Mr. Andre Lafarge, who related his experiences in January and February during his trip to France with four other residents of New Orleans on a mission to celebrate the centennial of the founding of New Orleans. His subject was "My Trip to France." Several hundred feet of films were exhibited showing views of this committee visiting in various points in France.

The next lecture was on May 7 by Compatriot Patterson, who for years has been an active worker in charity organizations.

On May 16 the Society celebrated the twenty-fifth anniversary of its founding by a dinner at the French Restaurant Louisane, when addresses were made by Past Presidents Merrick, Robinson, and Wood, and by Compatriots Wright and Milling. President C. Robert Churchill presided. There was an attendance of 46 members, and the occasion was one of the most enthusiastic in the history of the Society.

The Society has not been inactive in other directions. For example, it is building a War Fund, which is only just started. At this moment something about \$1,000 is in the treasury for this special purpose. That particular amount of money has been raised among 15 of the 100 members. The balance of them have not been approached as yet. This money will be expended in the most judicious manner for Red Cross and other work connected with the war and for use for which these organizations do not always have ready funds.

Medals have been donated—one each for the boys' and girls' high schools of this city—for the best essay on the subject, "Material Resources of Louisiana Available for the War." No doubt this will bring out some thoughts and some ideas as to the actual resources of the State.

The Society has just issued a 24-page booklet, giving a complete roster of the members and showing lots of other information that is very useful to the organization as a whole, special stress being laid on facts pertaining to Louisiana's assistance to the Colonies in the Revolutionary War. Copies of this booklet will be distributed to each of the other Chapters in the United States. More copies can be had on request.

Some historical work is also being done in regard to Louisiana's part in the American Revolutionary War, uncovering the real remarkable campaigns of Don Bernardo de Galvez in the years 1779, 1780, and 1781, and diligent search is being made for copies of roster of the troops that served with him, particularly during the year 1779, at which time his army of about 1,800 men was composed almost exclusively of Louisianians, a large portion of these being descendants of the Arcadians, those unfortunate people who had been expelled from Nova Scotia by the British. The descendants of every one of these men are eligible to

the Society, and it is hoped that before long authentic records will be found.

There are a couple of pages in the booklet bearing on this particular question, but from an historical standpoint and for reference only.

Baker, 303d Infantry range officer; Mr. William R. Balch, long a resident of London, now with *The Boston Transcript*, who delivered an address on "Revelations of the Present War"; Surgeon David G. Eldridge, Commonwealth dock, and Sergt. Charles J. Meissner, fife and drum squad.

The S. A. R. Minute Man Committee has been active in war work: Money expended, \$3,000; number of men assisted, 5,000; number of articles given out, 12,000; supplies sent to every camp and fort in Massachusetts, to every New England State, to New York, New Jersey, North Carolina, Virginia, Texas, and Halifax; also to French sailors on convoys in our harbor and our boys in France; 2,500 certificates for services rendered have been awarded, going to nearly every State, to Washington, to Paris, to London, and Australia; jellies, books, periodicals, and felt slippers to hospitals; gloves, sweaters, wristers, mufflers, socks, helmets, comfort bags, games, graphophone records sent to the soldiers; medicine, stationery, and typewriting machines furnished camps; legal advice, dentistry, and chiropody supplied free, and through co-operation of Washington representatives delayed payments secured for soldiers and dependents.

The dedication ceremonies included a parade in which 12,000 persons participated, it being the first occasion of a public character in which the Oklahoma Society, S. A. R., had participated as an organization. An appropriate banner identifying the organization was carried, and generous recognition of the Spirit of '76 was expressed by the little company of descendants of those who made America free, was accorded along the line of march. The parade was reviewed by Compatriot Governor R. L. Williams and Lieut. Paul Perigord of the French army.

The Rhode Island Society, on May 4, dedicated a memorial to Col. Israel Angell at the North Burial Ground, Providence. Vice-President Sumner paid tribute to the character of Colonel Angell and Col. Robert P. Brown read a paper on the military career of that soldier in the Revolution.

President George Albert Smith of the Utah Society marched beside Chaplain Lewis.

The Wisconsin Society has largely increased its membership during the year, making the greatest net percentage of gain among societies of more than 100 members, and was awarded the traveling banner at the Rochester Congress. The Society has taken a stand against the study of German in the schools.
