THE AMERICAN'S CREED.

I believe in the United States of America as a government of the people, by the people, for the people, whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign nation of many sovereign States; a perfect Union, one and inseparable, established upon those principles of freedom, equality, justice, and humanity for which American patriots sacrificed their lives and fortunes.

I therefore believe it is my duty to my country to love it; to support its Constitution; to obey its laws; to respect its flag, and to defend it against all enemies.

STORY OF THE AMERICAN'S CREED.

The idea of laying special emphasis upon the duties and obligations of citizenship in the form of a national creed originated with Henry S. Chapin. In 1916-1917 a contest, open to all Americans, was inaugurated in the press throughout the country to secure "the best summary of the political faith of America." The contest was informally approved by the President of the United States. The artists and authors of the Vigilantes, especially, and representatives of other patriotic societies

supported it; the city of Baltimore, as the birthplace of the Star-Spangled Banner, offered a prize of \$1,000, which was accepted, and the following committees were appointed: A committee on manuscripts, consisting of Porter Emerson Browne and representatives from leading American magazines, with headquarters in New York City; a committee on award, consisting of Matthew Page Andrews, Irvin S. Cobb, Hamlin Garland, Ellen Glasgow, Julian Street, Booth Tarkington, and Charles Hanson Towne; and an advisory committee, consisting of Dr. P. P. Claxton, United States Commissioner of Education, Governors of States, United States Senators, and other national and State officials.

The winner of the contest and the author of the Creed selected proved to be William Tyler Page, of Friendship Heights, Maryland, a descendant of President Tyler and also of Carter Braxton, one of the signers of the Declaration of Independence.

FROM THE CONGRESSIONAL RECORD.

The complete proceedings in regard to the official acceptance of the American's Creed may be found in the *Congressional Record*, No. 102, April 13, 1918, from which is taken the following explanation of the doctrinal origin of the Creed: . . .

"The United States of America"—Preamble Constitution of the United States.

"A government of the people, by the people, for the people"—Preamble Constitution of the United States; Daniel Webster's speech in the Senate, January 26, 1830; Abraham Lincoln's Gettysburg speech.

"Whose just powers are derived from the consent of the governed"—Thomas Jefferson, in Declaration of Independence.

"A democracy in a republic"—James Madison, in *The Federalist*, No. 10; Article X of the Amendments to Constitution.

"A sovereign nation of many sovereign States"—*E pluribus unum*, great seal of the United States; Article IV of the Constitution.

"A perfect Union"—Preamble to the Constitution.

"One and inseparable"—Webster's speech in the Senate, January 26, 1830.

"Established upon those principles of freedom, equality, justice, and humanity, for which American patriots sacrificed their lives and fortunes"—Declaration of Independence.

"I therefore believe it is my duty to my country to love it"—In substance from Edward Everett Hale's "The Man Without a Country."

"To support its Constitution"—Oath of Allegiance, Section 1757, Revised Statutes of the United States.

"To obey its laws"—Washington's Farewell Address; Article VI, Constitution of the United States.

"To respect its flag"—National Anthem, The Star-Spangled Banner; Army and Navy Regulations; War Department circular on Flag Etiquette, April 14, 1917.

"And to defend it against all enemies"—Oath of Allegiance, Section 1757, Revised Statutes of the United States.

At the Rochester Congress of the National Society, on May 20, Compatriot James H. Preston, Mayor of Baltimore, introduced a series of resolutions on the American's Creed, as recited in the June OFFICIAL BULLETIN and the National Year Book, and they were unanimously adopted. The concluding resolution was as follows:

WHEREAS it is peculiarly appropriate that at the Twenty-ninth Annual Congress of the National Society of the Sons of the American Revolution, taking place in the midst of the world war, some renewal of the memories of the past and a pledge for the future should be entered into by the descendants of the patriots whose blood and sacrifice have made safe to us our national existence and liberties; now, therefore, be it

Resolved by the Twenty-ninth Annual Congress of the National Society of the Sons of the American Revolution, That we do hereby indorse and approve the "American's Creed," by William Tyler Page, as selected by a committee of the Vigilantes and presented to the nation, in the city of Washington, as described in the *Congressional Record* of April 13, 1918, and that we give our hearty assent and approval to the sentiments contained therein, and that we commend to our compatriots in whatever jurisdiction the words and the spirit contained in the said "American's Creed"; and

Be it further resolved, That the Secretary General be instructed to convey specially to each of the secretaries of each of the State Societies a copy of this resolution, with instructions to read the same at the next general meeting of their respective State Societies.

MINUTES OF EXECUTIVE COMMITTEE MEETING, DECEMBER 12, 13, 1918.

A meeting of the Executive Committee and the Advisory Committee, duly called by the President General, was held at the Belvedere Hotel, Baltimore, at 10 o'clock a. m., December 12, 1918. President General Ames presided, with full attendance of the committee: E. M. Wentworth, Chancellor L. Jenks, Lewis B. Curtis, John Lenord Merrill, John Milton Reifsnider, George E. Pomeroy; also Past Presidents General Cornelius A. Pugsley, Hon. Edwin Warfield, and Secretary General A. Howard Clark of the Advisory Committee. Letters of regret were received from Judge Stockbridge and others of the Past Presidents General on the Advisory Committee and from the Vice-Presidents General who had been invited to attend in conference and from the Treasurer General. President Hancock, Secretary Robertson, and Treasurer Houghton of the Maryland Society also attended the meeting. The minutes of the last meeting of the committee were read and approved.

In his absence, the report of Treasurer General Burroughs was read by the Secretary General. The balance on hand May 15, 1918, was \$7,931.83; total receipts since that date, including \$200 interest from the Moses Greeley Parker Fund, \$1,593.86; total disbursements, \$2,799.34; balance on hand November, \$6,726.35.

The Registrar and Secretary General reported the business of the Society and the general activities in good condition. The present total membership is 16,200. The enrollment of new members from May 1 to November 30, 1918, has been 647, an increase of 100 of the same period a year ago.

Resolved, That the Executive Committee endorses the work of "The National Association for Constitutional Government," of which Compatriot David Jayne Hill is president, and recommends co-operation on the part of our membership therein.

It was voted that J. E. Caldwell & Co. be authorized to manufacture and sell to members at their own expense, without any responsibility on the part of the National Society, a gold seal finger ring bearing as an emblem the central part of the badge of the Sons of the American Revolution.

The Secretary General reported progress in arrangements for manufacturing the grave-marker adopted by the Rochester Congress, and he

was authorized to complete arrangements for making and selling the marker without incurring expense therefor.

The action of the committee, taken by correspondence, in electing Frank W. Rawles, a Vice-President General, in place of Mr. Churchill, who was elected at the Rochester Congress, but did not accept the office, was ratified and confirmed.

A report of the Committee on Americanization was presented by Chairman Jenks and approved.

The following proposed amendment to the Constitution, recommended by the Maryland Society and the Empire State Society for action at the Detroit Congress, was presented for information of the committee:

Amend Section 4, Article V, of the Constitution of the National Society by adding the following new paragraph to the Section:

The members of the Executive Committee, other than the President General, shall be known as Directors General, and by virtue of their office shall be members of the National Congress and entitled to vote at the annual meeting of the National Congress during their terms of office.

It was voted that the National Society of the Sons of the American Revolution continue the observance of the 17th day of September as Constitution Day, inaugurated by President General Wentworth in 1917, and be considered the principal anniversary celebration by the Society each year throughout the country. Mr. Wentworth was requested to prepare a letter on the subject to be sent to the several Societies and Chapters.

A letter was received from Mr. Pierson, chairman of the Publicity Committee, reporting on the very gratifying results of the work of the committee in promoting the observance of Constitution Day, the State Societies very generally co-operating in carrying out this important celebration.

It was voted that on account of the legal complications involved, no action should be taken on the proposition discussed at the Rochester Congress to enroll minors under 21 years of age as members of the Society.

The distribution of ribbon bars to be worn by compatriots in the Army or Navy of the United States was ordered to be discontinued.

It was voted that the President General, Mr. Jenks, Mr. Wadsworth, and the Secretary General be a committee with power to secure bronze memorial medals or badges for members, sons of members, and families of deceased members who have served in the late world war, the State Societies to pay the cost of the badges and the presentation to be made with some formality in the presence of a National Society officer.

The President General submitted a letter from the Acting Governor of the Society of Colonial Wars, asking the co-operation of the Sons of the American Revolution, with other patriotic societies, in the presentation at the proper time to Marshal Foch "a very handsome sword as an expression of our esteem, admiration, and appreciation of his great services to the Allied cause in stemming the German advance."

The committee took a recess at 11.50 a. m. until Friday at 9.30 a. m. On Friday morning, December 13, the committee reconvened.

Mr. Curtis reported in full on the work of the Committee on Increased Membership, presenting several proposed plans for State Society operations. The report was received and the committee was authorized to send out a letter embodying its suggestions of methods for securing new members.

A letter was received from Past President General Francis Henry Appleton, recommending that "our national Thanksgiving Day be made more than it has come to mean"; that hereafter it may be a real national Peace Day.

President General Ames presented correspondence he had had with President Spillman of the Oklahoma Society, asking the co-operation of the National Society toward the erection of a monument in Oklahoma City "to commemorate the memory of the soldiers and sailors who have given their lives in the cause of human liberty," thus inaugurating a movement to erect a monument in each State.

The Executive Committee expressed its hearty endorsement of the general proposition, but felt that it should await some general action by the Federal Government in connection therewith.

After discussing various matters concerning the welfare of the Society, the committee adjourned.

SOCIAL FUNCTIONS INCIDENT TO COMMITTEE MEETING.

On Wednesday evening, December 11, the Executive Committee and officers of the Maryland Society were guests of the Southern Commercial Congress at a banquet, attended by 700 diners, at the Emerson Hotel. On Thursday noon the Maryland Society gave an oyster luncheon to the committee at the Athletic Club, and in the afternoon they were guests of Mayor Preston on a submarine chaser, leading a naval pageant in Baltimore harbor, in review of a war-ship squadron. At 6 o'clock the committee and several officers of the Maryland Society were entertained at dinner by the President General. On Friday afternoon, after

reviewing a military parade, made up in part of soldiers returned from the war, the committee and several officers of the Maryland Society, with some city and State officers, were given an elaborate luncheon at the Maryland Club, when, in after-luncheon addresses, Compatriot Preston was most highly and justly commended for his wonderful work in beautifying the city.

DOINGS OF STATE SOCIETIES.

THE COLONEL JEREMIAH WADSWORTH BRANCH of the Connecticut Society held its annual meeting at the Hartford Club December 12, when an illustrated lecture on "The Hun" was delivered by Mr. William Webster Ellsworth. The following officers were elected: President, John Marvin Parker, Jr.; Vice-President, George S. Godard; Secretary-Treasurer, Charles G. Stone; Historian, Frank B. Gay; Chaplain, Rev. E. Livingston Wells; Necrologist, Leverett Belknap; Auditor, Edward W. Beardsley; Executive Board, Edward M. Stanley, New Britain; Edward P. Taylor, and Meigs H. Whaples.

The District of Columbia Society, at its meeting on November 15, listened to addresses by Senator Warren G. Harding of Ohio and Rear Admiral George W. Baird, and on December 18 were addressed by Compatriot Claude N. Bennett.

The Massachusetts Society.—The Old Essex Chapter held a Victory meeting at Lynn on November 20, and an address was given by Lieutenant Vittoris Orlandini of the Italian Military Mission.

The Illinois Society held its annual meeting on Tuesday evening, December 3, 1918, at the Auditorium Hotel, Chicago. About 400 were present. The program included: Music, by Goldsmith's Orchestra; toastmaster, Fred A. Smith, President of the Society; invocation, Dr. Frederick L. Selden, Chaplain of the Society; address, "America and the World Crisis," Prof. Herbert L. Willett, D. D., the University of Chicago; address, "Illinois," Hon. Edward F. Dunne, ex-Governor of Illinois; unveiling of the Service Flag of the Society, presented to State Society by Oak Park Chapter; dedication of Roll of Honor, ceremony directed by the Alden Kindred of America, assisted by the First Infantry, Veteran Corps, Illinois Reserve Militia, Capt. John S. Beeler, commanding.

The Maryland Society held a special meeting on December 12, 1918. This meeting was held in lieu of the regular meeting of the

Society on October 19, Peggy Stewart Day, which was postponed on account of the epidemic of Spanish influenza, which was very prevalent at that time. The date selected, that of December 12, is the anniversary of the moving of the Continental Congress from Philadelphia to Baltimore, and the date was also very significant in that the Executive Committee of the National Society, at the invitation of the Maryland Society, moved its semiannual meeting to Baltimore.

There were present at the meeting about 125 members of the Maryland Society, and among the distinguished guests were President General Louis Annin Ames and every member of the Executive Committee of the National Society.

The theme of the evening was Americanization and the American Creed. Hon. James H. Preston, Mayor of Baltimore, explained the conception of the American Creed, and the presentation of the same to the Congress of the United States and the National Congress of the S. A. R. at Rochester last May, and the acceptance by both.

Hon. John Milton Reifsnider, chairman of a special committee on the subject, reported that the Society was now having the Creed printed in a large form and framed for presentation to all schools in the State of Maryland, and were trying to have same learned by every school child in the State. He further reported that every child in the city of Baltimore must learn it.

Mr. William Tyler Page, a descendant of President Tyler and the author of the American's Creed, was present and recited the Creed:

THE AMERICAN'S CREED.

I believe in the United States of America as a government of the people, by the people, for the people, whose just powers are derived from the consent of the governed; a democracy in a republic; a sovereign nation of many sovereign States; a perfect Union, one and inseparable, established upon those principles of freedom, equality, justice, and humanity, for which American patriots sacrificed their lives and fortunes.

I therefore believe it is my duty to my country to love it; to support its Constitution; to obey its laws; to respect its flag, and to defend it against all enemies.

The guest of the evening, President General Louis Annin Ames, gave a most enjoyable talk on the relation of democracy and republic and the spirit of 1776. He spoke of the work of the Executive Committee in celebrating Constitution Day, September 17, and said it should be second only to Declaration Day. He concluded with the remarks that the three leading nations—the United States, France, and England—

are all democracies and will work on together, and that America will be the beacon light for the entire world.

Chancellor L. Jenks of the Executive Committee spoke of what was being done in the Middle West regarding Americanization, and said he welcomed the American's Creed and hoped that it would become the slogan of Americanization, and that the last paragraph of same be the especial inspiration of every member of the Sons of the American Revolution.

Major Edouard Dupont of the French Military Mission, who had been over three years of active service, gave a most interesting talk on what France had done during the war and how she was preparing for the reconstruction of the nation.

The meeting being turned over to the entertainment committee, the guests and members partook of a buffet luncheon and a social interchange before dispersing.

THE DETROIT CHAPTER, at its October meeting, listened to an address by Major George E. McKean, M. C., U. S. A., home from France, and members of the Chapter who had sons in the service told about what their sons were doing.
