The Society has won and been accorded recognition as a national institution, not as an historic or genealogical association, but as a great patriotic organization. It aims to keep step with the music of the Union—alert, progressive and untiring in the service and for the welfare of the whole country.

A. Howard Clark,

Secretary General, 1892-3: 1904-18.

Registrar General, 1893-1918.

The past year brought many sorrows to the Sons of the American Revolution, but none that affected the entire membership as deeply as the death of Compatriot A. Howard Clark, a victim of Spanish influenza, at Washington, D. C., December 31, 1918.

Compatriot Clark was a true American—a student of American life and institutions, an instructor by example and precept of the duties and obligations of American citizenship; his daily life was devoted to the upbuilding of a better Americanism.

A. Howard Clark was born at Boston, April 13, 1850, and became a member of the Sons of the American Revolution upon the organization of the District of Columbia Society, April 19, 1890. He served in various capacities in the District Society and was elected Secretary General of the National Society in 1892. At the next Congress he was elected Registrar General, serving as such over a quarter of a century. In 1904 he was elected Secretary General and performed the joint duties until his death.

Among other activities, Compatriot Clark was especially interested in the work of the Smithsonian Institution, serving from 1881 to the time of his death as Curator of the Division of History and editor of their publications, the latter requiring a very broad knowledge of the varied branches of Science, and Secretary or Curator of the American Historical Association from 1889. He had represented his country as Commissioner to the Exposition at Paris in 1889, and as attaché to the Exposition at London in 1883, being honored by the Government in both countries and received the Decoration of Officier du Mérite Agricole from the President of the French Republic.

Compatriot Clark was a member, by right of descent, in many patriotic societies, but his energy and affection was given to the one that he ever deemed to possess the opportunity to promote the greatest good to his country, the National Society of the Sons of the American Revolution.

Compatriot Clark married Miss Alice Morrow, who, with two sons, survive him. Their grief is shared by every member of the Society, who tender them their sincere sympathy in this hour of mutual bereavement.

OFFICIAL NOTICES.

Stops will be made for inspection at the plant of the Ford Motor Company, and the Eagle Ship Plant and Tractor Plant at River Rouge. In the evening the banquet will be held at the Hotel Statler. An invitation has been extended to General Leonard Wood, U. S. A., to be one of the speakers.

The Congress will be the guests of Detroit Chapter.

MINUTES OF EXECUTIVE COMMITTEE MEETING, JANUARY 31, 1919.

A meeting of the Executive Committee duly called by the President General was held at the rooms of the New Jersey Society in Newark, New Jersey, at 3 o'clock p. m. on January 31, 1919.

The following members of the Committee were present: The President General, Mr. Ames, of New York; Mr. Wentworth, of Iowa; Mr. Curtis, of Connecticut; Mr. Merrill, of New Jersey, and Judge Reifsnider, of Maryland. The President of the New Jersey Society, Mr. Carl M. Vail, and Vice-President General, T. W. Williams, of New Jersey, also were in attendance. Mr. William S. Parks, of the District of Columbia Society, acted as Secretary.

The minutes of the meeting of the Executive Committee on December 12-13, 1918, and published in the Official Bulletin for December, were approved as printed.

The President General announced formally the death of Secretary General and Registrar General A. Howard Clark on December 31, 1918, at his home in Washington after a brief illness. Past President General Wentworth and Judge Reifsnider of the Executive Committee presented a memorial on the death of Compatriot Clark, which after brief eulogies of his life and work, were adopted, ordered to be printed and a copy sent to the family of our late Secretary General. The memorial is published in another part of the Bulletin.)

The President General reported the appointment ad interim of William S. Parks, President of the District of Columbia Society, as Secretary General. His action was approved by the Committee, and on motion duly adopted President Vail of the New Jersey Society was directed to cast the unanimous vote of the Committee for Compatriot William S. Parks as Secretary General to fill the unexpired term of the late A. Howard Clark. Compatriot Teunis D. Huntting, of New York, Registrar of the Empire State Society, was duly elected Registrar General, for the unexpired term.

It was ordered that notices of these elections be sent to the several State Societies in due course.

A resolution relative to freeing Armenia from Turkish rule was presented and after some discussion, amended as to detail, adopted and copies ordered to be sent to the President of the United States, the Congress and officers of the National and State Societies. (See page 5.)

Judge J. M. Reifsnider, David L. Pierson and the Secretary General were appointed as a Special Committee to exploit the American's Creed.

Various matters of a routine character were presented and necessary action taken thereon.

A vote of thanks was tendered to the New Jersey Society for the use of their rooms, and at 4.50 o'clock p. m. the Committee adjourned.

SOCIAL FUNCTIONS INCIDENT TO THE MEETING OF THE EXECUTIVE COMMITTEE.

An informal luncheon given by the President General at one o'clock p. m. at the Hotel Robert Treat and the reception and dinner of the New Jersey Society in the evening in honor of the President General and Mrs. Ames, to which further reference is made, were the social features incident to the meeting of the Executive Committee.

ARMENIA.

Resolutions Adopted by the Executive Committee of the National Society of the Sons of the American Revolution, at Newark, New Jersey, January 31, 1919.

WHEREAS we, the Sons of the American Revolution, lineal descendants of men who by their service and sacrifice during the war of the American Revolution helped to achieve the independence of the American people, are pledged to maintain and extend the institutions of American freedom, the very foundations of which were threatened and imperiled during the world war; and

WHEREAS, regardless of centuries of frightful persecution, incessant attack, unspeakable atrocity, and horrible massacre, Armenia during the world war sacrificed a million of its population largely because of sympathy with the Allied Powers in their defense of Honor, Justice, and Liberty:

Be it Resolved by the Sons of the American Revolution, That we most earnestly request our Government and the Allied Powers to at once recognize the independence of Armenia as proclaimed by the Armenian National Representatives at Paris:

Be it Further Resolved, in response to the insistent desire expressed by the Armenian people, That we urge the United States, in co-operation with the Allied Powers, to guide them in establishing a republican form of government, aid them in their efforts to return the deported Armenians to their homes, and assist in organizing the great work of the reconstruction of Armenia.

Resolution Submitted by Senator King, of Utah, in the Senate of the United States, February 13, 1919.

WHEREAS the Armenian nation has for many centuries occupied certain regions in Asia Minor extending from Ararat to the Gulf of Alexandretta, including the southern littoral of the Black Sea in the region of Trebizond; and

WHEREAS the Armenian nation is the oldest nation inhabiting said region and has developed therein a national culture with a common language and religion; and

Copies of these resolutions have been sent to the President of the United States, all members of the United States Senate and House of Representatives.

State Societies and Local Chapters of the Sons of the American Revolution are asked to give these resolutions wide publicity through the columns of their own publications and local newspapers, etc.

WHEREAS the Armenians are capable of self-government, and their common interests and aspirations make proper the erection of a national Armenian government in said region: Now, therefore, be it

Resolved, That it is the sense of the Senate that Armenia be constituted a free and independent country and that the Armenian people be permitted to erect therein a free national republic for the maintenance of their national rights and the perpetuation of their native language, culture, and traditions.

LETTER FROM SENATOR SIMMONS OF NORTH CAROLINA.

AMENDMENTS TO THE CONSTITUTION.

The following amendment to the Constitution of the Society, proposed and recommended by the Maryland Society and the Empire State Society for action at the Thirtieth Annual Congress, is as follows:

Amend Section 4, Article V, of the Constitution of the National Society by adding a new paragraph to the section:

The members of the Executive Committee other than the President-General, shall be known as Directors-General, and by virtue of their office shall be members of the National Congress and entitled to vote at the annual meeting of the National Congress during their terms of office.

The Massachusetts Society, pursuant to the provisions of Article IX of the Constitution of the National Society of the Sons of the American Revolution, by action duly taken, recommends the amendment of Section 1 of Article III of the Constitution of the National Society of the Sons of the American Revolution by adding thereto after the words "Great Britain," the following words and figures:

"Provided, however, that any male person, above the age of 18 years and under the age of 21 years, whose qualifications in regard to ancestry and personal character are as above prescribed, shall be

eligible to a qualified membership to be known and designated as junior membership, said junior membership to permit to each junior member all privileges granted to full membership except those of holding office, of voting, of holding any interest in the property or funds of the Society or of any Chapter thereof, or of receiving a certificate of membership except as hereinafter provided, or of wearing any insignia of the Society other than the rosette; a special certificate may be issued to such junior member in such form as may be prescribed by the Board of Trustees: providing such junior member shall not be in arrears for dues, on attaining the age of twenty-one years he shall automatically be vested with full membership in the Society."

The Society requests that the proposed amendment be submitted for adoption at the next Annual Meeting of the National Society.

ADDITIONS TO MEMBERSHIP.

WASHINGTON'S BIRTHDAY.

The anniversary of the birth of George Washington was more generally observed than ever before. Particularly was this true in connection with the activities of the Sons of the American Revolution.

The most notable, perhaps, was that held at Memorial Continental Hall, the beautiful building of the National Society of the Daughters of the American Revolution in Washington, on the morning of the 22d of February, under the joint auspices of the National Society, Daughters of the American Revolution, the District of Columbia Society of the Sons of the American Revolution and the Sons of the Revolution in the District. The presiding officer was Past President General Elmer M. Wentworth, of the Sons of the American Revolution, and the principal address was delivered by David Jayne Hill, LL. D., a member of the District of Columbia

Society of the Sons of the American Revolution. In the large audience, which completely filled the hall, were Senators and Representatives in Congress, Cabinet officers and other high Government officials, representatives of foreign embassies and legations, Army and Navy and Marine officers and other representative guests. Music was furnished by the U. S. Marine Band, The National Quartette and the Quantico (Marines) Glee Club. Solos were rendered with stirring effect by Lieutenant Jean Labatt, of the French Military Mission, who sang "The Marseillaise," and Lieutenant Charles Trowbridge Tittmann, United States Army, who sang Julia Ward Howe's "The Battle Hymn of the Republic." Both of these young officers received ovations and were compelled to repeat the wonderful songs. The American's Creed was read by its author, Hon. W. Tyler Page, of the Maryland Society of the Sons of the American Revolution. Miss Grace Moore sang "Somewhere in France," and Miss Annie Jett, "In Flanders Field." As a matter of record the order of exercises of this remarkable celebration is published in full.

Doctor David Jayne Hill's address was a noteworthy one, delivered under unusually interesting circumstances. Space forbids more than brief extracts taken from the columns of the Washington Star:

Non-hostile criticism of the proposed League of Nations, in its present form as outlined, was made by David Jayne Hill, former United States ambassador to Germany and member of the permanent administrative council of The Hague, in an address this morning before a crowd that taxed the capacity of Memorial Continental Hall, where exercises were held in memory of Washington.

Mr. Hill declared that the league plan should be amended to meet American traditions before its operation is made permanent. He advocated a continuation for the defense of world law of justice of the entente, which has been formed to suppress German imperialism as an alternative to the proposed league.

WARNS OF COMPLICATIONS.

"I would not be understood as offering offensive criticism of the plan," Mr. Hill said. "There are many admirable features in it. * * * But in view of complications that I believe are certain to arise, I would wish to qualify our participation in any compact by precisely the words that were employed in accepting The Hague convention in 1899, and again in 1907."

Mr. Hill declared that George Washington "would regard with suspicion the establishment of an imperial syndicate to rule the world and alone to impose peace in its own way. But the proposal to subject the future course of American people to the decisions of European

nations, with an obligation to receive punishment if they were not accepted, in addition to taking a part in the quarrels and rivalries of these powers in Europe, Asia, Africa and Oceania, by becoming a judge and a divider over them"—that would fill him with alarm.

"At such an ill-chosen moment the demagogues of our own country are proposing a break with our past even in our own internal economy; some of them are urging upon us a complete reconstruction of our economic life by the public ownership of our great industries under a bureaucratic regime; some of them undermining by popular decrees our representative form of government and our judicial system; and all of them, in some form, repudiating our constitutional guarantees of personal rights and restrictions upon government usurpation and power.

MUST MAKE ANARCHY IMPOSSIBLE.

Mr. Hill said that "we must require the effective organization of the law-abiding members of society. We must render the red flag of anarchy impossible anywhere in America. We must instantly deport every alien who displays it, and intern every native who proclaims the principles of anarchy."

"The most dangerous enemy of our institutions is found in the silent, insidious, indirect assaults upon our fundamental laws," said Mr. Hill, "which, once abolished, would cause the demolition of the whole structure of our republic."

WASHINGTON'S BIRTHDAY IN FRANCE.

SONS OF AMERICAN REVOLUTION.

For many years the *Herald* has chronicled regularly the patriotic work in Paris of "The Sons of the American Revolution." Briefly stated, that work is to strengthen and develop the spirit of Americanism, that is, democracy, by fittingly commemorating great dates in American history, notably the birthday of Washington. Never, until the Sons of the American Revolution in Paris took up the matter, was this anniversary made the object of reverent observance, with a ceremony that always includes the placing of a wreath on Washington's impressive statue in the place d'Iena. The Sons of the American Revolution announce today that this annual homage to the Father of the American Commonwealth will be paid on February 22, at half-past 10 a. m., without pomp, red tape or, so far as concerns the Sons of American Revolution, speechmaking. It is essentially an informal democratic gathering, to which all Americans are invited. The monument in the

place d'Iéna was unveiled in 1900, by General Horace Porter, then American Ambassador to France, the deep significance of the ceremony being brought out in a great speech by the Consul General, Mr. John K. Gowdy. The Sons of the American Revolution has ever since made the monument the center of a patriotic demonstration on Washington's Birthday.—*Paris Edition, New York Herald, February 15, 1919.*

PATRIOTIC CEREMONY IS HELD AT PLACE D'IÉNA.

The ceremony at the Washington Monument was participated in by members of the American colony in Paris, the Red Cross, Y. M. C. A., and Sons of the American Revolution. The speakers were the American Ambassador, William G. Sharp; M. Jusserand, French Ambassador to the United States, and General Harts, American Military Commander in Paris. H. Cleveland Coxe, delegate of the Empire State Society, Sons of the American Revolution, which organization inaugurated this ceremony in 1900, was master of ceremonies.

The military band from the 303d United States Infantry, came marching down the Avenue d'Iéna, leading two companies of soldiers, one from the Marines stationed in Paris and another from a doughboy division.

Mr. Sharp, after being introduced and receiving hearty applause, opened his "one-minute speech." He said:

"For three years I have come to this monument to help celebrate the memory of Washington. I am pleased to see so many of you patriotic Americans here.

M. Jusserand was next, recalling how for sixteen years he had celebrated Washington in Washington, but now had the honor to celebrate in Paris.

General Harts spoke next. The day was one to be remembered, he said, when a patriotic American Society organized such important gatherings in Paris. It was a pleasure to be there, and he carried a message of approval from the Commander-in-Chief of the American Army.

The American Red Cross was represented by Captain Hendry and Captain Mayou, while the Y. M. C. A. was represented by Mr. Cass Conway, Mr. James Gordon Henry and Mr. A. G. Cavins. The Aero Club was represented by Mr. Sidney P. Veit. One of the most striking wreaths was that sent by the American Consulate-General and presented by the Consul-General himself, Mr. Alexander M. Thackara. Wreaths were presented, too, by General Harts, on behalf of the U. S. Army; by Admiral Long, who was accompanied by Lieutenant-Commander Mr. Cleurd, on behalf of the U. S. Navy.

Among those who took part in the ceremony was the President of the Polish Commission to the Peace Conference, M. François de Pulaski, a lineal descendant of Casimir de Pulaski, one of the combatants on the American side in the War of Independence. M. de Pulaski placed some beautiful flowers on the statue as a tribute from the Polish Commission and people. Also present were Corporal Howard Annin and Lieut. J. Henry Smythe.

TO STATE REGISTRARS.

The Registrar-General reports that some State Societies delay granting a member a demit to another State Society until the applica-

tion is acted upon by the Board of Managers. This often causes delay and is not in accordance with the Constitution of the National Society (Section 5, Article IV). It is obligatory that a State Society should grant a demit to a member, if he is good standing, and does not call for any action by the Board of Managers. The acceptance of a candidate, either by demit or application, is left to the State Society applied to, but the granting of a demit is not.

State Registrars are requested to see that references to authorities for proof of ancestors' service are given on the application papers in every case, and that references to papers on file in the archives of kindred societies cannot be accepted, as such papers are not accessible to the Registrars or Registrar-General.

In filling out applications State Registrars should insist upon the giving of the maiden names only of the female ancestors, and where they are of the same surname for both man and wife designate which descends from the previous generation.

NOTES.

Hon. William Tyler Page, of Friendship Heights, Maryland, the author of the American's Creed and a member of the Maryland Society of the Sons of the American Revolution, has been nominated for the position of Clerk of the House of Representatives of the 66th Congress. This office is second only in dignity to that of Speaker.

"AMERICANIZATION."

Senator Hoke Smith's "Americanization" bill was reported favorably to the Senate recently by Senator Smith from the Committee on Education and Labor. It proposes that the Federal Government aid in promoting the education of native illiterate persons unable to speak English, and other residents of foreign birth.

It also proposes to aid in educating the foreigners who come to this country in the fundamental principles of government and citizenship. The Federal Government is to act in co-operation with the State.

Senator Kenyon, of Iowa, directed attention to the fact that there are 8,000,000 people in this country who could not speak the English language. He said he believed that Senator Smith's bill was the most important measure before the Senate.

BILL MAKES AVAILABLE ARCHIVES BUILDING FUND

Senator Poindexter of Washington has offered an amendment to the sundry civil bill providing for the erection of a national archives

building in the District of Columbia. The authorization for the purchase of a site and for the erection of the building was carried in an act passed in 1913, but the appropriation for the site and building has never been made by Congress.

The Poindexter amendment proposes to make the money available, \$436,000 for the site and \$1,500,000 for the building.—*Star*, Feb. 27, 1919.

According to a paragraph in a recent issue of the *Genealogical Quarterly* the Revolutionary archives are stored in a garage in Washington.

Thirty-nine students, all of them naturalized within the past six months, were graduated from the School for Foreigners in Washington recently. Representative Mondell, of Wyoming, and Chief Justice McCoy of the District Supreme Court addressed the graduates. Each of the graduates made a short speech on "Why I Became an American." It was a very interesting occasion.

Compatriot George D. Christy, an officer in the command, presented to the State through the Society, the flag of the 1st Territorial Arizona Regiment of the Spanish-American War, for similar display.

The Connecticut Society were the guests of President Burgess at luncheon at the Union League Club, New Haven, on December 21. A business session followed. The President of the Society was authorized to appoint a memorial tree committee. A cordial invitation was extended the Society by President Sperry of the General Silliman Branch No. 3, to hold its annual dinner at the Hotel Stratfield, Bridgeport, on Saturday, February 22. Twenty-two Society grave-markers were reported as having been placed on the graves of Revolutionary soldiers in Old Lyme, Cornwall and New Britain. Fifteen new members were elected. On February 22, the twenty-ninth annual banquet of the Society was held in Bridgeport. There was a large attendance. Mayor Clifford B. Wilson extended the hospitality of the city to the members

and thanked them for the part they had taken in the nation's affairs. President General Ames was the guest of honor, and in a brief address outlined the part taken by the Society as a national body, during the great war. Prof. Smith Burnham of West Chester, Pa., spoke on "Washington, the Man." The following resolution was adopted unanimously:

Resolved, That we endorse the action of the Board of Managers in voting in favor of planting a memorial tree in memory of each of those who gave their lives for the freedom of humanity in the world war now ended and that we recommend that the plan be adopted by all the patriotic organizations of the United States and use our influence to have this plan universally adopted.

The District of Columbia Society held its customary Ladies' Night on January 15. There was a very large attendance and the Society was honored by the presence of President General Ames, Past President Reifsnider, of the Maryland Society, and Hon. W. Tyler Page, the author of the American's Creed. Mr. Ames made a short address and Mr. Page told the story of the Creed. Supper, followed by dancing, was an incident of a noteworthy gathering.

The annual meeting was held at noon on February 22, when officers were elected as follows: President, Hon. David Jayne Hill, 1745 Rhode Island Avenue; Vice-Presidents, Rear Admiral Theodore F. David Jayne Hill, the new President of the Society, who succeeds William S. Parks, Secretary General of the National Society, has had a very distinguished and successful career. He is well known as an author, educator, and diplomatist. He has been president of Bucknell and Rochester Universities; Minister to Switzerland and The Netherlands, and for three years (1908-1911) Ambassador to Germany. He is the author of a Life of Washington Irving, and also of a Life of William Cullen Bryant, and has written many essays and public addresses.

The March meeting of the Society on the 18th instant was addressed by Major General William Crozier, his subject being "Will the Proposed League of Nations Prevent War."

Empire State Society.—The New York Chapter held its mid-winter meeting at the Hotel Martinique, New York City, on Saturday, February 22, 1919. The speakers were President General Louis Annin Ames, Rev. S. Edward Young, who made a stirring address on "Theodore Roosevelt," and Lieutenant J. H. Donaldson, 28th Infantry, U. S. A., who fought at Cantigny, Soissons, Berzy-le-sec, and the second battle of the Marne. He had with him many souvenirs of the different battles in which he took part.

Dinner was served at 7 o'clock p. m., to a large number of compatriots and their ladies who were present.

The annual church services of the Chapter were held on Sunday, February 23, 1919, at the Fourth Presbyterian Church, West End Avenue and Ninety-first Street. The sermon was preached by the Chaplain of the Chapter, Rev. Charles L. Goodell, D. D.

NEWBURGH CHAPTER. At the January meeting of the Newburgh Chapter a movement was started for the erection in that city of a permanent memorial for the commemoration of all soldiers, sailors, and marines who have participated in the various wars this country has been engaged in, to be erected by popular subscription. The Idaho Society, at its annual meeting February 22, adopted the following resolutions:

Be it Resolved, By the Idaho Society, Sons of the American Revolution, that it is the sense of this Society that we are unalterably opposed to any action on the part of our Government, or any of its authorized representatives, which may result in this country yielding up or surrendering any of its rights, liberties, privileges, prerogatives, power or sovereignty, for which our forefathers pledged their lives, their property and their sacred honor, or which may in the least degree encroach upon or militate against the powers vested by the Constitution of the United States of America in the Senate, or in the latter body in conjunction with the House of Representatives in Congress assembled, or which may result to any extent whatever in a yielding up or abandonment of any of the principles of the Monroe Doctrine, which has stood, with the unanimous approval of American citizenship, as the first line of defense against encroachments upon those liberties and those principles of government so dear to us all and as an insuperable barrier against foreign aggression, colonization or influence, designed to undermine the integrity or the permanence of democracy in the Western Hemisphere.

And be it Further Resolved, That we do hereby petition the National Society of this organization, and each and all of our sister societies, and our Senators and Representatives in Congress, to use their good offices and their influence to the end that the Monroe Doctrine shall remain intact, unsullied and uncompromised, and further that the rights, liberties, privileges, prerogatives, power and sovereignty of this country shall remain unimpaired in any manner whatsoever.

The Illinois Society held its quarterly meeting on February 15 at the Morrison Hotel, Chicago, with an attendance of 180. The plan tried a year ago of having this meeting at the week-end on Saturday noon proved so satisfactory that it was repeated this year, and with members who do not find it convenient to attend evening meetings.

While the date was selected for a joint celebration of Washington and Lincoln's Birthdays, the emphasis this year was upon the service rendered by our armies in France. Three thrilling addresses were given by men who had recently returned from service to our men at the front: Rev. Dr. George Craig Stewart, of Evanston; Dr. A. J. Francis, of Chicago, and L. P. Putnam, Y. M. C. A. Secretary, Chicago. It was one of the most interesting meetings held by the Society in recent years.

The Board of Managers met the work before them and elected eight new members and adopted resolutions of appreciation of the life and work of the late Secretary General A. Howard Clark.

The Louisiana Society held its annual meeting at the St. Charles Hotel, New Orleans, Saturday, December 28, 1918. Officers were elected as follows: President, Colonel C. The Society is in a flourishing condition, largely due to the efforts of the President, who is untiring in his work for the Society.

The Maine Society held its annual meeting on February 22 at the Lafayette Hotel, Portland, with a large attendance of members. Past President Henry S. Burrage presented the matter of a more adequate tablet on the boulder which represents Maine on the field of Valley Forge. A resolution was adopted that at the proper time a more descriptive tablet should be placed on the boulder.

The matter of the League of Nations was presented in a more or less informal manner and there was a lively discussion. No action was

taken either for or against the resolution which is now being presented to many societies and organizations as well as to State legislatures.

The annual dinner was served in the hotel ball room at 6:30, with an attendance of 110 members and ladies, including a large number of members of the Daughters of the American Revolution. ciety, and a son of Lowell, who had been a lifelong friend of Dr. Parker, spoke in appreciation of his life and public service. Dr. Charles M. The Michigan Society continues its activities and is looking forward to the Annual Congress of the National Society in May at Detroit with interest and pleasure.

THE DETROIT CHAPTER met December 6, 1918, for a buffet luncheon at the University Club. Rev. Gaius Glenn Atkins, D. D., lately returned from service at the front with the Y. M. C. A., was the guest, and interestingly described his six months' experience with our boys in France. Secretary Raymond E. Van Syckle told of the participation of Compatriots Capt. Merrit U. Lamb and Sergeant John Lamb, of Rockford, in the battle north of Soissons in August, 1918. The former was killed in action on August 21, and the latter, when heavy shelling and machine-gun fire destroyed telephone communication, without orders and on his own initiative, repeatedly patrolled the line making repairs and re-establishing communication. He worked night and day without rest, remaining on duty after seeing the body of his brother,

and was finally forced to go to the hospital from complete exhaustion. "By his bravery and devotion to duty, he so distinguished himself, as to become the object of admiration of brother officers and soldiers," said General Pershing in the citation awarding him the distinguished service cross.

KENT CHAPTER, of Grand Rapids, held its December meeting on the third of that month at the home of Frank A. Stone, and was entertained by an address by Mr. Stone on the "Early History of Grand Rapids." January 11, 1919, at the home of Glendon A. Richards, Grand Rapids, Lee M. Marshal Foch is deeply moved by the terms of your telegram. The invitation which in the name of the Sons of the American Revolution you have been kind enough to extend to him has been especially pleasing to him; he will gladly remember it, if circumstances later on bring him to your beautiful country.

Please be the interpreter of my hearty thanks before your colleagues

of the Sons of the American Revolution, and accept, Mr. President, the assurances of my high regard.

to communicate with the Senate of the United States that it is the earnest request of this organization that the Senate ratify this covenant in order that the liability of future wars may be reduced to a minimum."

Gen. Albert J. Logan led the opposition to the resolution. He said the document did not reflect the sentiment of the American people, and much less that of the members of the Sons of the American Revolution. Col. John P. Penny, former assistant postmaster, George W. Gosser and others backed up General Logan's statement, while others thought it unwise for the association to put itself on record in the matter. No one spoke in favor of the resolution and it was laid on the table without opposition.

Maj. Samuel W. Jeffries spoke of the slight on the American flag by business men and others, especially as to the letting of flags on buildings "flap themselves to pieces in the winds" and allowing the flags to become dirty and faded. Colonel Penny said too many flags are displayed simultaneously by business concerns, thus making the National Emblem cheap and commonplace. He said the American flag should not be used to decorate walls or stands, and that when it is so used it is often placed up-side-down. The matter was referred to the committee on flags, with authority to send cards of instruction as to the proper use of the American flag to all persons violating the flag regulations.

Memorial resolutions were adopted on the deaths of Frank G. Paulson, Rev. Robert B. Miller, for several years chaplain of the association; Congressman E. E. Robbins of Greensburg, and A. Howard Clark of Washington, D. C., for many years Secretary General of the National Society, Sons of the American Revolution.

McCormick, and Gen. A. J. Logan, all of Pittsburgh, board of managers.

The annual dinner of the Society was held on the evening of February 22. It was presided over by Dr. McCormick, the retiring president. The principal speakers were Judge Bonniwell and Congressman Frederic C. Hicks of New York. Officers of the Pittsburgh
