## OFFICIAL NOTICES.

This issue of the BULLETIN has been unavoidably hurried in preparation by reason of the recent change in officials at the Annual Congress of the National Society held at Detroit, Mich., and the very short time available for the preparation of material for the printers. On this account errors of commission or omission may have occurred.

The National Society property and records of various kinds have for many years been kept in rooms at the Smithsonian Institution, of which our former Secretary General, Mr. A. Howard Clark, was an official. Since his death the Society has been permitted to continue the use of the space so occupied, until recently it was found necessary by the Smithsonian Institution to require this space for its own use. The National Society of the Sons of the American Revolution is under many obligations to the officials of the Smithsonian Institution (some of whom are members of the local District of Columbia Society) for their kindness and considerate treatment of the representatives of our organization at all times, and this public acknowledgement, therefore, is cordially extended to them.

The Secretary General and Registrar General, with the concurrence of the Executive Committee of the National Society, has established headquarters in the National Union Building, No. 918 F Street Northwest, Washington, D. C., and it is hoped to complete the necessary equipment and installation of the property, records, etc., of the Society during the month of June. Until everything is in complete working order it is hoped that the members of the Society will be as indulgent as possible should any delays or errors occur in the transaction of the heavily increasing business of the organization.

President General Jenks has planned a series of visits to numerous State and local Societies, starting on his first trip from Chicago, June 12. He expects to visit Toledo, Cleveland, Buffalo, Rochester, Syracuse, Springfield, Mass., Boston, and Concord, N. H. His visits will no doubt be highly appreciated by the compatriots of those cities, and produce increased interest in the organization.

# ABSTRACT OF THE PROCEEDINGS OF THE ANNUAL CONGRESS OF 1919.

On the invitation of the Detroit Chapter, the Thirtieth Annual Congress of the National Society was held at Detroit, Michigan, on May 19 and 20, 1919. There was an attendance of nine General Officers, four Past Presidents-General, and one hundred and fifty-five delegates, representing twenty-three State Societies.

The opening exercises included a prayer by the Chaplain General, the presentation of the Colors, the Pledge to the Flag, and an address of welcome on behalf of the Governor of Michigan and the Mayor of Detroit by the Corporation Counsel, to which President General Ames made fitting response. General Charles A. Coolidge, President of the Michigan Society, welcomed the Congress on behalf of the State Society.

The President General's report reviewed the activities of the National Society and the State Societies and Chapters as he had observed them during his term of office, referring particularly to the war service of compatriots who had made the supreme sacrifice, and to the work in every line of patriotic endeavor that had been carried on by the Sons of the American Revolution. He paid fitting tribute to our late Secretary General, A. Howard Clark, and to the memory of Compatriot Theodore Roosevelt, a member of the Empire State Society at the time of his death (January 6, 1919). He referred also to the progress of the Society in the increase in membership and to the advancement and development of its patriotic work.

The reports of the Secretary General, Registrar General, Treasurer-General, and Historian General were presented, read, and ordered filed for publication in the Year Book. Reports of committees also were received, and after having been read were ordered to be printed in the proceedings of the Society.

The amendments to the Constitution, relative to junior membership in the Society and to the duties and designations of the members of the Executive Committee, were adopted. (These amendments were printed in full in the March BULLETIN, pp. 6-7.)

The Board of Trustees amended the By-Laws as follows:

Amend article XV, section 1, first paragraph, by striking out the words following after "at the collar" and inserting in place thereof, "if an active or past Officer General of the National Society or President, active or past of a State Society." Then add to section 1, paragraph two, "Past Presidents General and Vice-Presidents General in full

dress shall wear a sash of the Society colors, three and one-half inches wide, extending from the right shoulder to the left hip."

The Registrar General reported 1,220 new members enrolled during the year, an average of more than 100 a month, and the largest, with one exception, since the organization of the National Society.

The Treasurer General reported the balance May 15, 1918, as \$7,931.83, and the total receipts of the year \$9,782.91. The disbursements during the year were \$8,932.91, and the net balance May 15, 1919, \$8,781.83.

The Permanent Fund of the Society now amounts to \$13,609.58.

The Historian General (Lieut. Arnold) in his report gave a brief history of the early days of Detroit, paid a tribute to the memory of our late Secretary General-Registrar General Clark, including a sketch of his career, and in conclusion presented interesting notes as to the mints and coinage of the Government of the United States.

The reports of committees were as follows:

On Americanization and Aliens, by the chairman, Compatriot Chancellor L. Jenks.

On the Flag, by the chairman, Compatriot William Van Zandt Cox.

On Patriotic Education, by the chairman, Compatriot J. Milton Reifsnider.

On War Service, by the chairman, Compatriot Carl Montaigne Vail.

On Increased Membership, by the chairman, Compatriot Lewis Beers Curtis.

On the Washington Guard, by Compatriot John Lenord Merrill, Governor General.

A verbal report from the Memorial Committee was made by the chairman, Past President General R. C. Ballard Thruston.

Reports were submitted also by the Committee on Publicity, Compatriot Pierson, chairman; the Committee on Increased Membership, Colonel Churchill, chairman, and from several State Societies. Space forbids a detailed reference to them in this summary.

The following resolutions were unanimously adopted:

*Be it Resolved*, That the Congress of the Sons of the American Revolution records its appreciation of and extends its thanks to the Governor of the State of Michigan and the Mayor of the City of Detroit, represented by the Corporation Counsel, for the cordial welcome extended to the delegates and visiting women of the Congress:

To the Michigan State Society and the Detroit Chapter, Sons of the American Revolution, for their labors in behalf of and hospitality to the Congress assembled in this city.

To the Louisa St. Clair Chapter, Daughters of the American Revolu-

lution, for the delightful luncheon, entertainment, and hospitality extended to the delegates and visiting women:

To Senator and Mrs. Truman H. Newberry, for their cordial invitation to the reception for the delegates and visiting women, although the necessary attendance of Senator Newberry at the extra session of Congress required the cancellation of plans for their reception:

To Major and Mrs. Frederick M. Alger, for the reception for the delegates and visiting women at their home "By Way," Grosse Pointe Village.

*Resolved*, That the thanks of the National Society be and they are hereby tendered to President General Ames for the banners presented at this Congress to the seven State Societies, viz: Louisiana, Oklahoma, Missouri, Arkansas, Idaho, Wisconsin, and Utah, whose membership has been increased during the past year twenty or more per cent; and the following:

WHEREAS, Compatriot *La Verne Noyes*, a former President of the Illinois Society of the Sons of the American Revolution, and Past Vice-President General of the National Society, has by a gift of three and one-half million dollars (\$3,500,000.00) to the University of Chicago, established an educational fund for the benefit of the soldiers and sailors of the great world war; Therefore be it

*Resolved by the National Society of the Sons of the American Revolution in Congress Assembled*, That the thanks and congratulations of our entire membership are hereby tendered to Compatriot Noyes for his generous and patriotic action, and that a certified copy of this resolution be sent to him by the Secretary General.

The following telegram, to which a suitable reply was made, was received from Mrs. Sarah E. Guernsey, President General of the National Society of the Daughters of the American Revolution:

Election of Officers and Trustees concluded the business of the Congress. General Officers were unanimously chosen, as printed on a preceding page.

Social functions in connection with the Congress, included a luncheon at the Hotel Statler, on Monday, May 19, given to the delegates and the ladies by Louisa St. Clair Chapter of the Daughters of the Ameri-

can Revolution; a reception on Monday evening at the residence of Major and Mrs. Frederick M. Alger, at Grosse Pointe, automobile rides and visits to industrial plants and other places of interest Tuesday afternoon, and a banquet on Tuesday evening at the Hotel Statler in honor of the delegates to the Congress and the ladies accompanying them, when addresses were made by the President General, the President General-elect, and other distinguished guests, including Rear Admiral Frederick B. Bassett, U. S. N., Commandant Great Lakes Training Station; Major-General William G. Haan, U. S. A., Commanding General, 32nd Division, A. E. F.; Past Presidents General Nelson A. McClary, R. C. Ballard Thurston, Newell B. Woodworth, and Elmer M. Wentworth.

Religious and patriotic services were held in the First Presbyterian Church on Sunday evening, May 18. The delegates of the Congress, accompanied by ladies, marched to the church from the Hotel Statler, escorted by the reception committee of the Detroit Chapter and a band of music. The sermon was preached by Rev. Lee S. McColleston, D. D., Dean of Tufts College, Massachusetts, and Chaplain General of the National Society of the Sons of the American Revolution.

#### MINUTES OF MEETING OF EXECUTIVE COMMITTEE, NATIONAL SOCIETY SONS OF THE AMERICAN REVOLUTION, HELD MAY 17, 1919, AT TOLEDO, OHIO.

A meeting of the Executive Committee of the National Society Sons of the American Revolution, duly called by the President General, was held at the Toledo Club, Toledo, Ohio, at 11.00 A. M., May 17, 1919.

In addition to President General Ames, those present were Past President General Wentworth, of Iowa; Mr. Jenks, of Illinois; Mr. Curtis, of Connecticut; Mr. Pomeroy, of Ohio; Judge Reifsnider, of Maryland, and Secretary General Parks; Mr. Merrill, of New Jersey, being detained at home by important business.

The minutes of the last meeting of the Executive Committee, held January 31, at Newark, New Jersey, were not read, but approved as printed in the March BULLETIN.

The committee recommended the adoption of the proposed amendment to the Constitution offered by the Massachusetts Society relative to Junior membership. The other amendment, making the members of the Executive Committee members of the Congress and giving them the title of Directors General, was referred to the Trustees of the National Society, S. A. R.

The Executive Committee recommended to the Trustees the adoption of the proposed amendment to article 15, section 1 of the By-Laws, which was submitted in writing by Compatriot John Leonard Merrill:

"Amend article 15, section 1, first paragraph, by striking out the words following after 'at the collar,' and inserting in lieu thereof: 'if an Active or Past Officer-General of the National Society or President, active or past, of a State Society,' and add to section 1, paragraph two: 'Past Presidents General and Vice-Presidents General in full dress shall wear a sash of Society colors, three and one-half inches wide, extending from the right shoulder to the left hip.'"

President General Ames reported as to the observance of Constitution Day, September 17, 1918; also upon the proposed joint celebration in September next in conjunction with other patriotic societies.

On motion of Compatriot Chancellor L. Jenks, the following resolution was adopted:

"That Louis Annin Ames be appointed as special representative of the National Society, sons of the American Revolution, to serve in conjunction with representatives of other patriotic societies, in outlining a joint celebration, September 17 next, under the auspices of the National Security League and other associated organizations.

A unanimous vote of thanks was tendered Compatriot Pomeroy, of Toledo, for his hospitality in entertaining the members of the Executive Committee at the Toledo Club during their sojourn at Toledo. The committee then adjourned.

*Social Functions incident to the meeting of the Executive Committee:*

A luncheon was given to the Executive Committee by Mr. Pomeroy at the Toledo Club, followed in the evening by a banquet, covers being laid for fourteen.

Mr. Pomeroy entertained all of the Executive Committee as his guests at the Toledo Club, and on Sunday morning the trip from Toledo to Detroit was made in motor cars.

MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES  
MAY 20, 1919.

A meeting of the Board of Trustees was held at the Hotel Statler, Detroit, Mich., on call of the President General immediately after the adjournment of Congress at 12:30 P. M., May 20, 1919.

On motion of Mr. Ames the recommendation of the Executive Committee for the amendment of article 15, section 1 of the By-Laws, relative to the wearing of the insignia of the Society, was approved.

On motion, the Executive Committee was authorized to transact all necessary business matters of the National Society in the interim between this date and the next meeting of the National Congress.

The meeting of the Trustees then adjourned.

MINUTES OF MEETING OF THE EXECUTIVE COMMITTEE  
MAY 21, 1919.

A meeting of the Executive Committee duly called by the President General was held at Detroit, Mich., May 21, 1919.

Present: President General Jenks, Mr. Wentworth, Mr. Reifsnider, Mr. Henry, Mr. Pomeroy, Mr. Curtis, and Mr. Ames.

On motion of Mr. Wentworth, which was adopted, appropriations were voted for carrying on the affairs of the Society during the year, including the payment of the usual salaries to the Secretary General and Registrar General, and such necessary office expenses, including clerical assistance, as during the past year. It was also voted to include in the motion authority for payment of the Secretary General's expenses at the annual meeting at Detroit and the traveling expenses of the Treasurer General. Also for traveling expenses of the Secretary General in his attendance at the annual Congress and meetings of the Executive Committee and Trustees, and for traveling expenses of the Treasurer General in attendance at the annual Congress.

It was ordered that the National Year Book of 1919 be published in a limited edition, free distribution being made only to the General



Officers, Executive Committee, Trustees, one copy to each chapter, two copies to each State Society, one to each delegate at Detroit, and to the usual list of libraries. Such additional copies as may be available may be sold at cost price. Such amount as may be necessary was voted for printing and distributing the Year Book.

The President General was authorized, at any time when he shall so desire, to submit by mail or telegraph any matter requiring the action of the Executive Committee to the several members thereof, and that any vote so taken by mail or telegraph shall have the same force and effect as if the Executive Committee had been convened in special session and action taken at such specially called meeting.

Mr. Curtis moved the appointment of a committee to report at the next meeting of the Executive Committee on the question of canvassing for new members of the Society. Motion adopted. The President General appointed Messrs. Curtis, Ames, and Pomeroy as this committee, with instructions to report at the next meeting.

The matter of securing and equipping headquarters for the Secretary General and Registrar General at Washington, D. C., was, on motion, referred to the President-General and to the Secretary General, with full power to act.

No further business appearing the meeting adjourned.

#### EVENTS IN THE STATE SOCIETIES.

The **California Society** reports that during the year ending March 31, 1919, the board of managers held ten meetings. This Society usually holds a meeting on the 4th of July, at the base of the Washington Monument, jointly with the Sons of the Revolution, but this year the usual exercises have been waived in view of a general celebration by the people of the city of Washington to be held on that date in the Monument grounds.

The **District of Columbia Society** held its usual meetings during the year, numbering six, one each month, from November to April. These meetings include in the exercises the regular business of the organization and addresses usually by a well-known public speaker, music, and closing with a substantial and attractive buffet luncheon. The January meeting is of a special character and is known as the "Ladies' meeting," when the lady friends and relatives of members are invited. All business affairs of the organization are dispensed with at this meeting. In addition to addresses and music and the supper, those in attendance, usually numbering several hundred, close the evening with a dance.

The meeting on February 22d is devoted to the annual election, commencing at noon, with reading of the records of the officers, a luncheon, smoker, and a good time generally for the members. Annual dues of the Society, \$4.

This law is designed to promote patriotism by displaying the American Flag at polling places during election and provides that the flag shall be displayed at each polling place at each election, there to serve as a symbol of that responsible liberty which finds expression in the suffrage of a free people, and as an inspiring challenge to the youth of America and foreign-born citizens alike, who in its presence, execute the serious duties of citizenship.

The Maine Society may well feel proud in securing the instant and unanimous approval of every measure presented by it to the State Legislature for many years past. The Society in Maine is making an extensive drive to double its membership during the year and its example might be followed very generally by others.

The Maryland Society held its annual meeting on April 19th, at which were presented the annual reports of the officers and committees of their year's work, followed by the election of officers for the coming year. The Society enjoyed very pleasant addresses from Mr. Geo. W. Ward and Wm. Henry Owen.

The silver anniversary of George Washington Chapter was celebrated at Springfield, on April 11. The Society listened to interesting

accounts of the original formation of the chapter and other early events in that section. It was stated at the meeting that Robert Newman, of Boston, was the man who hung the signal lanterns for Paul Revere the night of his famous ride.

Compatriot David L. Pierson, chairman of the Publicity Committee of the National Society, has issued a circular by direction of the President General, in which the committee urgently calls attention to the forthcoming anniversary of the adoption of the Federal Constitution on September 17 next. Various organizations, both State and Chapter, are urged to take steps immediately to bring about a nationwide observance of the day which marked the beginning of our Government and its high place in the parliaments of the world. The circular also advises that churches, colleges, schools, civil and patriotic organizations of every kind should be invited in each State and community to cooperate with our organization.

The Empire State Society continues to show its activity. The regular meeting of the Society was held on April 19, in New York City, at the Hotel Pennsylvania, as the guests of the New York Chapter. At the meeting reports of the various officers and committees were presented and the annual election of officers held. The meeting also listened to an illustrated lecture entitled "On the Battle Line of the Telephone," given by Mr. H. J. Carroll, Manager of the New York Telephone Co. Lecture Bureau. At this meeting, also, compatriot John W. Vroonman, chairman of the Patriotic Legislation Committee, submitted a very interesting report.

The Colonel Cornelius Van Dyck Chapter held a special meeting on April 19, at the Schenectady County Historical Society, at which Mr. Robert Sewart Ross, recently Y. M. C. A. Secretary in France, spoke of his experiences with the American Expeditionary Force.

We note that a special meeting of the Empire State Society has been called to convene at the City Hall, New York City, on June 14, for the purpose of presenting medals to the members of that Society who have been in the service of the United States, either in the Army or Navy, during the great war.

We are pleased to see that our former President General, Compatriot Lewis Annin Ames, continues his activities and is having an active part in this meeting as its presiding officer. The Oregon Society, as we learn from the newspapers, is purchasing silk flags, to be used in the Naturalization courts in Oregon, and they have been presented by that Society to the Bureau of Naturalization of the Department of Labor for distribution in the courts where naturalization proceedings are held. In the United States District Court for the State of Oregon, at Portland, the flag is draped around the bench during the hearing of the application, and in another court the Judge arranges that the prospective citizen shall stand holding the flag in his left hand, while raising the right to take the oath of allegiance to the United States.

In Pennsylvania the rector and officers of the Washington Memorial Chapter at Valley Forge on May 20, 1919, conducted the service of dedication of the Bay in the Cloister of the Colonies, given by Mr. A. E. Pearson in honor of the men of New Hampshire.

Mr. Eugene C. Bonniwell, Judge of the Municipal Court in Philadelphia, has published a very interesting booklet on the subject "American Citizenship," which covers an explanation of citizenship and its advantages, with a description of the proceedings of naturalization, etc.
