SECRETARY COL David Edward Thompson Condensed Minutes of the 2020 Spring Leadership Meeting

Chairman Niemann thanked former Vice-Chairman V. McMurry for his work spanning five years of processing the Certificates of Patriotism and keeping the database accurate. Chairman Niemann introduced Vice-Chairman Pettett and thanked him for his efforts in taking over this role full-time, effective February 1, 2020.

Vice-Chairman Pettett updated the VRC on the review and processing steps. On average, between 30-50 Certificates of Patriotism are processed each month. Vice-Chairman Pettett reviews and processes the Certificates during the course of each month; at the end of the month he forwards these Certificates to Headquarters. Headquarters then distributes the Certificates to the appropriate State Societies and Chapters for presentation to the Compatriots. It takes about six weeks to get through the process.

Vice-Chairman Pettett stated that the application and processing steps are the same. Compatriots still do the application form from the website (PDF-format on the instruction sheet); submit the form to <u>VetCorps@SAR.org</u>; then the form ends up in Vice-Chairman Pettett's mailbox. The forms are batched into PDF files, saved, and at the end of the month put on Share File. This enables retrieval, if necessary, of documentation at a later date. Vice-Chairman Pettett asked that the VRC members relay the processing steps to their respective State Society and Chapter points-of-contact. He further emphasized that he is here to serve the Committee, and is open to feedback and phone calls if there are questions or concerns regarding the Certificates. Chairman Niemann added that all of the Certificates are customized. There are currently 85 templates in use to customize each Certificate for the Compatriot's specific service.

Chairman Niemann received a number of inquiries from compatriots regarding the status of their Certificates of Patriotism. After checking the VRC records, it was noted that the certificates were completed and mailed to the State Secretaries in the previous 3 - 6 months. Chairman Niemann requested that VRC members stress to their State and Chapter officers the importance of honoring the veterans in a timely manner.

Chairman Niemann provided the attendees with an overview of the Republic of Korea Ambassador for Peace Medal. He explained that to be eligible, the veterans must have served during the Korean War from June 25, 1950 to July 27, 1953. It is also available for the veterans who have participated in UN peacekeeping operations until the end of 1955. To receive the medal the veteran must complete an application, attach his DD214 and send it to any Korean Consulate.

World War I Veterans Corps

World War One was one of the deadliest wars in history that resulted in over 9,000,000 combatant deaths. The United States entered WWI on April 6, 1917 when President Woodrow Wilson declared war on Germany and joined the Allied Powers of France, England, Italy, Russia, Romania and Japan who had been fighting the Central Powers (Germany, Austria-Hungary, Ottoman Empire and Bulgaria) since 1914. It was the entry of the United States that turned the tide of war into victory for the Allied Powers. The war ended with the surrender of Germany on November 11, 1918.

There were 2.8 million American forces that served in the campaign theater during World War I. Casualties for the American Expeditionary Force were 53,402 killed in action and 205,000 wounded. Another 63,000 soldiers died of disease and other causes during "The Great War" that was supposed to end all wars. The leader of the American Expeditionary Force was General of the Armies John "Black Jack" Pershing a member of the Pennsylvania Society, Sons of the American Revolution.



World War I Victory Medal

Based on an approved Memorial Membership a SAR Veteran that has received the World War I Victory Medal is automatically eligible to be a member of the NSSAR Veterans Committee World War I Veterans Corps. The sponsor of the Compatriot's Memorial Membership will need to complete the NSSAR Veterans Multi-Corps Recognition Form and Proof of Service.
