Editorial Review: This "primer," written as if addressed to a new trustee for a university, is a comprehensive discussion of investment issues relevant not only to investment trustees but also to investment professionals who work with trustees. Taking an individual step-by-step through the process of responsible trusteeship, it offers a solid introduction to basic investment principles. It is long, but it is organized in chapters where useful knowledge can "scanned" to one's interest level.
