Note #1: When using a lineage which has already been accepted by the SAR or DAR a record copy of the referenced SAR or DAR application must be provided with the documentation and all dues and fees shown above.

Note #2: Establishing a new lineage or patriot ancestor – if you are applying as a junior member and the ancestor you are applying under has not been documented or approved through the SAR, DAR or CAR in the past the application cost is shown above.

Note #3: Applications of family members must be submitted at the same time, follow the same lineage to the same patriot ancestor and be within two generations of one another (grandfather to grandson, uncle to nephew, etc.).

Note #4: The applicant must provide his birth certificate, a copy of his C.A.R. Member of Good Standing card and a "record copy" of his C.A.R. approved membership application form.

Note #5: The Memorial Dues/Fees have been changed to reflect the same amount as “Regular” Dues & Fee.

Printed Copy USPS Subscriptions

1. Chapters collect the CASSAR authorized **annual subscription fees** and remit them to the CASSAR Treasurer, along with a listing of the Paid Subscribers including their USPS mailing addresses. This is entirely independent of the annual reconciliation process.
2. The CASSAR Treasurer provides a compiled Paid Subscribers List to the Editor of the California Compatriot.
3. Compatriots who do not pay annual subscription fees are removed from the list on January 1, each year.
4. The California Compatriot Editor uses the Treasurer's Paid Subscribers List for printing and mailing each Edition.
5. The Treasurer updates the Paid Subscribers throughout the year and informs the Editor.

Cybercrime Alert

"I need you to process a payment today..."

"Do you have a few minutes to mail a check today..."

"I need you to get a couple of gift cards for me today..."

"Are you available to complete a bank transfer today..."

"I need you to make a payment of \$4,859 today..."

"Can you process a transfer of \$8,850 today..."

If you receive an email addressing you by name from another officer or individual in your chapter, you may be the target of a cybercrime. Chapter Treasurers and those with access to your Chapter accounts, may receive emails requesting the expenditure of chapter funds.

Beware! Always be on the lookout for scams, especially those requesting disbursement of Chapter funds.

Don't be naïve. Use your head. Validate all such requests before taking the requested action.

Do not reply to the email you received or call the number provided in the email.

Instead, call your President, VP, Secretary or Registrar directly or send them an email using their known telephone number or email address. Ask them directly if they made the request.

Implement a two-party authorization process in place for payment. CASSAR uses a check request form downloadable from the CASSAR website. Chapters may not need a form, although from a legal and record perspective it's not a bad idea.

Have a process and procedures in place with a clear understanding by all officers to make sure Chapter expenditures are legitimate.



Arthur M. & Berdena King Eagle Scout Award – 2019 Temporary Transition Rules Extension

As of February 1, 2019 Boy Scouts of America has revised their membership rules to allow females to become scouts. With the inclusion of female scouts they have revised their primary name to “Scouts BSA”. This revision will allow females to advance to the Eagle Scout Rank. To provide a transition period for those that joined on February 1st to be able to achieve the rank of Eagle Scout, Scouts BSA has made a “Temporary Transition Rules Extension”. The NASSAR Eagle Scout Committee has adopted this extension and it can be found on the NAS-SAR web site at this link:

Here is the key wording of the extension”

“Temporary Transition Rules Extension – Any youth who registered as a member of Scouts BSA between February 1, 2019, and December 1, 2019 and was granted an extension by the National Council BSA to complete the Eagle Scout rank requirements after they have turned 18 years of age, will have 365 days from the date their Eagle Scout application was validated by the National Advancement Program Team to enter the contest.”

A copy of the approved extension must be attached to the contest application.

This should clarify for your Chapter competition that in the future you will possibly have both male and female applicants. If you have any questions please contact Bill Nay, Chair of the California Society Eagle Scout Committee.

From the Desk of the CASSAR Registrar

As of today California has begun to process over 200 applications with approximately 150 of them approved. A recent change to the processing was National needing us to ensure that the applications do not have partial generation at the bottom of the page. I forwarded a tutorial to all chapters.

I did note however, that one needs to be using Google Chrome to be able to finesse the application as requested. It does work! I have been able to rework a few apps that did not meet this standard, but in the future will be returning them to the chapters to be redone.

On another note I am still seeing too many ancestry.com pages that are being attempted to be used as proofs. Whenever possible I have gone online and tried to locate the actual document. Ancestry.com has a “search” item on the task bar which often I have then located the document and included it with the application. There also have been too many documents included that need to be enlarged (cropped) to be only the page needed.

I would also ask that Chapter Registrars review the App Prep Manual and the Genealogy Policies. Too many apps are being forwarded that are including family histories that do not meet the requirements.

We are, in my mind doing good but we can always strive to do better.

General George Washington Chapter

Butte County Camp Fire Hero Recognition

January 20, 2019

The General George Washington Chapter recognized the Butte County Sheriff's Department, five firefighters and four paramedics on January 20 by presenting them each with the SAR Hero Medal. The Camp Fire was the deadliest and most destructive wildfire in California history. It is also the deadliest wildfire in the United States since the Cloquet fire in 1918 and is high on the list of the world's deadliest wildfires; it is the sixth-deadliest U.S. wildfire overall. It was one of the world's costliest natural disasters in 2018.

Named after Camp Creek Road, its place of origin, the fire started on November 8, 2018, in Butte County, Northern California. The fire caused at least 86 civilian fatalities, with two people still missing, and injured 12 civilians, two prison inmate firefighters, and three other firefighters. It covered an area of 153,336 acres (62,053 ha) (almost 240 sq. miles), and destroyed 18,804 structures, with most of the damage occurring within the first four hours. Total damage was \$16.5 billion; one-quarter of the damage, \$4 billion, was not insured. With the arrival of the first winter rainstorm of the season, the fire reached 100 percent containment after seventeen days on November 25, 2018.

Due to the rapid, brave and continued decisive actions these nine individuals along with the Butte County Sheriffs Department were undoubtedly instrumental in saving lives and evacuation of multitudes of people without regard to their own safety.

In July, the chapter marched, with the Orange County Chapter, in the Huntington Beach 4th of the July Parade. At the 129th National Congress in July, many Harbor Chapter members volunteered to assist the Orange County Chapter with registration at the event.

In addition to these activities, chapter members attended 4 local DAR events and presented SAR awards at many JROTC ceremonies throughout Southern California. Please join us on the 1st Thursday of each month for chapter meetings at Alpine Village in Torrance.



Mother Lode Chapter

Authenticate a family heirloom ... The “*Goff Marine Flag*”
Bob Conover, Mother Lode Chapter, needs your help. For several years he has tried on his own to authenticate the origin of the family Heirloom, the “*Goff Marine Flag*”. Bob’s Patriot is Hezekiah Goff.

The Conover family story is that this flag, passed down through generations, once belonged to their ancestor Hezekiah Goff. He was a marine aboard the *Oliver Cromwell* in 1778 out of Connecticut; he also later served in the Massachusetts Continental Line, and even served in the War of 1812. The flag came from somewhere. The family have called it the ‘*Goff Marine Flag*’ because one story has it that when the *Oliver Cromwell* capture a “prize” at sea (such as the *Admiral Keppel* and the *Cyrus*) they sent it back to port under an American flag – and this was one of those flags.”

George Washington was the first to bring the war to British shipping when he authorized seven "Cruisers" to capture British supply ships. Individual states built small navies to protect their coasts and to harass their British tormentors. Connecticut's navy of 10 ships, including the 20 gun *Oliver Cromwell*, built in Essex on the Connecticut River, was moderately successful. *Oliver Cromwell* was ordered to be built in January 31, 1776.

Unlike many veterans who served at that time, his unit was virtually unknown by most people until now.

Petty Officer Ely's wartime service was as a part of a unit which was unique in the Vietnam War and in the history of the US Navy. Helicopter Attack Light Squadron – HA(L) 3 – also known as the Seawolves, was an all-volunteer squadron which drew approximately 2600 members who served from 1967 to 1972.

Admiral Elmo Zumwalt established the Seawolves as part of his trident approach to combat – SEAL's, Seawolves, and PBR's. Its primary mission was to provide close helicopter air support to all riverine craft in the Viet Nam theater. A role which Army helicopter units were not equipped to support. The Squadron flew day and night, in good weather and bad and were airborne in less than three minutes of a call.

HA(L) 3 is the only unit in Navy History to have been Established and Dis-Established outside of the United States. It, therefore, has no homeport. Until recently, many Viet Nam era veterans did not believe the unit existed and therefore did not recognize the unit's work.

"Scramble the Seawolves" is an outstanding documentary that brings the dedication and sacrifice of Compatriot Ely and other members of HA(L) 3 to light. See: <https://video.kpbs.org/video/scramble-the-seawolves-yacuzzi/> Most impressively, to this day, it is the most decorated unit in Naval Aviation history with over 17,000 personal and unit awards.

FRIDAY

Treasurer General David Wright discussed the upgrade of the accounting software. The procedures for opening mail and depositing checks to the SAR and the SAR Foundation were discussed because a complaint had been voiced about the time it took for a donation check to be deposited. The proposed Constitution and Bylaw amendments for Congress were discussed. PG Mike Tomme reported on the progress with Mission Data, which finished the Member Database and was now working on the Website. Don Shaw reported that RFPs for the SAR History book are still being collected.

Lee Popham gave an update on the budget and spending to date. Don Shaw reported that a genealogist had resigned, and he had already hired a replacement. Bill Stone described the video made by SolidLight about the progress on the plans for the SAR Education Center and Museum. PG Alter reported that 58% of members had replied to the PCI inquiries for the Member directory to be published, which resulted in the correction of many member emails and addresses we had on file. The member directory books should be received by the end of the year. PG Alter had asked all Executive Committee members to review the five application forms currently allowed for new member applications. After discussion, the Executive Committee voted to direct the Genealogy Committee to move to only one accepted application form – the online form which captures the data.

Kent Gregory reported that the Museum Board had chosen Cowan's Auctions to sell over four hundred deaccessioned items by online auction. He also reported that three artifacts were being donated during Congress, and that six other artifacts are being purchased by members to be donated at Fall Leadership. The Insurance Committee made a recommendation for purchasing liability insurance for all states at the national level and charging the state societies the prorated costs. The Executive Committee sent the proposal back to the committee because there are no insurance companies that sell insurance in all 50 states. An issue with the legal agreement with Hillsdale College for the America's Founding Documents Program was discussed and sent back to the Education Committee for a recommendation from the entire committee. PG Alter pointed out that money was spent on a pilot test of the program, but the results have not been reported back to the trustees.

The Ladies Auxiliary set up their hospitality room in Balboa Bay I & II. The hospitality room was run by Janet Brown, Karen Dodd, Lacy Dodd, Brenda Torres, JoAnn Kramer, Karen Faulkinbury, Mary Hinshaw, Gail Raser, Gloria Noell, Liz Ferris, Lisa Gregory, Mary Lucas, Dianne Stephens, and Karen McKelvie

Janet Brown, Karen Carlson, Lisa Gregory, Mary Anne Littlefield, and Barbara Van Valkenburg donated Keurigs for the hospitality room. The ladies in the hospitality room provided over 60 cups of coffee a day (plus hot chocolate, tea, and water), and provided breakfast snacks and afternoon cookie snacks for people during the congress.

On Friday evening, some of the California Society compatriots went to dinner at Water Grill Restaurant, which was across from the South Coast Mall. At 8:19PM, we felt the 7.1 Ridgecrest Earthquake (120 miles away). This followed the 6.4 earthquake the day before, and the 5.4 earthquake in the morning.

SATURDAY

On Saturday, July 6, 2019, Jim Klingler was Day Captain, and Hammond Salley was Assistant Day Captain. Phil Mitchell, Hans Hunt, Kevin Bidekap, Karen Carlson, Lisa Gregory, and Jim Klingler served as bus captains for the various tours. The SAR provided bottled water to attendees. There was an optional tour to the Lyon Air Museum in Santa Ana, and the Nixon Library in Yorba Linda. The Lyon Air Museum holds the plane collection of Major General William Lyon (USAF-Ret), and had a temporary exhibit on Ferraris. We saw a Boeing B-17 "Flying Fortress," a Douglas A-26 "Invader," a Douglas C-47 "Dakota," an American Airlines Douglas DC-3, a North American B-25 "Mitchell," as well as other planes. We saw Adolph Hitler's 1939 Mercedes-Benz Model G4 Offener Touring Wagon, which he used to visit Paris in 1940. We also saw American and German motorcycles, Jeeps and trucks from World War II. We next visited the Richard Nixon Presidential Library and Museum, and had a luncheon there, while listening to the US Marines Band in the adjacent room. SUNDAY

On Sunday, July 7, 2019, Stephen Renouf was Day Captain, and John Ferris was Assistant Day Captain. Jim Fosdyck, Mark Kramer, Charles Lampman, and Bob Taylor attended the Color Guard Committee Breakfast. Dan McKelvie was presented with the SAR Von Steuben Medal. The committee discussed the Castaways Park review prior to the Memorial Service, and announced that color guardsmen would be permitted to bring muskets and sabers in the church for the Memorial Service. Mark Kramer would be performing safety checks. The committee voted to expand the definition of a national color guard event to include events where the president general is unable to attend, but designates the current secretary general or treasurer general to represent him at the event. Beach, read a proclamation from the current
mayor. Following pictures, the Color Guard was
bused to the St. Andrews Presbyterian Church in
Newport Beach for the National Society's Annual
Memorial Service. Dave Gilliard and David Duf-
field drove golf carts for people with mobility is-
sues. The National Society remembered the SAR
compatriots who died in the previous year.

After the Memorial Service, several committees
met in the late afternoon. The Bylaws and Legal
Advisory Committee reviewed bylaw amendment
proposals from State societies. Derek Brown at-

tended the meeting of the Knight Essay Contest, which discussed the 4-year budget, and having annual prizes of
\$5,000 (first), \$2,500 (second), and \$1,000 (third).

They want to encourage State Societies to give financial aid to state winners. They had \$18,000 in donations last
quarter. The deadline for State Societies to submit state winners to National for the 2020 contest will be April 30,
2020. Derek Brown, and Jim Faulkinbury attended the meeting of the Germany Society, where they discussed
new member applications, financial status and donations, and forming an
SAR Chapter in Germany. There was a brief discussion on a potential
trip to Germany in the future. They elected an alternate trustee for the
Germany Society. Phil Hinshaw attended the meeting of the Newsletters
& Periodicals Committee with three other people, but the chairman did
not attend. Stephen Renouf chaired the meeting of the Medals & Awards
Committee, which was attended by members Bob Ebert, and guests
Derek Brown, and Phil Hinshaw. The committee unanimously approved
a proposal for the Colorado Society SAR 125th Anniversary Medal
(proposed by the Colorado Society).

This is a limited edition medal – they are only making 125 medals for sale
at \$35 per set. The committee unanimously approved a proposal for the
US Flag Retirement Award (proposed by the NSSAR Flag Committee).

This award, similar to the Admiral Furlong Award, is for State Societies
for presenting the US Flag Retirement Certificates. It is funded by the NSSAR Flag Committee, with funds that
will last over 18 years. The committee unanimously approved a proposal to remove the “silk” requirement in the
description of the SAR Broad Sash in SAR Handbook Vol. IV, page 6 (proposed by the Medals & Awards Com-
mittee). The committee unanimously approved a proposal to approve the 2020 SAR Congress Medal (proposed
by the Virginia Society), which will be sold for \$35 per set. The Medals & Awards Committee went into executive
session, and approved the SAR Gold Good Citizenship Medal for Gen. Gordon Sullivan (proposed by the Virgin-
ia Society), who is leading a capital campaign for the National Museum of the US Army at Fort Belvoir, Virginia;
for Thomas Walker (proposed by the Alabama Society), who helped to create the American Village living history
museum; and for Sang Chui Lee, who promoted Taekwondo in the US and the world, and led the US Olympic
Taekwondo Team in the 1988 Seoul Olympics.

MONDAY

On Monday, July 8, 2019, John Ferris was Day Captain, and Brian Stephens was Assistant Day Captain. Robert Taylor and Derek Brown attended the Council of State Presidents' Breakfast. President General Warren Alter presented the Silver Certificate of Appreciation for the Council of State Presidents to Peter Davenport, John Fulwider, Stephen Hinson, Bobbie Hulse, David Jessel, Patrick Kelly, Kevin Mullen, William Schwetky, George Stickney, Michael Sullivan, Robert Taylor, and Kevin Waldroup. He presented the Gold Certificate of Appreciation for the Council of State Presidents to Kevin Carr. President General Warren Alter opened the 129th Annual Congress of the Sons of the American Revolution. State Senator John Moorlach sent his district director, Scott Carpenter, to present a resolution to the Sons of the American Revolution. Orange County Supervisor Michelle Steel sent her district director, Tim Whitacre, to present a resolution.

Costa Mesa Mayor Katrina Foley presented a proclamation to the Sons of the American Revolution. Costa Mesa Councilwoman and Past Mayor Sandra Genis addressed the SAR Congress. President General Denise Doring VanBuren of the Daughters of the American Revolution, and Senior National President Norma Griffin of the Children of the American Revolution brought greetings to the Sons of the American Revolution. Grand Viscount General Lindsey C. Brock brought greetings from the Order of the Founders of North America, Governor General Jim Fosdyck brought greetings from the Order of the First Families of Maryland, Governor Bruce Merritt brought greetings from the Society of Colonial Wars in California, Eric Stassforth brought greetings from the Society of War of 1812 in California, Ray Raser brought greetings from the California Mayflower Descendants, and Commander Stephen Renouf brought greetings from the California Commandery of the Military Order of Foreign Wars of the United States. PG Alter introduced Chuck Klausmeyer, the senior creative producer for mikeroweWORKS. Mr. Klausmeyer accepted the SAR Gold Good Citizenship Medal for Mike Rowe, the host of the television program *Dirty Jobs*. His foundation, mikeroweWORKS, grants scholarships to students studying blue collar trades. Mr. Klausmeyer played a voicemail from Mike Rowe in which he apologized for not being able to be present to accept the award, and said he was humbled to receive the prestigious award from the Sons of the American Revolution. The California Society will arrange to re-present the medal to him at a future date when he is in California. During the presentation of gifts, President Robert Taylor presented the annual California Society donation of \$1,000 to the SAR Center. The past presidents general gave their comments.

The Youth Awards luncheon was held at the hotel, with T. Rex Legler of the Indiana Society as emcee. Following lunch, Chairman of the SAR Poster Contest Ron Barker announced that the winner (\$300 cash prize) was Jasmine Gadot (sponsored by the Gold Country Chapter in CA) with a poster on Sybil Ludington. Kansas came in second place (\$150), and North Carolina came in third place (\$100). Ron Barker announced that the SAR Brochure Contest winner (\$350 cash prize) was South Carolina Society, Ohio came in second place (\$250), and Kentucky and Maryland came in third place (\$150). Chairman Ed Rigel of the King Eagle Scout Award announced that the winner was Ambrose Terneus of Nebraska, who read his essay, "Abraham Whipple: Audacity in the Atlantic." He received \$10,000 for first place. The second place winner (\$6,000) was from Texas, and the third place winner (\$4,000) was from Kentucky. The Dr. Tom and Betty Lawrence American History Teacher Award was announced – the winners were Jonathan Bragwell (elementary school teacher in AL), Christopher Razo (middle school teacher in AZ), and Renny Taylor (high school teacher in NC), who each won \$5,000. Darrin Schmidt, the chairman of the CAR Committee, presented a check for \$1,000 for National CAR President Mackie Storage's national project – *Foundations of Freedom* – which will raise funds for Ferry Farm, the childhood home of George Washington. James M. Lindley, the chairman of the SAR Knight Essay Contest, introduced winner Caleb Sheppard (Florida), and he read the winning essay on "The Right to Keep and Bear Arms: The History and Meaning of the Second Amendment." He received \$5,000 for first place. The second place winner (\$2,500) was from Virginia, and the third place winner (\$1,000) was from Indiana.

Chairman David Perkins of the Outstanding JROTC Cadet Award announced the winner was Air Force Cadet Major Boston John of Utah, who received \$4,000 for first place. The second place winner (\$1,500) was from Oklahoma, and the third place winner (\$1,000) was from Virginia. Chairmen John Bredenfoerder of the SAR Rumbaugh Oration Contest announced the winner (\$5,000) of the oration contest was Allison Stanley, sponsored by the Alabama Society, and she delivered her oration on the power of words. She referenced *Common Sense* by Thomas Paine, and explained how his words were a powerful weapon in the battle for American Independence. Following the Youth program, the seersucker sages took their picture – including Jim and Karen Faulkinbury, and Un Hui Fosdyck.

On Monday afternoon, the committee chairmen gave their report to congress. Chairman Peter Davenport of the Bylaws and Resolutions Committee presented the recommendations of the committee. The first proposal was to amend Article III of the SAR Constitution to define two new categories of membership – national life members, and emeritus members.

The committee recommended approval, and the motion passed. The second proposal (from the Indiana Society) was to amend Article IV of the SAR Constitution to increase the term of general officers (except vice presidents general) from one year to two years. The bylaws committee recommended disapproval, and congress voted to defeat the proposal. The third proposal was to amend Bylaw 1, Section 7 to allow memorial members for two generations from the application upon which it is based in either direction – two generations prior to the application, or two generations after the application. The bylaws committee recommended approval, and the motion passed. The fourth proposal was to amend Bylaw 19, Section 1 to eliminate the “Independent Audit Committee,” and add its responsibilities to the “Audit Committee,” and increase the number of members of the Audit Committee from five to seven members. The bylaws committee recommended approval, and the motion passed. The fifth proposal was to amend Bylaw 19, Section 1(h)(1) to change the Historian General, Librarian General, and Curator from ex-officio members of the Museum Board to non-voting members of the Museum Board. The bylaws committee recommended the proposal be accepted, and the motion passed. The sixth proposal was to amend Bylaw 20, but it was withdrawn by the Indiana Society as moot due to the defeat of the proposal for two-year terms for general officers. The seventh proposal (from the Indiana Society) was to amend Bylaw 20, Section 1 to restrict the membership of the nominating committee to people with little to no experience in the National Society. The bylaws committee recommended disapproval, and congress voted to defeat the proposal. The eighth proposal (from the Indiana Society) was to amend Bylaw 20, Section 2 to make the nominating committee impotent by having them simply list all nominees for each office without recommending the most qualified. The bylaws committee recommended disapproval, and congress voted to defeat the proposal. The ninth proposal was to amend Bylaw 24, Section 3 to remove a national life member from the roll and suspend payment of their national dues if they are not current members in any state society. National dues payments will be resumed upon his reinstatement by a state society. The committee recommended the proposal be approved, and the motion passed. The tenth proposal was to amend Bylaw 33 regarding discipline, procedure and due process. There was a spirited discussion over section 10, and congress voted to postpone the discussion until Tuesday. The eleventh proposal was to amend Bylaw 34, Section 1 (proposed by the Michigan Society) to remove the requirements for membership in the national ladies’ auxiliary, and replace the text with “meeting the eligibility requirements as provided in the bylaws of the ladies’ auxiliary.” The bylaws committee recommended approval, and the proposal was approved. The annual congress then recessed for the day.

At 5PM, the California Society held a pizza party to honor new Minuteman Jim Faulkinbury. We ordered pizza from the Hotel kitchen, and had them delivered to the California Hospitality Suite for the CASSAR members and their SAR guests. At 8PM, the Minuteman Ceremony and Awards Night was held.

The current Minutemen marched into the room, and the 2019 Minuteman candidates were inducted: Michael Elston (VA), Jim Faulkinbury (CA), Larry Leslie (KY), James Lindley (WA), Thomas Showler (PA), and William Stone (AL). Following the Minuteman Ceremony, there was a brief recess, and then the Awards Night continued. Patrick Mesnard of the France Society was presented with the SAR Gold Roger Sherman Medal, and Brigitte Mesnard was presented with the SAR Martha Washington Medal. The California Society won the SAR William M. Melone Award for the state society that had the largest number of approved supplemental memberships, the Admiral William R. Furlong Memorial Award for state societies that present SAR Flag Certificates, and the CAR Activity Award for state societies that have worked with the Children of the American Revolution. The California Society received participation certificates for competing in the Brochure Contest, the Outstanding JROTC Cadet Contest, the Knight Essay Contest, the Eagle Scout Contest, and the Poster Contest. California Compatriots received Certificates of Appreciation for serving at National: Jim Faulkinbury (Genealogist General), and Kent Gregory (Executive Committee). California Compatriots received Certificates of Appreciation for chairing national committees in 2018-19: Chairman Ronald Barker (Americanism), Vice Chairman James Fosdyck (Color Guard Committee), Vice Chairman Ronald Barker (Council of Vice Presidents General), Vice Chairman Ronald Barker (Education), Chairman James Klingler (Finance), Vice Chairman Jim Faulkinbury (Information Technology), Vice Chairman James Klingler (Investment), Chairman Stephen Renouf (Medals & Awards), Chairman Kent Gregory (Museum Board), Chairman Stephen Renouf (Premium Membership Medals), Vice Chairman John Dodd (Premium Membership Medals), and Chairman John Dodd (Youth Exchange Program). Gary O. Green was presented the SAR Color Guardsman of the Year Award by PG Alter and Jim Fosdyck. The following California Compatriots received the Liberty Medal for being the first line sponsor of ten new members: Kerry A. Adams, David A. Gilliard, and Harry M. Stover, Jr. The following compatriots received the oak leaf cluster for multiple awards of the Liberty Medal: Terry L. Briggs (2), James H. Cunningham (2), Jim Faulkinbury, M. Kent Gregory (2), Donald H. Gurley (2), Gary D. Jensen (3), Richard J. McMullen (2), Raymond Raser (2), and Owen Stiles.

TUESDAY

On Tuesday, July 9, 2019, Brian Stephens was Day Captain, and Dan McKelvie was Assistant Day Captain. The SAR districts held their breakfast meetings. Derek Brown, John Dodd and Bob Taylor attended the Intermountain/Western/Pacific/Rocky Mountain District Breakfast. Attendees were introduced to district officers, and activities in the districts were announced. Candidates for opposed offices campaigned at the district breakfasts.

After breakfast, the SAR Congress reconvened. Chairman Peter Davenport of the Bylaws and Resolutions Committee then finished up the voting on the bylaws amendments. The bylaws committee reformulated the contentious section 10 of bylaw 33, and the proposal was approved as amended. The Executive Committee made a proposal to purchase a check scanner for the 5/3 Bank to facilitate deposits, and the proposal was approved. The Nominating Committee report was presented: John Manning for president general, Davis Wright for secretary general, Bruce Pickette for treasurer general, Peter Davenport for chancellor general, Jim Faulkinbury for genealogist general, William Stone for historian general, Doug Collins for registrar general, Tony Vets for Librarian General, Dr. Darryl Addington for surgeon general, David Felts for chaplain general, Warren Alter for SAR Foundation Board (PG Position), and John Dodd for SAR Foundation Board (At-Large).

John Thornhill was nominated from the floor to run for registrar general. The slate of vice presidents general was presented – including Jim Fosdyck (Western District). All the general officers and vice presidents general nominated for positions that were uncontested were elected unanimously by acclamation. The election board was appointed to conduct the election for registrar general. The credentials committee reported that there were 205 registered delegates to the SAR Congress. Congress was recessed for committee meetings in the afternoon.

At Noon on Tuesday, Ron Barker, Jim Blauer, Arnold Burr, John Dodd, John Ferris, James Fosdyck, David Giliard, Kent Gregory, Russell Kaiser, Jim Klingler, Don Littlefield, Dan McKelvie, Ray Raser, Brian Stephens, Robert Taylor, Edward Torrence, and Robert Whitman attended the George Washington Endowment Fund Luncheon in the Fountain Terrace Room, and Stephen Renouf took pictures for the absent Un Hui Fosdyck. New George Washington Fellows received their pins from President General Warren Alter.

On Tuesday afternoon, Lou Carlson, Jim Klingler, and Dan McKelvie attended the meeting of the Finance/Budget Committee, where they discussed details of the SAR budget. Jim Faulkinbury attended the Membership Committee meeting, but there was not a quorum to conduct business. The compatriots in attendance were asked to determine ways to get former members to reinstate for the next meeting at the Fall Leadership Meeting. Derek Brown, Donald Littlefield, and Robert Taylor attended the Council of State Presidents Business Meeting.

In the absence of President Tom Jackson (TX), Dan Woodruff (SC) was elected acting president, and the Council discussed future goals, such as membership retention. The Council elected four members (and four alternates) to the National Society Nominating Committee – Robert Taylor (CA), Robert Meyer (NJ), James Becker (NC), and Kenneth Goodson (MI). The four alternates elected were Dr. John Fulwider

(MS), L. Stephen Hinson (OH), Harry Roberts III (DE), and Ed Hoak (MA). The new Council of State Presidents officers for 2018-19 are: President Robert Taylor (CA), Secretary Kevin Carr (NM), and Assistant Secretary Anthony Abbott (WA). The Council discussed the need for volunteers for the SAR Patriot Research System (PRS), and it was estimated to take about 20 minutes per application to enter the SAR member to the patriot along with intermediate ancestors. This can be done by chapter members who may not be able to actively participate in chapter meetings. They also noted that the New Members Manual was on SAR ShareFile.

John Dodd, David Grinnell, and Stephen Renouf attended the Historian General's History Seminar on *Quakers in the Age of Revolution*. The guest speaker, Dr. Patrick Cecil (a member of the Orange County Chapter), spoke about the settlement of Quakers in Pennsylvania, and their friendship with the local Indians. He discussed the Paxton Boys (frontiersmen of Scots-Irish heritage), who were vigilantes formed to retaliate against Indians following the French & Indian War and Pontiac's War. He discussed the split between pacifist Quakers and Quakers who supported the Revolution, and the expulsion of pacifist Quakers, who were interned in Virginia. General Washington asked Pennsylvania to allow the wives and daughters to visit their relatives in the internment camps. After the Revolutionary War, General Mad Anthony Wayne asked the Quakers for help in pacifying the Indians since they had good relations with the Indians. John Dodd, Kent Gregory, and Stephen Renouf attended the meeting of the Congress Review Committee, which discussed the successes and failures of the Costa Mesa Congress. There were only a few minor issues that needed to be addressed in future congresses. Balloting was held for the contested race for registrar general.

The SAR Ladies Auxiliary held a luncheon at the Bowers Museum in Santa Ana, California. Conni Barker and Karen Carlson served as bus captains. Following lunch, a representative from the National Disaster Search Dog Foundation spoke about their vital work training search dogs. The Ladies Auxiliary raised about \$10,310 for the foundation. The ladies had time to explore the museum, visiting the permanent collections on Sacred Realms, Ceramics of Western Mexico, First Californians, California Bounty, California Legacies, Gemstone Carvings, Spirits and Headhunters, and Ancient Arts of China. They also were able to visit the special exhibit on international fashion designer Guo Pei.

On Tuesday evening at 5:25PM, the California Society had their group picture taken by Penny Rogo-Bailes. Janet Brown, Kathryn Brown, Lacy Dodd, Karen Dodd, Darian Taylor, Conni Barker, and Karen Carlson set up the table decorations for the Tuesday and Wednesday banquets. At the President General Banquet, the outgoing vice presidents general and general officers processed into the banquet room. The National Color Guard held the change of command ceremony, as National Color Guard Commander Mark Anthony turned over command of the National Color Guard to James Fosdyck of the California Society. It was announced that Doug Collins of Kentucky won the election for Registrar General held earlier in the afternoon. Following dinner, the California Society procured a special guest speaker – Captain Charlie Plumb (USN-Ret), an outstanding motivational speaker. He was a farm boy from Kansas who dreamed of being a pilot.

He secured an appointment to the US Naval Academy, and following his graduation, he attended the Navy Fighter Weapons “Top Gun” School in San Diego.

He served on the Aircraft Carrier *USS Kitty Hawk*, and flew 74 successful combat missions over Communist North Vietnam in a F-4 Phantom Jet (he was code named “Plumber”). Five days before the end of his tour in Vietnam, Captain Plumb was shot down over Hanoi and taken prisoner. He spent the next 2,103 days in an 8-foot by 8-foot POW cell, subject to cruel torture by the Communists. He described how he learned to communicate with other prisoners in adjoining cells by use of a code developed for tugs on a wire. He helped to inspire fellow prisoners, and keep their morale up despite their horrendous predicament. Following the end of the Vietnam War, and his repatriation to the United States, he continued his Naval career as a pilot – retiring after 28 years of service in the United States Navy. Captain Plumb is now a highly sought after motivational speaker. President General Warren Alter presented Captain Plumb with the SAR Certificate of Appreciation and a desktop Liberty Bell in gratitude for his enthralling presentation. PG Alter inducted Captain Joseph Charles Plumb, Jr. into the Sons of the American Revolution, and John Dodd pinned the SAR Rosette on his collar. PG Alter presented Compatriot Plumb with the SAR Wounded Warrior Coin and the SAR War Service Medal. The National Ladies Auxiliary officers for 2019-20 were sworn into office. President Warren Alter presented his final awards. He presented the SAR Daughters of Liberty Medal to outgoing Ladies Auxiliary president Martha Barnhart, and to Keitha Callanan. WEDNESDAY

On Wednesday, July 10, 2019, Dan McKelvie was Day Captain. Derek Brown and Jim Fosdyck attended the Donor Recognition Breakfast, where the Youth Program chairmen presented awards. The SAR Congress reconvened at 9 AM.

It was announced that there were \$35k in gifts, and \$39k in pledges raised during the congress. Christopher Moberg was elected from the floor as vice president general for the North Central District. The nominations for national trustees/alternate trustees were presented, including Derek Brown/Robert Taylor (California Society), Stephen Renouf/Charles Alcaraz (Spain Society), Robert Moore/Steven Morgan (Hawaii Society), and Charles Smith/Brian Worcester (Nevada Society). There was a motion to elect the nominated trustees/alternate trustees, which passed unanimously.

President General-Elect Jack Manning's nominations for the Executive Committee were presented: Warren Alter (AZ), David Boring (AL), John Dodd (CA), Fred Olive (AL), and David Perkins (CT), and a motion to ratify the appointments passed unanimously. Jack Manning appointed Russ DeVenney (MO) as VPG of the International District, Michael Elston (VA) as Ambassador to the UK, Richard Bryant (MO) as Ambassador to the Caribbean, Derek Brown (CA) as Inspector General, Ray Wess (FL) as Deputy Inspector General, Nathan White (TX) as Project Manager, Rev. Randy Moody (FL) as Parliamentarian, Kenneth Goodson (MI) as Committee Coordinator, and David Boring (AL) as Chief Compliance Officer. President General Warren Alter declared the election of the general officers for 2019-20.

There was a motion to have the general officers, vice presidents general, living past presidents general, and Executive Committee members elected as trustees, and the motion passed unanimously. There was a motion to destroy the ballots for the election, which passed. Chancellor General Dick Bryant installed the 2019-20 national trustees. President General Alter adjourned the congress. President General-Elect Jack Manning convened the first meeting of the 2019-20 Trustees. There was a motion to authorize the president general, treasurer general, secretary general, and executive director to sign bank documents, which passed. There was a motion to approve the annual renewal of the \$1.5 million line of credit with Fifth Third Bank, which passed. The trustees meeting was adjourned.

On Wednesday afternoon, there was an optional tour to Mission San Juan Capistrano in Orange County, California. We took the bus to San Juan Capistrano. The bus captains were John Dodd and Curtis Porter. We had lunch at El Adobe de Capistrano Restaurant – the northern part of the building was built in 1797 as the home of Miguel Yorba, and the southern part was built in 1812 as the *juzgado* (the court and jails) of the town. When Richard Nixon was president, the restaurant prepared Mexican food exclusively for him. The restaurant later switched from a continental menu to a Mexican menu. Following lunch, we walked two blocks to Mission San Juan Capistrano, and had a guided tour of the highlights of the mission, including the old chapel, the ruins of the 1776 mission church, and the wine-making exhibit. After the tour, we had time to wander the grounds of the mission, and do some shopping in the gift shop. We returned to the hotel in the afternoon.

On Wednesday evening, the Installation Banquet was held in the hotel ballroom. The newly elected Vice Presidents General processed, including James Fosdyck of the Western District. After dinner, President General Warren Alter presented the SAR Meritorious Service Medal to Surgeon General Darryl Addington. PG Alter presented the SAR Gold Congress Appreciation Medal to Paul Callanan; and he presented the SAR Silver Congress Appreciation Medal to John Dodd, Kent Gregory, Stephen Renouf, and Janet Brown.

PG Alter presented the SAR Lydia Darragh Medal to Nancy Alter, and presented her with a certificate certifying she is a Kentucky Colonel. Disney figurine. Chancellor General Richard Bryant swore in new general officers, and the new Vice Presidents General. New Chancellor General Peter Davenport then installed

Jack Manning as the 116th president general of the Sons of the American Revolution. The George Washington Seal Ring Honor Guard then brought in the ring, and President General Jack Manning took the ring oath. President General Manning presented Warren Alter with the SAR Gold Good Citizenship Medal, and presented him with the past president general neck ribbon. President General Manning gave his inaugural address, in which he stated one of the most important duties of the President General is traveling the country to attend and support the work of chapters and states. He said he intended to continue the work of his predecessors in furthering the SAR Education Center and Museum, and continue PG Alter's program of improving communication and providing transparency to the trustees and members. President General Manning adjourned the 129th SAR Annual Congress.

THURSDAY

On Thursday morning, July 11, 2019, Derek Brown (guest) and Kent Gregory (guest) attended the first meeting of the new Executive Committee. The appointments on committees, as required by Bylaw 19, were approved for the Budget Committee, Museum Board, Ethics Committee, Finance Committee, Genealogy Committee, Investment Committee, Handbook Committee, and Strategic Planning Committee. Fourteen members were removed from the Genealogy Committee due to lack of participation, and the need for “fresh blood” on the committee. Medals & Awards Committee Vice Chairman Paul Callanan presented the report of the Medals & Awards Committee, and the medal proposals and gold good citizenship medal proposals were all approved by the Executive Committee. The SAR Foundation met, and PG Joseph W. Dooley was elected president of the SAR Foundation Board, and Michael Elston was elected vice president.

There was an optional tour to the Ronald Reagan Presidential Library on Thursday Morning. Jim Klingler served as bus captain, and had everyone boarded as soon as the buses arrived. We viewed a film on Ronald Reagan's life on the long bus ride to Simi Valley.

When we arrived, we broke into groups of 10, and were given a guided tour of Air Force One (a Boeing 707 aircraft), the Reagan Museum, and the replica of the Oval Office. We broke for lunch in the café, and then resumed our tour on our own. We saw the Marine One helicopter (from the Lyndon Johnson Administration), and took our time visiting the highlights of the Reagan Museum, including the new suit with a bullet hole from the assassination attempt, an iron beam from the World Trade Center, and exhibits on Reagan's presidency – such as the Berlin Wall, and the negotiations with General Secretary Mikhail Gorbachev of the Soviet Union.

We boarded the buses in the afternoon, and saw a film on the humor of Ronald Reagan from his speeches on the long bus ride back to Costa Mesa. The California Society volunteers did a tremendous job hosting the 2019 SAR Congress in Costa Mesa, California. The volunteers will be honored by the California Society at the Fall Board of Managers Meeting in Irvine, California, later in the year. The California Society is permitted to award 30 SAR Bronze Sam Adams Congress Appreciation Medals to volunteers who helped to host the meeting.

KERN CHAPTER AND THEIR TRAVELING TRUNK

Four years ago the Kern Chapter started attending 5th grade assemblies to present history on the American Revolution. Last year we attended 12 schools in the Bakersfield area with our Color Guard and a box full of props.

After seeing the trunk at the SAR National Congress held in Houston, our Chapter went to Hobby Lobby and purchased a trunk to put all our props in. It works great and helps keep everything organized. On the top of the trunk is our tablecloth, which goes down first then all the other items come out with the sailing ship the last item out. Since we are all wearing our uniforms and a DAR member is in her period clothing, we felt adding additional period clothing in the trunk wasn't needed.

Our programs last about an hour to an hour and a half. Arnie Burr of the Color Guard starts talking about what life was like 250 years ago and goes over many of the items on the table. From the candles for light and ships for transportation students learn what life was like during the Revolution. Steve Corbin talks about weapons and money. Kerry Adams about the Marines and how they protected the Navy, and Mike Davis explains the different flags and how the flags were used during the Revolution. Mary Ann Claxton (DAR) talks about her clothing and since she is the person that has sewn all our uniforms, she points out the different symbols on the uniforms. We point out to the students that the Industrial Revolution had not arrived yet and that everything was done by hand. All the wood for the ships was cut by hand, and all the sewing was done by hand. There was no electricity, so all the conveniences they are accustomed to today, didn't exist during the American Revolutionary War era.

The feedback in letters we receive from students and teachers lets us know they thoroughly enjoy what we are doing in teaching the history of the American Revolution. If only for a few minutes, we are planting seeds of interest in our Patriot Ancestors lives.
