

### Brief Book Reviews

(Copies of these recently published books have been donated to the S. A. R. Library by the author.)

"Uncollected Works of Abraham Lincoln" Vol. I and Vol. II assembled and annotated by Rufus Rockwell Wilson published by The Primavera Press, Inc., Elmira, New York—\$5.00 per volume.

In the "Uncollected Works of Abraham Lincoln" a monumental work in assembling and annotating is in progress. The complete work will be in four volumes, two of which have been published. The first volume covers the period from 1824 to 1840 and the second volume covers the period from 1841 to 1845. This compilation contains letters, addresses, legal pleadings and other writings of the great emancipator. The compiler's note of expla-

nation before each paper greatly increases the interest to the reader and student. The compilation is splendidly indexed, facilitating quick access to the hitherto most obscure writing. Attorneys will find the pleadings drawn by Lincoln of particular interest as they represent not only the writings of the great man but also historically show the forms employed in legal practice at that time.

This work represents the patient, painstaking and intelligent labor of a real scholar who has a most vital interest in this subject. This compilation will be most valuable and entrancing to the student or reader who is interested in Abraham Lincoln.

## Events of State Societies

### Alabama

JAMES (HORSESHOE) ROBERTSON CHAPTER and guests observed Washington's Birthday with a dinner meeting at the Tuscaloosa Country Club. The guest speaker was Doctor George Lang, Professor of Philosophy at the University of Alabama, who delivered a most interesting historical address on the Philosophy that Led up to the Revolutionary War and American Independence. State President John T. Bradford spoke in an interesting manner of the founding of the Society in Alabama.

Miss Eva Clapp, School of Music, University of Alabama, led in the singing of America and The Star-Spangled Banner and also rendered several delightful solos with Mrs. Sarah Snow as accompanist.

Compatriot J. Whitfield Moore was elected a Delegate to the National Congress at Jacksonville in May.

The Texas Banner, won last year by the Alabama Society, was displayed with the National Colors.

This Chapter will, at the end of the current school year, present the Society's R.O.T.C. Medal to honor students of the Military Department of the University of Alabama, and the Good Citizenship Medal to outstanding graduates of all the High Schools of Tuscaloosa County.

### Arkansas

The 60th Annual meeting and banquet was held February 22nd at the Sam Peck Hotel, Little Rock. Admiral Corydon M. Wassell was the principal speaker.

The following officers were elected: General Douglas MacArthur, Honorary President; Judge Joseph M. Hill, President Emeritus; Hon. John N. Heiskell, President; Hon. Edwin E. Dunaway, Judge Reuben W. Robins, Vice Presidents; Hon. Sam M. Wassell, Chancellor; Rev. James M. Workman, Chaplain; Robert W. Mosley, Registrar; Joseph Brooks, Genealogist; Edward O. Mitchell, Treasurer; Dallas T. Herndon, Historian; Dr. John H. Reynolds, Librarian; Mason E. Mitchell, Secretary.

Delegates to the Jacksonville Congress were named as follows: Admiral Corydon M. Wassell, Col. James L. Blakeney, Major Edmund R. Wiles, Edwin E. Dunaway, S. M. Wassell, Dr. C. H. Dickerson, Grafton E. Conway. Secretary Mitchell was nominated for National Trustee.

The Society has had a gratifying growth since World War II, and the formation of local chapters is being considered. World War II Medals were presented to twenty members, who served in the war; five medals had been previously awarded. The Society is grateful that none were seriously wounded or lost in combat. The Society went on record to oppose legislation providing offices in the Old State House, now known as a War Memorial.

The honor guest at the banquet was Miss Marie Lloyd, Vice President General of the D.A.R. and other guests included Dr. and Mrs. Harry A. Little, and the wives of Past Presidents, and Regents of four D.A.R. Chapters of Little Rock.

### California

At its December Board meeting a Resolution was adopted expressing the pleasure of the members at the election of Judge Ben H. Powell, III, as President General, by the National Executive Committee to fill the vacancy caused by the death of President General Shaler.

SAN FRANCISCO CHAPTER—At its December meeting the Chapter reported special trophies to be presented to the R. O. T. C. Batteries at the University of San Francisco, the High Schools of San Francisco and to individual cadets at these schools and to St. Ignatius High School. These are awarded for high scores in the Hearst and 6th Army Rifle Matches. Units in eleven western states compete. Trophies are also provided for R. O. T. C. Battalions in the 1st and 2nd High School Regiments. The Chapter now makes thirteen perpetual trophy awards.

In cooperation with the Printers Guild of San Francisco, the Chapter participated in ceremonies commemorating the birthday of Benjamin Franklin at the base of the Franklin statue, at which Gen. H. G. Mathewson, Vice President General was the speaker and which was attended by Admiral L. E. McCormick, Commandant, 12th Naval District, and by British and French Consuls, and a color guard of the French Legion.

PASADENA CHAPTER at its banquet meeting on February 22nd presented the S.A.R. Good Citizenship Award to Judge William R. McKay, in

recognition of his outstanding work in organizing chapters of the Order of DeMolay for boys, throughout Southern California. Judge McKay was Deputy Grand Master of the Order, and in March became International Grand Master. The presentation was made by President George W. Minot and Secretary J. Wilfred Corr. In accepting the award, Judge McKay addressed the Chapter on "Creation of the U. S. Constitution and Bill of Rights."

Officers elected at this meeting include Col. Walter D. Thurber, President; Alembert Pond and Ralph R. Allan, Vice Presidents; J. Wilfred Corr, Secretary; Ewart W. Adams, Treasurer; and Clarence E. Burleigh, Historian.

LOS ANGELES CHAPTER—Hon. John Anson Ford, County Supervisor, was the guest speaker at the Washington's Birthday meeting, whose subject was "George Washington." President Harry C. Mabry presided and introduced the speaker and spoke on the "1949 Presidential Inauguration," which he attended with his brother Governor and Compatriot Thomas J. Mabry, of New Mexico. A feature of the evening was the presentation to Mr. Ford of a Commission making him an Honorary Colonel on the staff of Governor Mabry.

SAN DIEGO CHAPTER elected the following officers on February 22nd: President, Judge Everett N. Curtis; Vice President, Edward Fuller; Secretary-Treasurer, R. King Kauffman; Historian, Dr. Frank R. Felt; Chaplain, Rev. A. Watson Brown.

ALAMEDA COUNTY CHAPTER met February 24th and heard Mr. William H. Head, speak on "He Knew Lincoln." Members of the D.A.R. participated.

#### Connecticut

GEN. DAVID HUMPHREYS BRANCH, New Haven, held its annual Washington's Birthday banquet on February 19th at the Hotel Garde, and presented as its speaker Dr. James Rowland Angell, President Emeritus of Yale University, whose death has since been announced. This distinguished American was one of the foremost educators of his day, was President of Yale University for sixteen years, and had had distinguished service with the Universities of Minnesota, Chicago, and Carnegie Institution.

#### District of Columbia

During the Winter Season several very interesting meetings were held. The first one was held at Washington's famous Mayflower Hotel, on Wednesday, November 17, 1948, with Past D. C. Society President Maj.-Gen. Amos A. Fries making the principal speech against the proposed expenditure of \$300,000,000 by the Federal Government for the use of the several states for so-called "educational purposes." Gen. Fries felt the proposal unnecessary and inappropriate at this time. Following the business meeting, a beautiful technicolor journey to South America via the motion picture screen was enjoyed by all present.

At our January 19th meeting in the historic Larz Anderson House, home of the Society of the Cincinnati, Lady Rama Rau, wife of the Indian Ambassador, spoke on activities by the Government of India, but 18 months old at the time, towards abolishing the caste system. She spoke with great dignity and poise and delivered a fine address. Afterwards, the Compatriots and their guests formed a receiving line and were individually introduced to Lady Rau by Commander John E. Allen, Secretary of the D. C. Society. Light refreshments were also served, and many of the group inspected valuable objects belonging to the Society of the Cincinnati, who had been our gracious host for the evening.

The Washington's Birthday Luncheon-Meeting was held this year in the East Room at the Mayflower, with over 100 members and guests present. President General Ben H. Powell, III, was an honored guest and spoke of the magnificent achievements of General Washington, and of his sterling character. Senator J. Melville Broughton, of North Carolina, also spoke on George Washington. The Senator outlined his views that Washington was truly an exceptional individual, brilliant mentally and energetic physically. Greetings were well spoken by other representatives of national and local S.A.R., D.A.R. and C.A.R. societies.

Preceding this meeting, the annual Joint Observance of Washington's Birthday was participated in by the D. C. Society, under auspices of the Sons of the Revolution, Daughters of the American Revolution and the Children of the American Revolution, and a wreath was placed at the Washington Monument.

#### Florida

The State Society Officers and Jacksonville Compatriots are very busy in preparation for the Congress of the National Society to meet in the latter city May 15-18, and plans are very well in progress, and as nearly complete as possible. The fine

#### Society in France

Writing from Oxford University, where he is taking a course, Comte Victor de Pange, Secretary of our Society in France, mentions the Society's participation in annual ceremonies held on November 11th in memory of American and French soldiers killed during both World Wars and especially in memory of Lieutenant-pilot Quentin Roosevelt and of General Theodore Roosevelt. In attendance on this occasion were U. S. Secretary of State and Mrs. George C. Marshall; U. S. Ambassador H. E. Jefferson Caffery, and General Foster Tate, Military attache; French Generals Giraud, Requin, Revers, Mast, Devinc, and other distinguished personages. The Society in France was represented by Vice President Viscount Benoist d'Azy, and representatives of the D.A.R. and Cincinnati Societies were also present.

#### Idaho

The reorganization of the OLD FORT HALL CHAPTER at Pocatello has put new life into both Chapter and State Society. #### Missouri

To emphasize and broaden the observance of Bill of Rights Day in 1948, letters setting forth the significance of the first ten Amendments and urging greater understanding of their vital importance were sent to 231 Missouri Schools, 480 Missouri newspapers, to the Governor of the State, the Mayors of Kansas City and St. Louis and all members of the State Society.

The Society reports with sorrow the untimely death of Colonel E. Carroll Sibley on January 6. Col. Sibley, who was a Professor of Economics at Washington University, had a distinguished academic and military career and had been a loyal and devoted member of the State Society's Board of Managers.

A committee composed of Compatriots Lucian Erskine, Darold E. Ferneau and Marion S. Francis has completed a comprehensive study of the problems involved in the sale to children of comic and crime books, and of the statutes, ordinances and court decisions applicable thereto in other States and Municipalities. The committee's detailed report and recommendations were submitted to the Society's Board of Managers; the committee was directed to proceed immediately in initiating action to implement their recommendations throughout Missouri. The first step was to send the President of the St. Louis Board of Aldermen a vigorous endorsement of the proposed ordinance for that city which has just been sponsored by the Junior Chamber of Commerce. The Society hopes to secure the enactment of similar legislation throughout Missouri, either locally or by the State Legislature.

The Board of Managers has authorized the creation of a Legislative Committee, whose membership will be composed of those Missouri compatriots who are in the State Legislature. The function of this committee will be to watch for legislation introduced in the General Assembly which may be of interest to the Society, and to assist the Society in supporting or introducing bills.


#### Empire State

# Minutes of the Meeting of the Executive Committee, S. A. R.

Held at the Netherlands Plaza Hotel, Cincinnati, Ohio, February 18, 1949

President General Ben. H. Powell, III, presiding.

Present: Compatriots A. H. Foreman, Albert C. Brand, Robert H. McNeill, John G. Ballord, James D. Watson, Clarence E. Shriner. Also, Secretary General Frank B. Steele, and Treasurer General George S. Robertson.

Guests in attendance: Chancellor General Wallace C. Hall, National Trustee, Buford C. Tynes, W. Va.; State Society Presidents, H. S. Sidener, Ohio; L. A. Cassidy, Ky.; S. H. Gillam, Minn.; Dr. U. G. McClure, W. Va.; and Compatriots Douglas High, H. I. Hadsell, and F. L. Woodbridge.

The meeting was called to order by the President General at 10 A.M., and Invocation offered by Rev. Herman S. Sidener, followed by the Pledge of Allegiance.

On motion of Past President General Foreman, visiting Compatriots were accorded the privileges of the floor.

President General Powell paid a brief memorial tribute to the late President General Charles B. Shaler.

The minutes of the meeting of the Executive Committee held December 9th were approved as presented by the Secretary General, and the Treasurer General's report was received for filing.

Reports of special committees were received from Compatriots High, on Headquarters property, and the National Oratorical Contest; from President Cassidy of Kentucky, with reference to a new Chapter being formed at Ashland, Ky.; on relations with the C. A. R. and the S. of R. from the Secretary General; and from Compatriot Brand on Pennsylvania matters.

Following Mr. High's report on the Headquarters Building, on motion, a Committee was appointed to investigate the possibilities of purchase of a lot adjoining the Headquarters, to report back with recommendations. The President General appointed Mr. Shriner, Chairman; and Compatriots Watson and McNeill, members.

The Secretary General presented proposed amendments for action at the Jacksonville Congress, as follows:

*Amend Art. IV, Sec. 1, of the Constitution* by adding after the words, "a President General," the words, "a First Vice President General."

*Amend Art. V, of the By Laws*, by adding a Section 1: "The First Vice President General shall be elected from the membership at large and shall in the event of illness, disability, resignation or death of the President General, perform the duties and exercise the powers of the President General during such illness or disability, or until the next Annual Congress, and shall, at other times, perform such duties as the President General may direct." Add the words, "Section 2" (in Art. V—Vice Presidents General) before the words "In the election of twelve Vice Presidents General," etc.

*Art. XVII—Executive Committee, Sec. 4, of the By Laws* by adding after the words, "In case of the death or disability of any officer of the National Society" the words, "except the President General." Sec. 4 will then read: "In case of the death or disability of any officer of the National Society, except the President General, the Executive Committee shall have the power to elect a successor to fill the unexpired term of office."

*Amend Art. II—State Societies and Chapters—Sec. 7(4) of the By Laws*, add after the words, "Pay to the Treasurer General as of April 1st of each year, the annual dues for such Society, computed at the rate of," the words "One dollar and fifty cents," instead of "one dollar." It will then read: "Pay to the Treasurer General as of April 1st of each year, the annual dues for such Society, computed at the rate of one dollar and fifty cents (1.50)" etc.

*Amend Art. XIX—Fees and dues—Sec. 5 of the By Laws*, by striking out after the words, "When any member, whose membership has terminated," the words "for any cause." Also, add after the words, "Shall at the same time pay to the National Society a fee of one dollar (1.00)," the words "and fifty cents (1.50)." Sec. 5 will then read: "When any member, whose membership has terminated, shall be reinstated by his State Society, such State Society shall immediately report

such reinstatement to the National Society, and shall at the same time pay to the National Society a fee of one dollar and fifty cents (1.50) for such reinstatement."

*Voted:* That the above newly proposed amendments be approved and presented at the forthcoming Congress at Jacksonville for action.

Reports on the Personal Property Tax situation in Washington were made by Compatriots Hall and McNeill and it was

*Voted:* That the President General, Chancellor General and Mr. McNeill be authorized to take any action necessary to prevent collection of any taxes by the D. C. until the matter can be submitted to Congress.

*Voted:* That the same Committee be authorized to pursue legislative action in Congress to finally settle our tax liability.

Designs for Insignia for Past Presidents General and Bars for State and Chapter officers were exhibited by the Secretary General and it was

*Voted:* That designs be corrected to comply with the resolution adopted at Minneapolis and when so corrected the same be recommended to the National Trustees for adoption.

Report on the installation of A.C. current in the Headquarters Building was made by Mr. McNeill and the Secretary General, and as to a circulating pump for the heating system. On motion action was deferred.

An inquiry by the California Society as to

the National Society's attitude on "Displaced Persons" was deferred indefinitely.

It was reported that \$900.00 was forwarded to the California Americanization Fund Committee as a contribution to its expense with reference to the text book situation. On motion the request for further contributions was tabled.

Reports on the Awards of Good Citizenship and R.O.T.C. Medals and the Boy Scout Committees were made by the Secretary General and Mr. Shriner, and plans for the Jacksonville Congress were discussed.

*Voted:* That duplication of annual reports for the annual Congress be made for the President General, Secretary-Registrar General and Treasurer General, and of such other reports of Officers and Committees as deemed advisable by the Secretary and Treasurer General in their discretion, for distribution at the Congress.

*Voted:* An appropriation of \$200 for the Basic Documents Committee was authorized. A letter from Mr. Ellis of Buffalo regarding a special emblem for under-privileged boys being aided by the Buffalo Chapter was tabled.



## Harvey Foote Remington

1863-1949

### Past President General, 1925

As we go to press word has come of the passing of our beloved Past President General, Harvey Foote Remington, who served the Society in its highest office in 1925, and elected at the Congress held at Swampscott, Mass.

His was a long life full of good works, and accomplishments. His death occurred in Florida where he was vacationing in St. Petersburg, and from where he intended to go to the forthcoming National Congress at Jacksonville. He had rarely missed a Congress for years, sometimes present for only a day, but almost invariably there for part if not all sessions. Mrs. Remington usually accompanied him up to the time of her decease. They both were greatly beloved and well-known to the membership of the Society.

Judge Remington was an ardent prohibitionist and advocate of law enforcement in years preceding the repeal. In 1928 he was President of the New York State Anti-Saloon League and later a founder of the Law Preservation party, opposing the nominations of "wet" candidates. He was prominent also in state and national organizations of the Baptist denomination and of many fraternal organizations. He was President of the Rochester Chapter and of the Empire State Society S. A. R. before he became President General; active in American Scenic and Historic Preservation Society, Rochester Historical Society, American Genealogical Society and many patriotic societies. He was Municipal Court Judge in Rochester in 1896, and a 32nd Degree Mason.

Surviving are four sons, all members of the Sons of the American Revolution, and two daughters, and a large number of grandchildren and great-grandchildren.

His loss will be deeply felt throughout the Society.

News of the passing of this devoted Compatriot on January 21, 1949, came as a shock to his many colleagues and friends throughout the Society.

Mr. Winters had served the New Jersey and National Societies actively for many years, as Chapter and State President, and Vice President General, and National Trustee. He was an unflinching attendant at National Congresses,

and spared no effort or pains in serving both his State and Nation.

He was instrumental in securing the permanent marking of historic sites in New Jersey, notably the York Road used as a highway by Washington, the Dey Mansion at Preakness, Washington's Headquarters in his New Jersey campaign. His historical interests were recognized by the Passaic County Historical Society which he served as Vice President.

His Revolutionary forebear was Josiah Gould, of the New Jersey Troops.

The sympathy of all Compatriots is extended to Mrs. Winters and his two daughters, all of whom have accompanied Mr. Winters to the Annual Congresses for a period of years.
