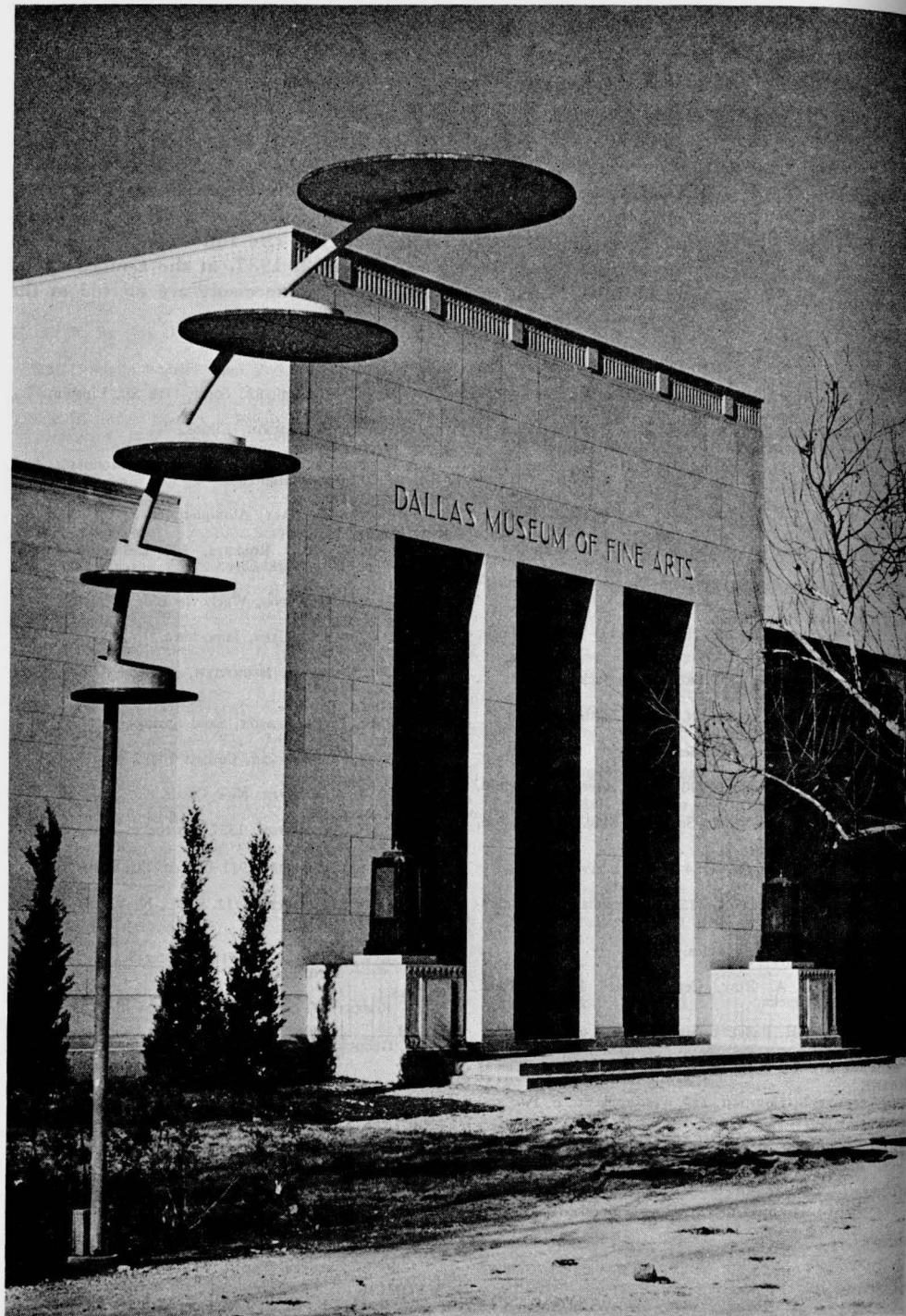

The President General's Message

★ APRIL 30TH, 1939, will be the 150th Anniversary of the date that Washington took the oath as first President of the United States on the balcony of Federal Hall in Wall Street, New York City.

To commemorate this milestone in American Government, a World's Fair is in the making in New York City. Upon solicitation of the patriotic societies a Committee was appointed of representatives of these societies by the World's Fair Board to advise it as to the proper celebration of this patriotic event.

In the course of the meetings, the President General of the Daughters of the American Revolution and your own President General considered the advisability of their two societies presenting throughout the Fair under our joint auspices an American Cavalcade which would depict with living actors the creation of American liberties leading up to Washington's inauguration. A similar project was successfully conducted at the Dallas Exhibition which they each had seen and appreciated the forceful method of bringing home by ocular demonstration the lesson which all citizens need.

We believe that there will be millions of visitors to the Fair who have no understanding or appreciation of our form of government and the meaning of the liberties they enjoy by reason of the Constitution.

A model of this American Cavalcade has been prepared and submitted to the World's Fair and approved by them and a location allocated. The grand stand would hold about 4,500 people and be capable of expansion. It would require 300 actors and 50 horses to make proper depicting of great events such as Runnymede, the Landing of the Pilgrims, the Indian Wars, the Settlement of Virginia, the Boston Tea Party, the Battle of Bunker Hill, the Surrender of Cornwallis, the Constitutional Convention, George Washington's Inauguration, etc.

The stage would be the largest outdoor stage in the world with scenic background comprising the entire scope from the Atlantic seaboard to the Pacific Coast. The action would take place through moving stages and parallels with an electric water screen rising to the height of forty feet to mask the entire production and synchronized with transcribed music. In this masterful setting, costumed with all the authenticity of careful research, directed by people who have a thorough knowledge of dramatic values as applied to spectacle production, American Cavalcade would trace the story of our growth and mark the preservation of that freedom from oppressive government, harsh rule and tyrannical legislation which brought about the birth of this great nation.

The story of the pioneer homesteading in the new land of America, building the small settlements that were to become great cities, the first steps of government, the free expression of a people seeking self-government through mutual respect, control, and that independence which is peculiar to our nation under those laws and traditions that are a heritage, will be the theme of American Cavalcade.

The Executive Committees of our two societies have approved the venture as far as it has gone and it is hoped that patriotic members of the two societies and other patriotic citizens will supply the amount of money necessary to build and carry it out. It is expected from past experience of Cavalcades of this nature that the money subscribed will be repaid with profit.

Notes and Comments

THE EMPIRE State Society will tender a complimentary dinner in honor of the President General, Messmore Kendall, in recognition of his outstanding patriotic work during the past two years of his administration, to be held at the Hotel Plaza, New York, on the evening of April 20, 1938.

In addition to Mr. Kendall, the speakers will include the Hon. Laurens Morgan Hamilton, of Paris and New York, a compatriot of the Empire State Society, and the principal guest speaker will be the Hon. William H. King, U. S. Senator from Utah.

Friends of our beloved Compatriot, David L. Pierson, of New Jersey, whose outstanding contribution has been the establishment and national observance of Constitution Day, will be interested to learn of his marriage on Christmas Day, 1937, to Miss Marian E. Shaw.

Recognition of Mr. Pierson's patriotic work

in making Constitution Day an outstanding event throughout the nation has been given by the New Jersey State Legislature, and similar legislation is pending in the Congress of the United States. Mr. Pierson has the good wishes and congratulations of all his compatriots throughout the Society.

The Connecticut Society will bring to the 49th Congress at Dallas, a cordial invitation to hold the 50th Congress in 1939 at New London. It will be remembered that Connecticut was one of the societies considered for the Congress this year.

The National Society was first incorporated in Connecticut and the officers of this Society feel it will be most appropriate to hold the 50th Congress of the Society in their State.

The project of the Maine Society, to erect a suitable sarcophagus to General Henry Knox

and his wife, has the endorsement of the National Society and will no doubt be generously supported by our membership.

The generosity of Col. James B. Ladd, Com-patriot of our Minnesota Society in providing Good Citizenship and R. O. T. C. Medal awards in his home state and to units of the R. O. T. C., has been frequently referred to in our pages. During the past year Colonel Ladd presented fifty-seven medals in all, some of which are in perpetuity. This is an example to our membership generally, and the Society feels deeply its appreciation of Colonel Ladd's practical and generous patriotic efforts in this field.

President General Kendall has done fine service during his sojourn this winter in Florida, in creating a new Chapter of that Society, at West Palm Beach, comprising many of its winter residents, whom he has interested in organizing. This will be known as the Gulf Stream Chapter and its organizing officers are Charles Francis Coe, President; Clifford V. Brokaw, Vice President; Philip H. Sawyer, Registrar; Blaine Webb, Secretary-Treasurer. Some of these are compatriots in the Empire State and other Societies, who will hold dual membership, and there are expected about fifteen or more new applicants, and a charter membership of at least fifty.

New York Chapter held a joint meeting of its Board of Directors with the State Society on March 3rd when strong resolutions were adopted in protest of the Reorganization Bill now pending in Congress (*as we go to press.*) Strong resolutions were also adopted by the Buffalo and Pittsburgh Chapters.

Mr. Thomas P. Plummer of the Maryland Society has been added to the Credential Committee for the Dallas Congress, and will take up the work there so efficiently handled for several years by Mr. Lee Wylie Tipton, in cooperation with the Chairman, George S. Robertson.

About a year ago, we offered our congratulations to our centenarian compatriot, Major General Aaron S. Daggett, of the Maine Society on his reaching his 100th birthday. We now renew these felicitations on his approaching 101st birthday anniversary which will occur

before another issue of the S. A. R. Magazine is published, on June 14th next.

General Daggett is hale and hearty at this writing, although a short time ago he suffered an illness, from which he fully recovered. Our sincere congratulations and felicitations are extended.

Congratulations are also extended to our beloved Past President General, General Henry F. Appleton, of Massachusetts, who recently celebrated his 90th birthday anniversary. General Appleton was President General in 1905-6.

The Ohio Society has prepared every attractive Charter form for Chapters within its jurisdiction. It is a printed sheet, about 17" by 14½" printed in blue ink, and with spaces for engrossing titles and dates, etc. A few of these are available if desired by any State Society. Inquire of Secretary William M. Pettit, 846 N. Broadway, Dayton, Ohio.

Credential blanks for the 49th Congress will be issued to State Secretaries from National Headquarters on or about April 15. State officers are reminded that a duplicate of their list of delegates is due at the office of the Secretary General, *prior* to the Congress, and should be sent as soon as it is possible to do so.

It will be very helpful if State Secretaries, on reading this notice, send to the Secretary General a requisition for the *exact number* of credential blanks which will be required; this information will aid in conserving postage costs.

Credentials to *National Officers*, including National Trustees, are sent directly to these officers from National Headquarters in Washington, and should *not* be supplied by State officers from the blanks issued to them.

Names of National Trustees nominated by the State Societies to be elected at Portland, Me., should be sent the Secretary General at least *thirty days* prior to the Congress. The new Trustees do not assume office until *after* their confirmation by the Congress, and are not eligible to vote at the meeting of the Board of Trustees which will be held *preceding* the Congress, but will be requested to attend the meeting which will be called *following* the Congress.

This notice is given as there is frequently a misunderstanding with regard to this matter.

The President General's Special Train to Dallas!

THE Transportation Committee has completed arrangements for the President General's Special to the Forty-ninth Annual Congress at Dallas, May 15th to 18th.

The President General's Special will leave St. Louis, Missouri, at 5:30 p. m. over the Frisco and Katy Lines on Saturday, May 14th, arriving in Dallas, Texas, at 9:30 a. m. on Sunday morning.

The delegates will be arriving in St. Louis from mid-day on Saturday and special cars are being provided to bring these delegates to St. Louis. A large majority of the delegates to the Congress will, of course, come from the eastern seaboard, Ohio, Indiana, Michigan and Illinois. Arrangements have been made for the special cars carrying the New England, New York, New Jersey, Pennsylvania, District of Columbia and Maryland delegates to converge at Harrisburg, Pa.; and it is expected that there will be sufficient cars at Harrisburg to really start the President General's Special Train from that point. However, this latter is a question depending on the number of delegates who will go from the east.

There will also be a special car starting from Boston which will pick up the delegates at Albany, Rochester, Syracuse, Buffalo, and connect with cars from Detroit and Cleveland. Special cars will also come from Chicago and Cincinnati.

The time of these cars leaving the various cities is shown on the schedule which is part of this article.

The Transportation Committee has been unable to arrange for special cars from the States west of the Mississippi River due to the uncertainty of the number of delegates attending from those States and the distances to be traveled. However, those from the west are asked, if at all possible, to arrange their arrival in St. Louis in time to catch the President General's Special which leaves at 5:30 Saturday afternoon.

At this point the attention of the delegates is called to the most cordial invitation extended by the Missouri Society, through its President, Compatriot J. Alonzo Matthews, to stop off in St. Louis for a few hours and be the guests of that Society on Saturday afternoon. Missouri Compatriots will take the visiting delegates on a sightseeing tour of the city which will include Forrest Park, Lindbergh Trophies and many other points of interest, following which an informal tea will be tendered the delegates

before they entrain on the President General's Special for Dallas.

The very finest of railroad equipment is being placed at the disposal of our Society and the opportunity to renew old acquaintances and make new ones on this day and a half trip from our eastern seaboard to our southwestern host city is something that the members cannot afford to overlook.

The round trip railroad fares and the cost of a lower berth one way from the principal cities are shown on the schedule following this article; and to those who come from intermediate points, information regarding rates will be gladly furnished if they will communicate with the Chairman of the Transportation Committee at 1508 Fidelity Building, Baltimore.

The attention of the delegates from the northwest is called to the fact that the *Thomas Jefferson Chapter* at Topeka, Kansas, extends a cordial invitation to delegates to stop off and have lunch with the Chapter at the Jayhawk Hotel on Saturday, May 14th. Anyone who can find it convenient to stop off at Topeka is asked to communicate with Vice-President General Ambrose Deatruck, at 726 Lincoln Street, Topeka, Kansas.

Arrangements will be made for those delegates who are immediately returning to their homes following the Congress to leave Dallas on Wednesday evening, May 18th.

The Transportation Committee has also arranged a post-Congress tour to Mexico and a full description of this trip follows this article.

The cost of the Mexican trip as shown includes all expenses from Dallas to Mexico City and return, including railroad and pullman transportation, all sightseeing trips, all hotel accommodations and all meals. The only additional expense will be tips and souvenirs.

A pamphlet describing the President General's Special and the trip to Mexico has been printed by the railroads and will be mailed to anyone who will communicate with the Transportation Committee.

For those making the trip to Mexico, the return will be made so that they can be back in their home city by May 30th.

For those who will go to Dallas and desire to return home by a circuitous route or for those who continue on to Mexico and in returning do not care to come back by way of Dallas and St. Louis but want to proceed

further on to the west or come home by way of the southeast, arrangements will be made and full information will be furnished if those interested will advise the Transportation Committee of their desires.

An interesting trip for those desiring to see more of Texas would be the triangle tour arranged by the Missouri Pacific Railroad. Another circuitous return trip can be provided via the Southern Pacific Railroad and the Morgan Line to New Orleans by rail and then by boat back to New York City. Delegates can also return direct from Mexico to New York by boat.

With the railroads promising to do everything in their power to make this trip to Dallas

and Mexico City pleasant and comfortable in every detail and with the excellent opportunity furnished the members of our Society to enjoy a week or two in the company of Compatriots from other sections; surely this Forty-ninth Annual Congress, which is the first to be held in the southwest, promises to be one of the largest attended in the history of the Society.

Make up your mind at once to be on the President General's Special and communicate your needs and desires to the Transportation Committee.

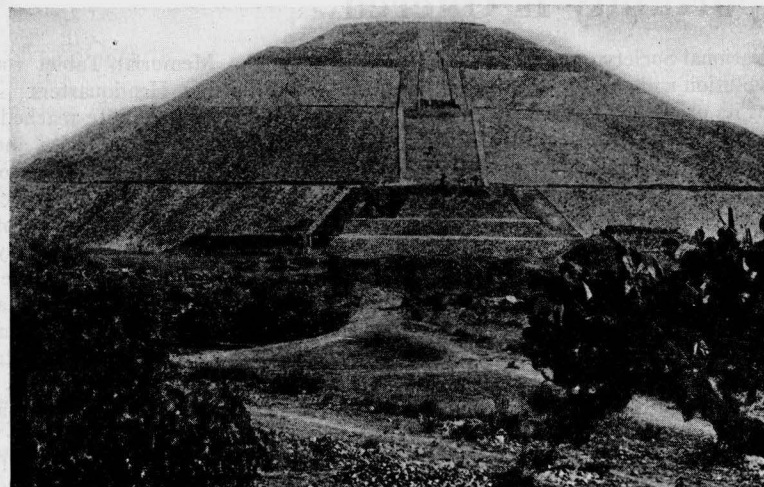

Minutes of the Meeting of the Executive Committee of the National Society S. A. R.

Held at The National Headquarters in Washington, D. C., Saturday, February 19, 1938.

Present: President General Messmore Kendall, presiding. Louis Annin Ames, New York; James M. Breckenridge, Missouri; Senator Tom Connally, Texas; Arthur M. McCrillis, Rhode Island; James D. Watson, Georgia. Also: Secretary and Registrar General Frank B. Steele and Treasurer General George S. Robertson.

The meeting was called to order by President General Messmore Kendall at ten a. m.

Voted: That the minutes of the meeting of the Executive Committee held November 8, 1937, be accepted with the following correction:

Instead of: "Voted: That the Treasurer General be authorized to cancel Certificates of Indebtedness heretofore subscribed for and not issued." *Read:* "Voted: That the Treasurer General be authorized to cancel subscriptions for Certificates of Indebtedness which have not been taken up."

Mr. Kendall brought up for discussion plans for the Congress to be held in Dallas in May.

President General Kendall stated that he was Chairman of a committee of the Patriotic Division of the World's Fair in New York and that this division was formed for the purpose of presenting to the people of America the patriotic side of the Fair. He told of a plan in conjunction with the Daughters of the American Revolution of getting up an American Cavalcade on the lines of that given at the Dallas Exposition and said that a model had been made which had been approved by the World's Fair officials who have allocated certain space where it is planned to build a

stadium holding several thousand people. The plan is to depict various episodes of American history by utilizing three hundred actors and fifty horses on the stage. The episodes will be designed to show the struggle to establish and preserve our liberties. There has been no definite estimate of the exact cost but it will be somewhere in the neighborhood of \$300,000. It is proposed to raise the money through patriotic minded citizens, if possible through our organizations, if not, outside, the presentation, however, to be entirely in control of our two organizations. Mr. Kendall stated that the D. A. R. at their last Board meeting approved the plan and it is to be brought up for final approval at their Congress to be held in April. Mr. Kendall spoke quite fully in regard to the plans for the Cavalcade and for raising money to start it saying that he believed it would succeed as a business as well as a patriotic venture. There was general discussion and it was

Voted: That the Executive Committee approve the plan inaugurated by the President General as far as it has gone.

Mr. Kendall brought up the matter of a book of patriotic sayings of various people compiled by Franklin L. Burdette of West Virginia.

Voted: That the commending of the book be deferred until it had been read by the President General.
Voted: To approve the purchase of a typewriter desk at \$21.50, a filing case at \$15.00 and a new typewriter which was bought at cost through a member of the Society.

Mr. Kendall stated that he wished to appoint a committee to handle publicity for the Congress and it was the sense of the committee that under the By-laws he had the power to appoint such a committee.

A suggestion of including other patriotic societies in Texas in the Annual Banquet was discussed. It was decided to leave the matter to the discretion of the President General as had been done at the November meeting.

The proposed trip to Mexico City in connection with the Dallas Congress and the railroad arrangements for the Congress were generally discussed and especially of the plans of the Missouri Society for entertaining the delegates in St. Louis on Saturday, May 14th. In view of the necessity of arriving in Dallas as early as possible on Sunday morning, May 15th, it was the sense of the committee that it would be most practical to have luncheon before arriving in St. Louis and leave in the late afternoon at whatever time the M. K. T. can arrange, and leave it to the Missouri Society to entertain the delegates as they wish but with the expectation that they would do nothing elaborate.

Mr. Steele read his report as Secretary and Registrar General which was received and placed on file.

Resolutions of regret were adopted at the passing of Mr. J. Walter Allen of Tennessee, former Historian General; Mr. Ashley Cabell of Missouri, last but one signer of the National Society Charter; and Mr. Allen Hawley, officer of the Empire State Society and distinguished pioneer in the aviation of our country.

Mr. Steele read a letter of appreciation to the Executive Committee from Mrs. Josiah A. Van Orsdel.

Mr. Kendall told about the new chapter which is being formed in Palm Beach in which it is hoped to have many members. In connection with this he stated that many members of other State Societies living in Palm Beach may wish to join the Palm Beach Chapter and there was full discussion of the ruling of the Chancellor General in regard to a member of one State Society joining a Chapter in another State. Secretary General Steele was instructed to write Chancellor General Souers for clarification of the interstate aspect of the ruling.

Voted: That the Executive Committee recommends to the Board of Trustees that the payment of the annual dues of the Georgia Society be allowed to be deferred until July 1st.

The Treasurer General was directed to issue a duplicate Certificate of Indebtedness for one stolen from Mrs. Kathryn S. Warren.

The proposal of Mr. J. Adger Stewart of Louisville, in regard to the Lee Memorial at Stratford, was brought up. No action taken.

It was the decision of the Committee again to call attention in the S. A. R. MAGAZINE to the Knox Sarcophagus expressing the indorsement of the National Society.

The proposed bill in Congress sponsored by the National Society of the Colonial Dames of America in reference to the 400th anniversary of the discovery of the Mississippi River by DeSoto was brought up but definite action in this matter was deferred.

Mr. Steele spoke in regard to the bill in Congress providing for the preservation of the Decatur House in Washington and it was voted that the matter be referred to the District of Columbia Society for recommendation.

The offer of Mr. Eugene C. Bonniwell, National Commander of the Military Order of Pulaski, to present to the Society the painting, "The Death of Pulaski," was discussed and it was voted to decline this gift with sincere regret inasmuch as the Society has no fitting place to make proper exhibition.

There was discussion of the printing of the Index of the Magazine. No action was taken.

There was discussion of the printing costs in general of the Magazine and Mr. Kendall volunteered to look into this matter through his publishing firm.

The proposal to reduce the price of the Official Grave Marker was brought up and it was the sense of the Committee that no reduction should be made.

Mr. Steele read a proposal of the Balfour Company of Attleboro in regard to manufacturing the Official Insignia and after discussion the matter was referred to a committee of Colonel Ames, the Secretary General and the Treasurer General.

Mr. Kendall brought up the question of repairs to the Headquarters Building and called upon the Chairman of the House Committee, Mr. John Paul Earnest, who was present at his request, to say a word.

Voted: That the President General be given discretion in the matter of making repairs to the Headquarters.

Compatriots throughout the country are therefore urged to have their respective state societies and local chapters give this matter immediate attention so that their secretaries may regularly send to the National S. A. R. Library in Washington all of their available publications. Any S. A. R. secretary desiring to have a list of the publications of his society already on file can obtain same by addressing the Librarian General.

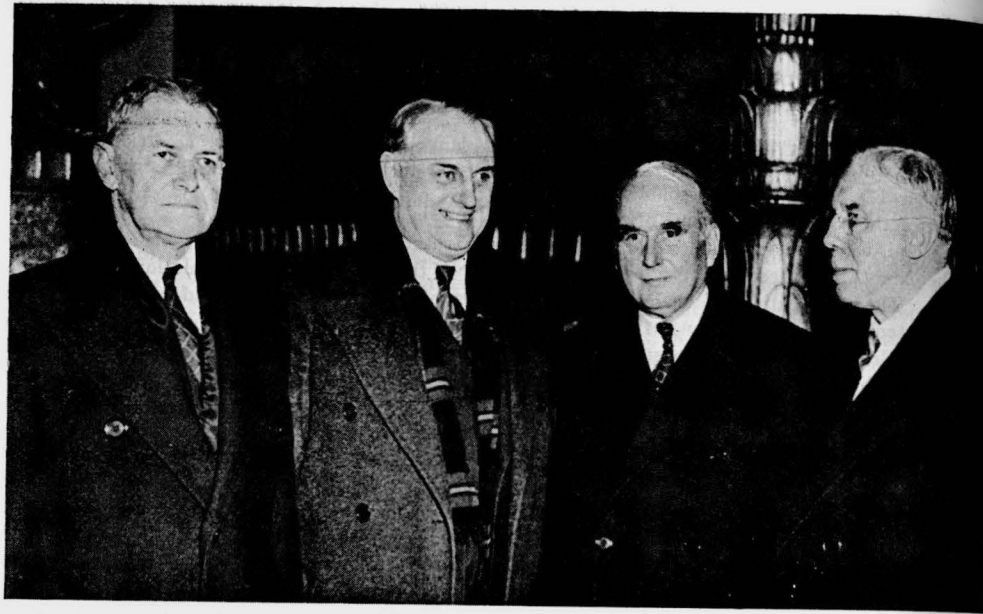

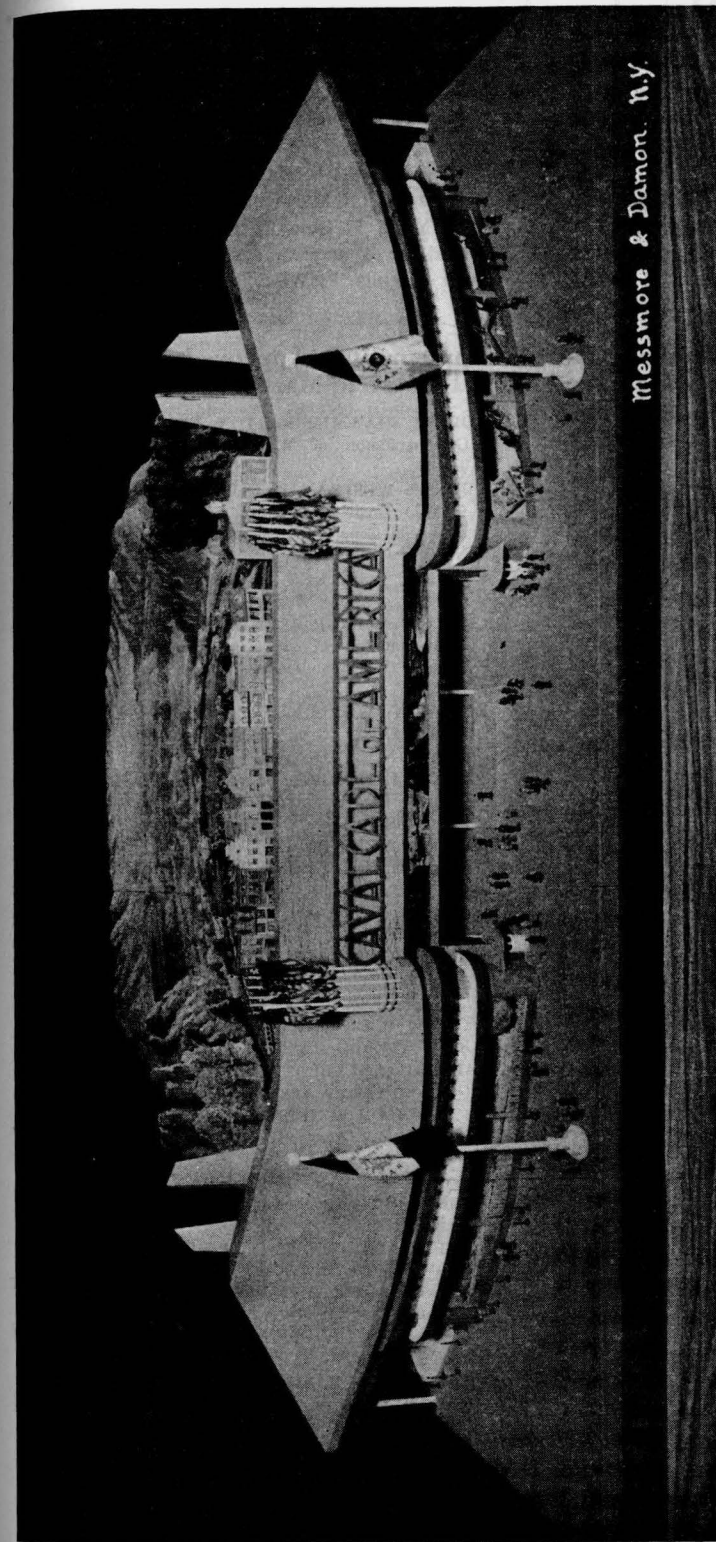
