Revolutionary Tax Lists in the

Northampton County Archives, Pennsylvania Subcommittee on Revolutionary Taxes, Genealogy Committee, National Society Sons of the American Revolution

Background and Purpose of the Report. The National Society, Sons of the American Revolution (SAR) recognizes payment of taxes that supported the Revolution as evidence of Revolutionary service. Revolutionary service of a direct ancestor is a requirement for a man to become a member of the SAR. The SAR has specified the conditions a tax must meet to count as supporting the Revolution in Genealogy Committee Policies and has specified what statutes authorized such taxes for Pennsylvania and other states. This information is posted at SAR.org under Genealogy, the former in the policy manual in SAR Genealogy Policies & Materials and the latter in Revolutionary War Tax Research. As a rule of thumb, taxes authorized by a statute stating that the funds were to support the Revolution or address a request of the Continental Congress provide evidence of service; those failing to state such a purpose, including taxes authorized before the Revolution, do not provide evidence of service. If a man was charged a penalty on a list, in particular a double tax on any Pennsylvania list, his entry on that list is not evidence of Revolutionary service under SAR policy.

The Northampton County Archives is the custodian of tax lists for that county and for many of those there are no copies in the Pennsylvania State Archives. John Sinks photographed Revolutionary period lists for 22 of the 26 townships for which there are extant tax lists from 1775 through 1783 in the Northampton County Archives. This report identifies 54 lists from 20 townships which provide evidence of Revolutionary service acceptable to SAR. Further research, especially regarding the schedule for assessment and collection of the various taxes, may lead to the determination that additional lists provide evidence of service.

Three additional lists may be determined to provide evidence of Revolutionary service with further research. One is a 1782 Heidelberg Township List. Damage to the page and difficult old German handwriting did not enable us to transcribe and translate enough of the title to make a definitive interpretation. A 1782 Chestnut Hill List and a 1782 Hamilton list were clearly authorized by the 1782 Supply Tax Statute. Many names were crossed off the list and the word "Half" was written by remaining names. We were unable to interpret these lists. Had those crossed off paid in full? Did "Half" mean that installments, which were a norm for later lists in Northampton mean the installments had been paid on time? Further examination of court records may yield answers about the scheduling of collection and clarify how these lists should be interpreted.

¹ Time did not permit photography of Towamensing, Weisenberg, Whitehall, or Williams Townships. Current Northampton County Archives no longer permits photography of these records.

To use these lists in support of an application for membership or a supplemental application, the applicant must submit a copy of the page bearing the name of the Revolution ancestor on whose service the applicant is to be approved. In addition, the applicant must submit a copy of the page or pages that identify the tax and the township of the list. Those pages will be specified in this report for each qualifying list. The lists also provide evidence of Revolutionary service of civil officials named in the lists, included county commissioners, assessors, and collectors.

Pennsylvania Statutes that Authorized Taxes to Support the Revolution. The Northampton County lists, by year, that have been determined to have supported the Revolution were authorized by one of the following statutes:

1779

Ch. 866. An Act for Raising the Additional Sum of Five Millions Seven Hundred Thousand Dollars for the Current Year One Thousand Seven Hundred and Seventy-Nine. Passed 10 Oct. 1779.

1781

Ch. 921 A Supplement to an Act Entitled "An Act for Funding and Redeeming Bills of Credit of the USA and for Providing Means to Bring the Present War to a Happy Conclusion." Passed 19 Dec. 1780. [This tax was to remain in effect for six years.] Ch. 944. An Act to Raise Effective Supplies for the Year 1781. Passed 21 June 1781. Ch. 948. An Act for Raising Additional Supplies for the Year 1781. Passed 25 June 1781. [Ch. 948 directed that this tax be "grafted upon and added to" the tax mandated by Ch. 921, so essentially a single tax was levied to satisfy these to statutes.]

Ch. 956. An Act for the Defense of the Frontiers of this State and for Other Purposes therein Mentioned. Passed 22 December 1781. [Ch. 956 exonerated from taxes men in certain counties, including part of Northampton, who suffered from depredations or were driven from their homes by the enemy, and men in those counties who stood their ground on the frontier and prevented the enemy from penetrating the interior of Pennsylvania. SAR considers exoneration lists as providing evidence of Revolutionary service.]

Please note that copies of the lists for the 1781 Supply Tax and Additional Supply Tax for Northampton County (authorized by Chapters 944 and 948) are in the Pennsylvania State Archives and are generally quite legible.

Northampton County Lists that Provide Evidence of Revolutionary Service.

Lists are ordered by township by year. If more than one list is in the Northampton County Archives for a township within a year, a list number is assigned. If only one list was extant in a particular year for a particular township, no list number is assigned. To support SAR applications, the applicant must provide the page bearing the name of the ancestor for whom evidence of Revolutionary service is claimed. In addition, a page bearing the text leading to the identification of the authorizing statute(s), a page identifying the year of the tax, and a page identifying that township. Pages containing this additional required information are identified below for each qualifying list.
