Information Regarding Committee Assignments

The National Society's committee system is important for the continued success of the Sons of the American Revolution. Between Annual Congresses and Leadership Meetings, the National Society's Committees are generally responsible for overseeing the various programs, provide advice and recommendations to the Executive Committee and the Board of Trustees, and conduct the business of the society. Committees are authorized and staffed consistent with the following: Bylaw No. 18 (Executive Committee), Bylaw No. 19 (Standing Committees), Bylaw No. 20 (Nominating Committee) and Bylaw No. 21 (Special Advisory Committees and Program Committees). The Bylaws authorize the President General to form other committees as necessary.

Reports from each Committee Chair are distributed at each Leadership Meeting and published as an electronic volume to each delegate attending the Annual Congress. In addition, Committee Chairs are encouraged to publish meeting notes following each Committee meeting. Committees may hold additional meetings electronically throughout the year. Due to time restrictions, Committees under the purview of parent Committees are expected to meet electronically to perform a majority of their business, especially prior to Leadership and Congress.

While some Committees are under the purview of parent Committees, they carry the same status as other independent Committees. Their respective Committee Chairmen and Vice Chairmen carry the same rights, responsibilities, and prominence as their parent Committee counterparts. The current committee structure was implemented to meet several goals. Namely, Committees with common objectives and areas of focus are now grouped together. This will enhance communication and facilitate stronger working relationships. The new structure also makes more efficient use of limited time and space accommodations at Leadership and Congress.

This document contains the list of 2024-2025 National Society Committees. Each Committee listing contains a brief description of the purpose of the Committee and identifies Committee Chairs, Vice Chairs, and other Committee members. Certain Committees have additional membership requirements. Although Committee assignments will be updated in the Member Database, this list is the official Committee assignment and participation list.

Active participation in the committee process is essential for operation of the National Society. Compatriots interested in serving on a particular Committee should contact the Committee Chair. All Committee additions must also gain approval from their parent Committee Chair (if applicable) prior to approval by the President General. The President General approves all committee appointment requests. National Headquarters cannot make changes to Committee membership without the President General's authorization. Compatriots needing to make corrections to their contact information should contact National Headquarters and the **PG's National Committee Coordinator, Keith Weissinger, kweiss47@comcast.net**, who will update this report periodically.

The Committee is a **Standing Committee**, as defined in Bylaw 21, Section 1 (e), consisting of a minimum of twenty-one (21) members, including the Genealogist General. The President General annually appoints one member of the committee to serve as chairman. The Genealogist General is ineligible to serve as chairman. The Genealogist General is a member of the committee for the length of his term as Genealogist General. The Committee reviews genealogical procedures and applications for membership and establishes SAR policy to ensure that there is reasonable evidence that applicants are eligible for membership. The Committee recommends methods of research for a prospect to follow where proof is missing on any essential fact. It also serves as a resource on genealogical sources and procedures.
