Preface

This article is intended to help people research the military service of their ancestor in the cause of American Independence. The sources listed are in no way endorsed or approved by the Sons of the American Revolution and may or *may not be acceptable documentation for service*.

When you are first considering applying for membership in the Sons of the American Revolution (SAR) the question you ask yourself is, "Did my ancestor serve?" SAR has a broad, but specific, definition of "service", please see: www.sar.org/how-to-apply/

Perhaps the two most used online sites to search for service are Ancestry www.ancestry.com and Fold3 www.fold3.com . Both sites require subscriptions to make full use of their resources.

However, you may be hesitant to pay for a subscription to a service such as Ancestry since you are unsure if your ancestor served. The first place to check is SAR's Patriot Research System (PRS) https://sarpatriots.sar.org/. You can enter the name of your ancestor and see if that person is already in SAR's database as a "Patriot". Be sure to take to time to read about PRS, how it can aid your search and its limitations. Remember, a person may still be a Patriot even if he or she does not appear in the PRS database.

Similarly, search the Daughters of the American Revolution (DAR) database, Genealogical Research System (GRS), Ancestor Search:

There are numerous free online sources where you can research the military service of your ancestor. Note: Often titles will be shorten when listed on various documents and these are state lists, there may be lists for specific locales.

Most records in War Department custody were destroyed by fire, November 8, 1800. Many of the remaining Revolutionary War records were lost during the War of 1812. As a result, there were, until 1873, few records for the period before 1789 in War Department custody. In 1873 Secretary of War William Belknap purchased for the Federal Government the papers of Timothy Pickering, who between 1777 and 1785 had been a member of the Board of War, Adjutant General of the Continental Army, and Quartermaster General; the papers of Samuel Hodgdon, Commissary General of Military Stores for several years during the war; miscellaneous contemporary papers; and some minor groups of records and single record items. In 1888 these records were transferred to the Department of State. By acts of July 27, 1892 (27 Stat. 275) and August 18, 1894 (28 Stat. 403), Congress authorized the transfer to

the War Department of all military records for the Revolutionary War period then in the custody of other Executive branch departments. These military records were transferred between 1894 and 1913 from the Departments of State, the Interior, and the Treasury. In 1914 and 1915, under authority of an act of March 2, 1913 (37 Stat. 723), the War Department made photographic copies of Revolutionary War records in the custody of public and private institutions in VA, NC, and MA. The entire collection was transferred to the National Archives in 1938. Although its contents span the period 1629-1915, the bulk of the information deals with the period 1775-83.

The director, assistant directors and some team leaders met Tuesday morning to discuss and decided to change several books to use for reference only or outright banning the use of several others. Unfortunately, if the Source of Service is on the ancestor's profile in the GRS, the reviewing genealogists will need to do a CN sheet to update the SS to an acceptable one or to do a DATACF to close the line. Some of these "banned" books have been forbidden for some time, but still appear on some records in the GRS. Some of the sources are excellent finding aids and should be used to locate an acceptable source.

We have found at least one entry on the "acceptable" page that refers to a headright, not a bounty land record, which should reference the Act of 20 August 1781. The document on the L drive, Guide to Knight Georgia's Roster of the Revolution, will be reviewed and revised.

- 1. Requirements List Thanks to Compatriot Terry Briggs (CA), we have a Requirements List Checklist that abbreviates the Requirements List. I have also heard some strong feedback that State Registrars are already signing the application; therefore there is no need for their signature on the checklist. I am sensing a need for the chapter registrar to be involved with both new and supplemental applications; although there is no written requirement to involve the chapter registrar in supplemental applications, the percentage of pended supplemental applications indicates that we need to do something different. Also, the chapter registrar may or may not be a Sponsor or Co-Sponsor on the application but he does need to review all applications before they are sent to the State Point of Contact.
- Committee of Assistance The Genealogy Committee has offered assistance for pended new
 applications that a state society may need to have some help with. John Schatzel (KS) is the
 chairman of the committee. He can be reached by email at jschatz82@aol.com
- 3. Google Group Christopher Smithson (MD) has developed an Applications Helpers Group Google Chat that allows folks to ask for help about applications that are difficult to complete. 



- 4. Date Fix for COX Software Compatriot Ron Bearden (AL)
 - a. If you are having a problem entering certain dates into the COX Software in the genealogy section of the form, this fix should take care of it. The problem you may be having is when you enter Mar 1876 into the blank and the COX Software changes your entry to 01 Mar 1876. "01" is added as a default because of the way the preferences are set. Follow these instructions to change the preferences setting.
 - b. This will allow you to enter the date Mar 1876 without the program changing it and adding the default date of "01". Open the COX Software so that you see the menu


headings of File, View, Tools, & Help. (as illustrated in screenshot A)



c. Left click "Tools." When you see the "Tools" menu, go down to "Preferences." (as illustrated in screenshot B) Left click "Preferences."



d. When you see the "Preferences" window pop up, left click the second tab, "Function." (as illustrated in screenshot C)



- e. With the "Function" tab open, look for "Auto Date Format." Change the bubble from "Yes" to "No."
- f. Click "Save" in the lower left corner of the "Preferences" window.
- g. This should allow you to enter any date onto the application form without COX changing it to a default date format.

- 5. Registrar Training We have a plan to present an online Registrar Training Class prepared by a Genealogy Committee Member, Dennis van Wormer, (MI). This is a six-week course, one day a week. The topics to be covered include:
 - a. Correctly filling out an application
 - b. Proper documentation and citation
 - c. Application printing, review, and submission
 - d. Genealogy research best practices
 - e. Genealogical proof arguments
 - f. Final topics and thoughts
- 6. Genealogy Committee policy changes The most recent rendition of the Genealogy Committee Policies is dated 25 Jul 2022. The significant changes in the document include:
 - a. Identifying a date, 1 Jan 2012, after which applications can be accepted as reliable sources for future applications, as long as the application or patriot has not been subsequently flagged by the genealogy staff.
 - b. There is now a requirement to "List on the application only information for which a proof is given."
- 7. Supplemental Applications are being pended at an alarming rate. Approval of these applications for 2022 is only 81.95 % nationwide. We need to do a better job of review of the supplemental applications before submission for Genealogy Staff approval.
- 8. As of 31 Jul 2022 we have about 866 new applications and 734 supplemental applications received at Louisville that need to be reviewed and approved.
